## AN ACT

To modify the boundary of the Shiloh National Military  
Park located in Tennessee and Mississippi, to establish  
Parker’s Crossroads Battlefield as an affiliated area of  
the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Shiloh National Mili-  
5 tary Park Boundary Adjustment and Parker’s Crossroads  
6 Battlefield Designation Act”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act, the following definitions apply:

3 (1) ~~AFFILIATED AREA.~~—The term “affiliated  
4 area” means the Parker’s Crossroads Battlefield es-  
5 tablished as an affiliated area of the National Park  
6 System under section 4.

7 (2) ~~PARK.~~—The term “Park” means Shiloh  
8 National Military Park, a unit of the National Park  
9 System.

10 (3) ~~SECRETARY.~~—The term “Secretary” means  
11 the Secretary of the Interior.

12 **SEC. 3. AREAS TO BE ADDED TO SHILOH NATIONAL MILI-**  
13 **TARY PARK.**

14 (a) ~~ADDITIONAL AREAS.~~—The boundary of Shiloh  
15 National Military Park is modified to include the areas  
16 that are generally depicted on the map entitled “Shiloh  
17 National Military Park, Proposed Boundary Adjustment”,  
18 numbered 304/80,011, and dated July 2014, as follows:

19 (1) ~~Fallen Timbers Battlefield.~~

20 (2) ~~Russell House Battlefield.~~

21 (3) ~~Davis Bridge Battlefield.~~

22 (b) ~~ACQUISITION AUTHORITY.~~—The Secretary may  
23 acquire lands described in subsection (a) by donation, pur-  
24 chase from willing sellers with donated or appropriated  
25 funds, or exchange.

1 (e) ADMINISTRATION.—Any lands acquired under  
2 this section shall be administered as part of the Park.

3 **SEC. 4. ESTABLISHMENT OF AFFILIATED AREA.**

4 (a) IN GENERAL.—Parker’s Crossroads Battlefield in  
5 the State of Tennessee is hereby established as an affili-  
6 ated area of the National Park System.

7 (b) DESCRIPTION.—The affiliated area shall consist  
8 of the area generally depicted within the “Proposed  
9 Boundary” on the map entitled “Parker’s Crossroads Bat-  
10 tlefield, Proposed Boundary”, numbered 903/80,073, and  
11 dated July 2014.

12 (c) ADMINISTRATION.—The affiliated area shall be  
13 managed in accordance with this Act and all laws gen-  
14 erally applicable to units of the National Park System.

15 (d) MANAGEMENT ENTITY.—The City of Parkers  
16 Crossroads and the Tennessee Historical Commission  
17 shall jointly be the management entity for the affiliated  
18 area.

19 (e) COOPERATIVE AGREEMENTS.—The Secretary  
20 may provide technical assistance and enter into coopera-  
21 tive agreements with the management entity for the pur-  
22 pose of providing financial assistance with marketing,  
23 marking, interpretation, and preservation of the affiliated  
24 area.

1       (f) ~~LIMITED ROLE OF THE SECRETARY.~~—Nothing in  
 2 this Act authorizes the Secretary to acquire property at  
 3 the affiliated area or to assume overall financial responsi-  
 4 bility for the operation, maintenance, or management of  
 5 the affiliated area.

6       (g) ~~GENERAL MANAGEMENT PLAN.~~—

7           (1) ~~IN GENERAL.~~—The Secretary, in consulta-  
 8 tion with the management entity, shall develop a  
 9 general management plan for the affiliated area.  
 10 The plan shall be prepared in accordance with sec-  
 11 tion 100502 of title 54, United States Code.

12          (2) ~~TRANSMITTAL.~~—Not later than 3 years  
 13 after the date that funds are made available for this  
 14 Act, the Secretary shall provide a copy of the com-  
 15 pleted general management to the Committee on  
 16 Natural Resources of the House of Representatives  
 17 and the Committee on Energy and Natural Re-  
 18 sources of the Senate.

19 **SEC. 5. PRIVATE PROPERTY PROTECTION.**

20       (a) ~~NO USE OF CONDEMNATION.~~—The Secretary of  
 21 the Interior may not acquire by condemnation any land  
 22 or interests in land under this Act or for the purposes  
 23 of this Act.

1       (b) ~~WRITTEN CONSENT OF OWNER.—No non-Fed-~~  
 2       eral property may be included in the Shiloh National Mili-  
 3       tary Park without the written consent of the owner.

4       (c) ~~NO BUFFER ZONE CREATED.—Nothing in this~~  
 5       Act, the establishment of the Shiloh National Military  
 6       Park, or the management plan for the Shiloh National  
 7       Military Park shall be construed to create buffer zones  
 8       outside of the Park. That activities or uses can be seen,  
 9       heard, or detected from areas within the Shiloh National  
 10      Military shall not preclude, limit, control, regulate, or de-  
 11      termine the conduct or management of activities or uses  
 12      outside of the Park.

13   **SECTION 1. SHORT TITLE.**

14       *This Act may be cited as the “Shiloh National Mili-*  
 15      *tary Park Boundary Adjustment and Parker’s Crossroads*  
 16      *Battlefield Designation Act”.*

17   **SEC. 2. DEFINITIONS.**

18       *In this Act:*

19           (1) *AFFILIATED AREA.—The term “affiliated*  
 20           *area” means the Parker’s Crossroads Battlefield estab-*  
 21           *lished as an affiliated area of the National Park Sys-*  
 22           *tem by section 4(a).*

23           (2) *PARK.—The term “Park” means Shiloh Na-*  
 24           *tional Military Park, a unit of the National Park*  
 25           *System.*

1           (3) *SECRETARY.*—*The term “Secretary” means*  
 2           *the Secretary of the Interior.*

3   **SEC. 3. AREAS TO BE ADDED TO SHILOH NATIONAL MILI-**  
 4                           **TARY PARK.**

5           (a) *ADDITIONAL AREAS.*—*The boundary of the Park*  
 6           *is modified to include the areas that are generally depicted*  
 7           *on the map entitled “Shiloh National Military Park, Pro-*  
 8           *posed Boundary Adjustment”, numbered 304/80,011, and*  
 9           *dated July 2014, and which are comprised of the following:*

10                   (1) *Fallen Timbers Battlefield.*

11                   (2) *Russell House Battlefield.*

12                   (3) *Davis Bridge Battlefield.*

13           (b) *ACQUISITION AUTHORITY.*—*The Secretary may ac-*  
 14           *quire the land described in subsection (a) by donation, pur-*  
 15           *chase from willing sellers with donated or appropriated*  
 16           *funds, or exchange.*

17           (c) *ADMINISTRATION.*—*Any land acquired under this*  
 18           *section shall be administered as part of the Park.*

19   **SEC. 4. ESTABLISHMENT OF AFFILIATED AREA.**

20           (a) *IN GENERAL.*—*Parker’s Crossroads Battlefield in*  
 21           *the State of Tennessee is established as an affiliated area*  
 22           *of the National Park System.*

23           (b) *DESCRIPTION OF AFFILIATED AREA.*—*The affili-*  
 24           *ated area shall consist of the area generally depicted within*  
 25           *the “Proposed Boundary” on the map entitled “Parker’s*

1 *Crossroads Battlefield, Proposed Boundary*”, numbered  
2 903/80,073, and dated July 2014.

3 (c) *ADMINISTRATION.*—*The affiliated area shall be*  
4 *managed in accordance with—*

5 (1) *this Act; and*

6 (2) *any law generally applicable to units of the*  
7 *National Park System.*

8 (d) *MANAGEMENT ENTITY.*—*The City of Parkers*  
9 *Crossroads and the Tennessee Historical Commission shall*  
10 *jointly be the management entity for the affiliated area.*

11 (e) *COOPERATIVE AGREEMENTS.*—*The Secretary may*  
12 *provide technical assistance and enter into cooperative*  
13 *agreements with the management entity for the purpose of*  
14 *providing financial assistance for the marketing, marking,*  
15 *interpretation, and preservation of the affiliated area.*

16 (f) *LIMITED ROLE OF THE SECRETARY.*—*Nothing in*  
17 *this Act authorizes the Secretary to acquire property at the*  
18 *affiliated area or to assume overall financial responsibility*  
19 *for the operation, maintenance, or management of the affili-*  
20 *ated area.*

21 (g) *GENERAL MANAGEMENT PLAN.*—

22 (1) *IN GENERAL.*—*The Secretary, in consultation*  
23 *with the management entity, shall develop a general*  
24 *management plan for the affiliated area in accord-*

1        *ance with section 100502 of title 54, United States*  
2        *Code.*

3            (2) *TRANSMITTAL.—Not later than 3 years after*  
4        *the date on which funds are made available to carry*  
5        *out this Act, the Secretary shall submit to the Com-*  
6        *mittee on Natural Resources of the House of Rep-*  
7        *resentatives and the Committee on Energy and Nat-*  
8        *ural Resources of the Senate the general management*  
9        *plan developed under paragraph (1).*
