A BILL ENTITLED

1 AN ACT concerning

2 **Dorchester County – Alcoholic Beverages – Arts Beer and Wine License**

3 FOR the purpose of establishing in Dorchester County an arts beer and wine license that
4 authorizes the holder to sell or serve beer and wine for on–premises consumption;
5 authorizing the Board of License Commissioners for Dorchester County to issue the
6 license to a nonprofit or for–profit retail business that engages in the display and
7 sale of original artwork in a certain arts and entertainment district; and generally
8 relating to alcoholic beverages in Dorchester County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Alcoholic Beverages and Cannabis**
22 19–102.

23 This title applies only in Dorchester County.

2 **(A) THERE IS AN ARTS BEER AND WINE LICENSE.**

3 **(B) (1) THE BOARD MAY ISSUE THE LICENSE TO A NONPROFIT OR**
4 **FOR-PROFIT RETAIL BUSINESS, INCLUDING AN ART CENTER, AN ART GALLERY, A**
5 **MUSEUM, OR A SIMILAR BUSINESS THAT IS PRIMARILY DEVOTED TO ART THAT**
6 **EXPRESSES MATTERS OF SERIOUS LITERARY, ARTISTIC, SCIENTIFIC, OR POLITICAL**
7 **VALUE, THAT:**

8 **(I) ENGAGES IN THE DISPLAY AND SALE OF ORIGINAL**
9 **ARTWORK; AND**

10 **(II) IS LOCATED IN AN ARTS AND ENTERTAINMENT DISTRICT**
11 **APPROVED BY THE DEPARTMENT OF COMMERCE.**

12 **(2) THE BOARD MAY NOT ISSUE THE LICENSE TO A BUSINESS THAT**
13 **DISPLAYS AND SELLS COMMERCIALY PREPARED OR MASS-PRODUCED ARTISTIC**
14 **PRODUCTS.**

15 **(3) THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE:**

16 **(I) AT RETAIL FOR ON-PREMISES CONSUMPTION WHEN**
17 **SNACKS ARE SERVED; AND**

18 **(II) ON MONDAY THROUGH SUNDAY, DURING NORMAL**
19 **BUSINESS HOURS BUT NOT EARLIER THAN 10 A.M. AND NOT LATER THAN 10 P.M.**

20 **(4) THE LICENSE MAY NOT BE TRANSFERRED FROM THE LOCATION**
21 **FOR WHICH THE LICENSE WAS ORIGINALLY ISSUED TO ANOTHER LOCATION.**

22 **(C) THE ANNUAL LICENSE FEE IS \$250.**

23 **(D) THE BOARD MAY ADOPT REGULATIONS TO CARRY OUT THIS SECTION.**

24 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**
25 **1, 2025.**
