## A BILL

To require the Secretary of Agriculture to conduct surveys to collect data regarding the prevention, reduction, and mitigation of greenhouse gas emissions, soil carbon sequestration, and forest wood and tree carbon sequestration, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Agricultural Emissions
- 5 Data Act of 2020".
