20 21	(a) (1) Subject to subsection (f) of this section, within a [half-mile] 0.1-MILE radius of any school, the State Highway Administration or a local authority:

- 1 May establish a school zone and maximum speed limits (i) 2 applicable in the school zone; and 3 (ii) Subject to subsection (d) of this section, may provide that fines are to be doubled for speeding violations within the school zone. 4 5 The State Highway Administration may establish a school zone 6 under paragraph (1) of this subsection on any State highway or, at the request of a local 7 authority, on any highway under the jurisdiction of the local authority. 8 A local authority may establish a school zone under paragraph 9 (1) of this subsection on any highway under its jurisdiction. 10 In Prince George's County, a municipal corporation may (iii) 11 establish a school zone under paragraph (1) of this subsection on any highway that: 12 1.
