- WHEREAS, Landlords should not be burdened with removing a tenant's personal belongings and placing them into public view immediately on eviction of the tenant; and
- WHEREAS, Neighborhoods benefit from having a tenant's personal belongings safely stored rather than becoming a source of blight in the community; now, therefore,

- (f) (i) [Subject] EXCEPT AS PROVIDED IN § 8–407 OF THIS SUBTITLE AND SUBJECT to the provisions of paragraph (2) of this subsection, if judgment is given in favor of the landlord, and the tenant fails to comply with the requirements of the order within 7 days, the court shall, at any time after the expiration of the 7 days, issue its warrant, directed to any official of the county entitled to serve process, ordering the official to cause the landlord to have again and repossess the property by putting the landlord, or the landlord's duly qualified agent or attorney, in possession of the property[, and for that purpose to remove from the property, by force if necessary, all the furniture, implements, tools, goods, effects or other chattels of every description whatsoever belonging to the tenant, or to any person claiming or holding by or under the tenant].
- 21 (ii) If the landlord does not order a warrant of restitution within 60 days from the later of the date of judgment or the expiration date of any stay of execution:
- 23 1. The judgment for possession shall be stricken; and
- 2. The judgment shall be applied to the number of judgments necessary to foreclose a tenant's right to redemption of the leased premises as established in subsection [(g)(2)] (H)(2) of this section unless the court in its discretion determines that the judgment may not apply for purposes of subsection [(g)(2)] (H)(2) of this section.
 - (iii) If the landlord orders a warrant of restitution but takes no action on the warrant within 60 days from the later of the date the court issues the order for the warrant or the date as otherwise extended by the court:
- The warrant of restitution shall expire and the judgment for possession shall be stricken; and
- The judgment shall be applied to the number of judgments necessary to foreclose a tenant's right to redemption of the leased premises as established

- in subsection [(g)(2)] (H)(2) of this section unless the court in its discretion determines that the judgment may not apply for purposes of subsection [(g)(2)] (H)(2) of this section.
- 3 (2) (i) The administrative judge of any district shall stay the execution 4 of a warrant of restitution of a residential property, from day to day, in the event of extreme 5 weather conditions affecting the residential property, including:
- 6 1. A temperature or next-day forecasted temperature of 32 7 degrees Fahrenheit or lower;
- 8 2. A winter storm warning or blizzard warning issued by the 9 National Weather Service:
- 10 3. A hurricane warning or tropical storm warning issued by 11 the National Weather Service; and
- 12 4. An excessive heat warning issued by the National 13 Weather Service.
- 14 (ii) When a stay has been granted under this paragraph, the 15 execution of the warrant of restitution for which the stay has been granted shall be given 16 priority and completed within 5 days after the extreme weather conditions cease.

- 1 (2) The tenant, in order to stay any execution of the judgment, shall give a 2 bond to the landlord with one or more sureties, who are owners of sufficient property in the 3 State of Maryland, with condition to prosecute the appeal with effect, and answer to the 4 landlord in all costs and damages mentioned in the judgment, and other damages as shall 5 be incurred and sustained by reason of the appeal.

- 4. After notice to the tenant, assignee, or subtenant by first-class mail, the affixing of the summons on the property shall be conclusively presumed to be a sufficient service to support restitution.
- (iii) [Upon] **ON** the failure of either of the parties to appear before the court on the day stated in the summons, the court may continue the case to a day not less than 6 [nor] **DAYS OR** more than 10 days after the day first stated and notify the parties of the continuance.
- 34 (2) (i) If [upon] ON hearing the parties, or in case the tenant or person 35 in possession shall neglect to appear after the summons and continuance the court shall 36 find that the landlord had been in possession of the leased property, that the said tenancy 37 is fully ended and expired, that due notice to quit as aforesaid had been given to the tenant 38 or person in possession and that the tenant or person in possession had refused so to do,

 - (iii) If the tenant appeals and files with the District Court an affidavit that the appeal is not taken for delay, and also a good and sufficient bond with one or more securities conditioned that the tenant will prosecute the appeal with effect and well and truly pay all rent in arrears and all costs in the case before the District Court and in the appellate court and all loss or damage which the landlord may suffer by reason of the tenant's holding over, including the value of the premises during the time the tenant shall so hold over, then the tenant or person in possession of said premises may retain possession thereof until the determination of said appeal.
- 17 (iv) The appellate court shall, [upon] ON application of either party, 18 set a day for the hearing of the appeal, not less than 5 [nor] DAYS OR more than 15 days 19 after the application, and notice for the order for a hearing shall be served on the opposite 20 party or that party's counsel at least 5 days before the hearing.

- (a) (1) (i) Subject to § 8–406 of this subtitle and where an unexpired lease for a stated term provides that the landlord may repossess the premises prior to the expiration of the stated term if the tenant breaches the lease, the landlord may make complaint in writing to the District Court of the county where the premises is located if:
- 32 1. The tenant breaches the lease;
- 33 2. A. The landlord has given the tenant 30 days' written 34 notice that the tenant is in violation of the lease and the landlord desires to repossess the 35 leased premises; or

- B. The breach of the lease involves behavior by a tenant or a person who is on the property with the tenant's consent, which demonstrates a clear and imminent danger of the tenant or person doing serious harm to themselves, other tenants, the landlord, the landlord's property or representatives, or any other person on the property and the landlord has given the tenant or person in possession 14 days' written notice that the tenant or person in possession is in violation of the lease and the landlord desires to repossess the leased premises; and
- 8 3. The tenant or person in actual possession of the premises 9 refuses to comply.
- 10 (ii) The court shall summons immediately the tenant or person in 11 possession to appear before the court on a day stated in the summons to show cause, if any, 12 why restitution of the possession of the leased premises should not be made to the landlord.
- 13 (2) (i) If, for any reason, the tenant or person in actual possession 14 cannot be found, the constable or sheriff shall affix an attested copy of the summons 15 conspicuously on the property.
- 16 (ii) After notice is sent to the tenant or person in possession by 17 first-class mail, the affixing of the summons on the property shall be conclusively presumed 18 to be a sufficient service to support restitution.
 - (3) If either of the parties fails to appear before the court on the day stated in the summons, the court may continue the case for not less than [six nor] 6 DAYS OR more than 10 days and notify the parties of the continuance.
 - (b) (1) If the court determines that the tenant breached the terms of the lease and that the breach was substantial and warrants an eviction, the court shall give judgment for the restitution of the possession of the premises and issue its warrant to the sheriff or a constable commanding the tenant to deliver possession to the landlord in as full and ample manner as the landlord was possessed of the same at the time when the lease was entered into. The court shall give judgment for costs against the tenant or person in possession.
 - 10 days from entry of the judgment. If the tenant (i) files with the District Court an affidavit that the appeal is not taken for delay; (ii) files sufficient bond with one or more securities conditioned [upon] ON diligent prosecution of the appeal; (iii) pays all rent in arrears, all court costs in the case; and (iv) pays all losses or damages which the landlord may suffer by reason of the tenant's holding over, the tenant or person in possession of the premises may retain possession until the determination of the appeal.
