15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND That the Laws of Maryland read as follows:

19 20	(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
21 22	(2) "QUALIFIED DATA CENTER" HAS THE MEANING STATED IN § $11-239~\mathrm{OF}$ THE TAX – GENERAL ARTICLE.



- 1 (3) "QUALIFIED DATA CENTER PERSONAL PROPERTY" HAS THE 2 MEANING STATED IN § 11–239 OF THE TAX GENERAL ARTICLE.
- 3 (B) THE GOVERNING BODY OF CALVERT COUNTY MAY ENTER INTO AN 4 AGREEMENT WITH THE OWNER OF A QUALIFIED DATA CENTER THAT IS LOCATED OR LOCATES IN THE COUNTY FOR A NEGOTIATED PAYMENT BY THE OWNER IN LIEU OF COUNTY PROPERTY TAXES.
- 7 (C) AN AGREEMENT FOR A NEGOTIATED PAYMENT IN LIEU OF TAXES UNDER 8 THIS SECTION SHALL PROVIDE THAT, FOR THE TERM SPECIFIED IN THE 9 AGREEMENT:
- 10 (1) THE OWNER SHALL PAY TO THE COUNTY A SPECIFIED AMOUNT
 11 EACH YEAR IN LIEU OF THE PAYMENT OF COUNTY REAL, OPERATING REAL,
 12 OPERATING PERSONAL, OR QUALIFIED DATA CENTER PERSONAL PROPERTY TAX;
 13 AND
- 14 (2) ALL OR A SPECIFIED PART OF THE REAL, OPERATING REAL,
 15 OPERATING PERSONAL, OR QUALIFIED DATA CENTER PERSONAL PROPERTY AT THE
 16 QUALIFIED DATA CENTER SHALL BE EXEMPT FROM COUNTY PROPERTY TAX FOR THE
 17 TERM OF THE AGREEMENT.
- 18 (D) AS SPECIFIED IN AN AGREEMENT FOR A NEGOTIATED PAYMENT IN LIEU
 19 OF TAXES UNDER THIS SECTION, FOR THE TERM SPECIFIED IN THE AGREEMENT, THE
 20 REAL, OPERATING REAL, OPERATING PERSONAL, OR QUALIFIED DATA CENTER
 21 PERSONAL PROPERTY AT A QUALIFIED DATA CENTER THAT IS LOCATED OR LOCATES
 22 IN THE COUNTY IS EXEMPT FROM COUNTY PROPERTY TAX.
- (E) ON THE WRITTEN REQUEST OF THE GOVERNING BODY OF CALVERT COUNTY, THE SUPERVISOR SHALL ASSESS THE REAL, OPERATING REAL, OPERATING PERSONAL, OR QUALIFIED DATA CENTER PERSONAL PROPERTY OF THE OWNER OF A QUALIFIED DATA CENTER WITH WHOM THE COUNTY HAS ENTERED INTO A PAYMENT IN LIEU OF TAXES AGREEMENT UNDER THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2025, and shall be applicable to all taxable years beginning after June 30, 2025.
