 18 **INGS.**

19 The Chairman of the Committee on the Budget of

 22 this resolution, and make adjustments to the pay-as-you
 23 go ledger, for one or more bills, joint resolutions, amend-

1 amounts provided in such legislation for those purposes,

6 **SEC. 3022. DEFICIT-NEUTRAL RESERVE FUND FOR LEGIS-**
7 **LATION MODIFYING STATUTORY BUDGET**
8 **CONTROLS.**

9 The Chairman of the Committee on the Budget of
10 the Senate may revise the allocations of a committee or
11 committees, aggregates, and other appropriate levels in
12 this resolution, and make adjustments to the pay-as-you-
13 go ledger, for one or more bills, joint resolutions, amend-
14 ments, amendments between the Houses, motions, or con-
15 ference reports relating to changes to the scope of seques-
16 tration as carried out by the Office of Management and
17 Budget, such as for the Financial Accounting Standards
18 Board, Public Company Accounting Oversight Board, Se-
19 curities Investor Protection Corporation, and other similar
20 entities, by the amounts provided in such legislation for
21 those purposes, provided that such legislation would not
22 increase the deficit over either the period of the total of

 6 sional budget process, which may include establishing an
 7 optional bipartisan budget pathway, by the amounts pro-
 8 vided in such legislation for those purposes, provided that
 9 such legislation would not increase the deficit over either
 10 the period of the total of fiscal years 2020 through 2024
 11 or the period of the total of fiscal years 2020 through
 12 2029.

13 **SEC. 3027. DEFICIT-NEUTRAL RESERVE FUND TO IMPROVE**
 14 **COORDINATION AND FEDERAL GOVERNMENT**
 15 **DISASTER RESPONSE AND MITIGATION.**

16 The Chairman of the Committee on the Budget of
 17 the Senate may revise the allocations of a committee or
 18 committees, aggregates, and other appropriate levels in
 19 this resolution, and make adjustments to the pay-as-you-
 20 go ledger, for one or more bills, joint resolutions, amend-
 21 ments, amendments between the Houses, motions, or con-
 22 ference reports relating to changes in disaster manage-
 23 ment and mitigation laws, which may include enhanced
 24 cooperation by Federal Government departments and
 25 agencies and State governments in responding, recovering,

1 or preventing major disasters, by amounts provided in
2 such legislation for these purposes, provided that such leg-
3 islation would not increase the deficit over either the pe-
4 riod of the total of fiscal years 2020 through 2024 or the
5 period of the total of fiscal years 2020 though 2029.

6 **SEC. 3028. DEFICIT-NEUTRAL RESERVE FUND TO PROVIDE**
7 **CONTINUED TAX RELIEF FOR FAMILY-OWNED**
8 **BUSINESSES, FARMS, AND RANCHES.**

9 The Chairman of the Committee on the Budget of
10 the Senate may revise the allocations of a committee or
11 committees, aggregates, and other appropriate levels in
12 this resolution, and make adjustments to the pay-as-you-

5 **STORMS, WILDFIRE, DROUGHTS, RISING SEA**
6 **LEVEL, AND OTHER CONDITIONS.**

7 The Chairman of the Committee on the Budget of
8 the Senate may revise the allocations of a committee or
9 committees, aggregates, and other appropriate levels in
10 this resolution, and make adjustments to the pay-as-you-
11 go ledger, for one or more bills, joint resolutions, amend-
12 ments, amendments between the Houses, motions, or con-
13 ference reports relating to supporting programs to analyze
14 the threats to installations of the Department of Defense
15 due to extreme storms, wildfire, droughts, rising sea level,
16 and other conditions by the amounts provided in such leg-
17 islation for those purposes, provided that such legislation
18 would not increase the deficit over either the period of the
19 total of fiscal years 2020 through 2024 or the period of
20 the total of fiscal years 2020 through 2029.

21 **SEC. 3030. DEFICIT-NEUTRAL RESERVE FUND RELATING TO**
22 **IMPROVING THE AFFORDABILITY OF RENTAL**
23 **HOUSING FOR LOW-INCOME FAMILIES.**

24 The Chairman of the Committee on the Budget of
25 the Senate may revise the allocations of a committee or
26 committees, aggregates, and other appropriate levels in

1 this resolution, and make adjustments to the pay-as-you-
2 go ledger, for one or more bills, joint resolutions, amend-
3 ments, amendments between the Houses, motions, or con-
4 ference reports relating to improving the affordability of
5 rental housing for low-income families by the amounts
6 provided in such legislation for those purposes, provided
7 that such legislation would not increase the deficit over
8 either the period of the total of fiscal years 2020 through
9 2024 or the period of the total of fiscal years 2020
10 through 2029.

11 **SEC. 3031. DEFICIT-NEUTRAL RESERVE FUND TO IMPROVE**
12 **FEDERAL FLOOD CONTROL EFFORTS.**

13 The Chairman of the Committee on the Budget of
14 the Senate may revise the allocations of a committee or
15 committees, aggregates, and other appropriate levels in
16 this resolution, and make adjustments to the pay-as-you-
17 go ledger, for one or more bills, joint resolutions, amend-
18 ments, amendments between the Houses, motions, or con-
19 ference reports relating to changes in Federal flood control
20 efforts and river management laws, which may include re-
21 forms to project prioritization and increased focus on the
22 Missouri River, by the amounts provided in such legisla-
23 tion for those purposes, provided that such legislation
24 would not increase the deficit over either the period of the

1 total of fiscal years 2020 through 2024 or the period of
2 the total of fiscal years 2020 through 2029.

3 **SEC. 3032. DEFICIT-NEUTRAL RESERVE FUND RELATING TO**
4 **A CLEAN AUDIT OPINION AT THE DEPART-**
5 **MENT OF DEFENSE.**

6 The Chairman of the Committee on the Budget of
7 the Senate may revise the allocations of a committee or
8 committees, aggregates, and other appropriate levels in
9 this resolution, and make adjustments to the pay-as-you-
10 go ledger, for one or more bills, joint resolutions, amend-
11 ments, amendments between the Houses, motions, or con-
12 ference reports relating to Department of Defense finan-
13 cial management, which may include legislation that holds
14 the Department of Defense accountable for failing to pass
15 a clean audit, or eliminates waste, fraud, and abuse, by
16 the amounts provided in such legislation for those pur-
17 poses, provided that such legislation would not increase
18 the deficit over either the period of the total of fiscal years
19 2020 through 2024 or the period of the total of fiscal
20 years 2020 to 2029.

21 **SEC. 3033. DEFICIT-NEUTRAL RESERVE FUND TO CON-**
22 **TINUE PROVEN MIDDLE CLASS TAX RELIEF.**

23 The Chairman of the Committee on the Budget of
24 the Senate may revise the allocations of a committee or
25 committees, aggregates, and other appropriate levels in

1 this resolution, and make adjustments to the pay-as-you-
 2 go ledger, for one or more bills, joint resolutions, amend-
 3 ments, amendments between the Houses, motions, or con-
 4 ference reports relating to changes in Federal tax laws,
 5 which may include provision of continued tax relief to
 6 working families and the middle class such as through ex-
 7 tension of tax provisions of Public Law 115–97 (131 Stat.
 8 2054), by the amounts provided in such legislation for
 9 those purposes, provided that such legislation would not
 10 increase the deficit over either the period of the total of
 11 fiscal years 2020 through 2024 or the period of the total
 12 of fiscal years 2020 through 2029.

13 **SEC. 3034. DEFICIT-NEUTRAL RESERVE FUND TO SUPPORT**
 14 **SERVICEMEMBERS’ ACCESS TO SAFE HOUS-**
 15 **ING.**

16 The Chairman of the Committee on the Budget of
 17 the Senate may revise the allocations of a committee or
 18 committees, aggregates, and other appropriate levels in
 19 this resolution, and make adjustments to the pay-as-you-
 20 go ledger, for one or more bills, joint resolutions, amend-
 21 ments, amendments between the Houses, motions, or con-
 22 ference reports related to addressing health, safety, and
 23 environmental hazards for tenants of military barracks or
 24 military family housing, which may include establishing
 25 the administrative framework necessary to ensure that ac-

1 countability is increased and improvements are made reli-
2 ably and without fear of retaliation, by the amounts pro-
3 vided in such legislation for those purposes, provided that
4 such legislation would not increase the deficit over either
5 the period of the total of fiscal years 2020 through 2024
6 or the period of the total of fiscal years 2020 through
7 2029.

8 **SEC. 3035. DEFICIT-NEUTRAL RESERVE FUND TO PROVIDE**
9 **THE DEPARTMENT OF HOMELAND SECURITY**
10 **WITH THE NECESSARY RESOURCES TO PRO-**
11 **TECT MIGRANT CHILDREN AND FAMILIES.**

12 The Chairman of the Committee on the Budget of
13 the Senate may revise the allocations of a committee or
14 committees, aggregates, and other appropriate levels in
15 this resolution, and make adjustments to the pay-as-you-
16 go ledger, for one or more bills, joint resolutions, amend-
17 ments, amendments between the Houses, motions, or con-
18 ference reports relating to providing the Department of
19 Homeland Security with the necessary resources to prop-
20 erly secure the border and protect migrant children and
21 families, which may include supporting efforts to keep
22 families together, by the amounts provided in such legisla-
23 tion for those purposes, provided that such legislation
24 would not increase the deficit over either the period of the

1 total of fiscal years 2020 through 2024 or the period of
2 the total of fiscal years 2020 through 2029.

3 **SEC. 3036. DEFICIT-NEUTRAL RESERVE FUND RELATING TO**
4 **REDUCING PRESCRIPTION DRUG COSTS FOR**
5 **AMERICANS.**

6 The Chairman of the Committee on the Budget of
7 the Senate may revise the allocations of a committee or
8 committees, aggregates, and other appropriate levels in
9 this resolution, and make adjustments to the pay-as-you-
10 go ledger, for one or more bills, joint resolutions, amend-
11 ments, amendments between the Houses, motions, or con-
12 ference reports relating to improving access to, and afford-
13 ability of, prescription drugs for all Americans, holding the
14 health care industry accountable for the prices that con-
15 sumers and Federal programs pay for critical medications,
16 and addressing issues that artificially increase the costs
17 of drugs, such as price gouging and pay-for-delay, by the
18 amounts provided in such legislation for those purposes,
19 provided that such legislation would not increase the def-
20 icit over either the period of the total of fiscal years 2020
21 through 2024 or the period of the total of fiscal years
22 2020 through 2029.

1 **SEC. 3037. DEFICIT-NEUTRAL RESERVE FUND TO ALLOW**
 2 **PROGRAM INTEGRITY FUNDING FOR TAR-**
 3 **GETED DENIAL REVIEWS.**

4 The Chairman of the Committee on the Budget of
 5 the Senate may revise the allocations of a committee or
 6 committees, aggregates, and other appropriate levels in
 7 this resolution, and make adjustments to the pay-as-you-
 8 go ledger, for one or more bills, joint resolutions, amend-
 9 ments, amendments between the Houses, motions, or con-
 10 ference reports relating to the addition of Target Denial
 11 Reviews in the allowable activities in section 815 of the
 12 Bipartisan Budget Act of 2015 (Public Law 114–74; 129
 13 Stat. 604) by the amounts provided in such legislation for
 14 those purposes, provided that such legislation would not
 15 increase the deficit over either the period of the total of
 16 fiscal years 2020 through 2024 or the period of the total
 17 of fiscal years 2020 through 2029.

18 **TITLE IV—BUDGET PROCESS**
 19 **Subtitle A—Budget Enforcement**

20 **SEC. 4101. POINT OF ORDER AGAINST ADVANCE APPRO-**
 21 **PRIATIONS IN THE SENATE.**

22 (a) IN GENERAL.—

23 (1) POINT OF ORDER.—Except as provided in
 24 subsection (b), it shall not be in order in the Senate
 25 to consider any bill, joint resolution, motion, amend-
 26 ment, amendment between the Houses, or con-

ference report that would provide an advance appropriation for a discretionary account.

(2) DEFINITION.—In this section, the term “advance appropriation” means any new budget authority provided in a bill or joint resolution making appropriations for fiscal year 2020 that first becomes available for any fiscal year after 2020, or any new budget authority provided in a bill or joint resolution making general appropriations or continuing appropriations for fiscal year 2021, that first becomes available for any fiscal year after 2021.

(b) EXCEPTIONS.—Advance appropriations may be provided—

(1) for fiscal years 2021 and 2022 for programs, projects, activities, or accounts identified in the joint explanatory statement of managers accompanying this concurrent resolution under the heading “Accounts Identified for Advance Appropriations” in an aggregate amount not to exceed \$28,852,000,000 in new budget authority in each fiscal year;

(2) for the Corporation for Public Broadcasting; and

(3) for the Department of Veterans Affairs for the Medical Services, Medical Support and Compli-

1 ance, Veterans Medical Community Care, and Med-
 2 ical Facilities accounts of the Veterans Health Ad-
 3 ministration.

4 (c) SUPERMAJORITY WAIVER AND APPEAL.—

5 (1) WAIVER.—In the Senate, subsection (a)
 6 may be waived or suspended only by an affirmative
 7 vote of three-fifths of the Members, duly chosen and
 8 sworn.

9 (2) APPEAL.—An affirmative vote of three-
 10 fifths of the Members of the Senate, duly chosen and
 11 sworn, shall be required to sustain an appeal of the
 12 ruling of the Chair on a point of order raised under
 13 subsection (a).

14 (d) FORM OF POINT OF ORDER.—A point of order
 15 under subsection (a) may be raised by a Senator as pro-
 16 vided in section 313(e) of the Congressional Budget Act
 17 of 1974 (2 U.S.C. 644(e)).

18 (e) CONFERENCE REPORTS.—When the Senate is
 19 considering a conference report on, or an amendment be-
 20 tween the Houses in relation to, a bill or joint resolution,
 21 upon a point of order being made by any Senator pursuant
 22 to this section, and such point of order being sustained,
 23 such material contained in such conference report or
 24 House amendment shall be stricken, and the Senate shall
 25 proceed to consider the question of whether the Senate

1 shall recede from its amendment and concur with a fur-
 2 ther amendment, or concur in the House amendment with
 3 a further amendment, as the case may be, which further
 4 amendment shall consist of only that portion of the con-
 5 ference report or House amendment, as the case may be,
 6 not so stricken. Any such motion in the Senate shall be
 7 debatable. In any case in which such point of order is sus-
 8 tained against a conference report (or Senate amendment
 9 derived from such conference report by operation of this
 10 subsection), no further amendment shall be in order.

11 **SEC. 4102. POINT OF ORDER AGAINST CHANGES IN MANDA-**
 12 **TORY PROGRAMS.**

13 Section 4102(b) of H. Con. Res. 71 (115th Con-
 14 gress), the concurrent resolution on the budget for fiscal
 15 year 2018, is amended—

16 (1) in paragraph (1), by inserting “(which shall
 17 not include a rescission bill or impoundment resolu-
 18 tion, as such terms are defined in section 1011 of
 19 the Congressional Budget and Impoundment Control
 20 Act of 1974 (2 U.S.C. 682))” after “making appro-
 21 priations for a full fiscal year”; and

22 (2) in paragraph (2)(C), by striking “fiscal year
 23 2020, \$15,000,000,000” and inserting “fiscal year
 24 2020 and each fiscal year thereafter, \$0”.

1 **SEC. 4103. HONEST ACCOUNTING: COST ESTIMATES FOR**
2 **MAJOR LEGISLATION TO INCORPORATE MAC-**
3 **ROECONOMIC EFFECTS.**

4 (a) CBO AND JCT ESTIMATES.—During the 116th
5 Congress, any estimate provided by the Congressional
6 Budget Office under section 402 of the Congressional
7 Budget Act of 1974 (2 U.S.C. 653) or by the Joint Com-
8 mittee on Taxation to the Congressional Budget Office
9 under section 201(f) of such Act (2 U.S.C. 601(f)) for
10 major legislation considered in the Senate shall, to the
11 greatest extent practicable, incorporate the budgetary ef-
12 fects of changes in economic output, employment, capital
13 stock, and other macroeconomic variables resulting from
14 such major legislation.

15 (b) CONTENTS.—Any estimate referred to in sub-
16 section (a) shall, to the extent practicable, include—

17 (1) a qualitative assessment of the budgetary
18 effects (including macroeconomic variables described
19 in subsection (a)) of the major legislation in the 20-
20 fiscal year period beginning after the last fiscal year
21 of the most recently agreed to concurrent resolution
22 on the budget that sets forth budgetary levels re-
23 quired under section 301 of the Congressional Budg-
24 et Act of 1974 (2 U.S.C. 632); and

25 (2) an identification of the critical assumptions
26 and the source of data underlying that estimate.

1 (c) DEFINITIONS.—In this section:

2 (1) MAJOR LEGISLATION.—The term “major
3 legislation” means a bill, joint resolution, conference
4 report, amendment, amendment between the Houses,
5 or treaty considered in the Senate—

6 (A) for which an estimate is required to be
7 prepared pursuant to section 402 of the Con-
8 gressional Budget Act of 1974 (2 U.S.C. 653)
9 and that causes a gross budgetary effect (before
10 incorporating macroeconomic effects and not in-
11 cluding timing shifts) in a fiscal year in the pe-
12 riod of years of the most recently agreed to con-
13 current resolution on the budget equal to or
14 greater than—

15 (i) 0.25 percent of the current pro-
16 jected gross domestic product of the
17 United States for that fiscal year; or

18 (ii) for a treaty, equal to or greater
19 than \$15,000,000,000 for that fiscal year;
20 or

21 (B) designated as such by—

22 (i) the Chairman of the Committee on
23 the Budget of the Senate for all direct
24 spending and revenue legislation; or

1 (ii) the Senator who is Chairman or
2 Vice Chairman of the Joint Committee on
3 Taxation for revenue legislation.

4 (2) BUDGETARY EFFECTS.—The term “budg-
5 etary effects” means changes in revenues, direct
6 spending outlays, and deficits.

7 (3) TIMING SHIFTS.—The term “timing shifts”
8 means—

9 (A) provisions that cause a delay of the
10 date on which outlays flowing from direct
11 spending would otherwise occur from one fiscal
12 year to the next fiscal year; or

13 (B) provisions that cause an acceleration
14 of the date on which revenues would otherwise
15 occur from one fiscal year to the prior fiscal
16 year.

17 **SEC. 4104. ADJUSTMENT AUTHORITY FOR AMENDMENTS TO**
18 **STATUTORY CAPS.**

19 During the 116th Congress, if a measure becomes
20 law that revises the discretionary spending limits estab-
21 lished under section 251(c) of the Balanced Budget and
22 Emergency Deficit Control Act of 1985 (2 U.S.C. 901(c)),
23 such as a measure increasing the limits for the revised
24 security category in support for a total defense budget of
25 \$750,000,000,000 for fiscal year 2020, the Chairman of

1 the Committee on the Budget of the Senate may adjust
 2 the allocation called for under section 302(a) of the Con-
 3 gressional Budget Act of 1974 (2 U.S.C. 633(a)) to the
 4 appropriate committee or committees of the Senate, and
 5 may adjust all other budgetary aggregates, allocations,
 6 levels, and limits contained in this resolution, as necessary,
 7 consistent with such measure.

8 **SEC. 4105. POINT OF ORDER AGAINST CERTAIN LEGISLA-**
 9 **TION RELATED TO SURFACE TRANSPOR-**
 10 **TATION FUNDING.**

11 (a) REPEAL OF SUNSET.—Section 405 of S. Con.
 12 Res. 13 (111th Congress), the concurrent resolution on
 13 the budget for fiscal year 2010, is amended by striking
 14 subsection (c).

15 (b) EFFECTIVE DATE.—The amendment made by
 16 subsection (a) shall take effect as though this resolution
 17 were agreed to on September 29, 2018.

18 **SEC. 4106. SURGICAL STRIKE POINT OF ORDER IN THE SEN-**
 19 **ATE AGAINST DIRECTING BUDGETARY**
 20 **TREATMENT.**

21 (a) DEFINITION.—In this section, the term “directs
 22 budgetary treatment” with respect to a provision means
 23 that the provision, as determined by the Chairman of the
 24 Committee on the Budget of the Senate—

1 (1) directs the congressional estimating process
2 for determining the budgetary effects of legislation;

3 (2) directs that a provision of legislation be con-
4 sidered a change in concepts and definitions under
5 section 251(b) of the Balanced Budget and Emer-
6 gency Deficit Control Act of 1985 (2 U.S.C.
7 901(b)); or

8 (3) reclassifies the budgetary treatment of
9 funding.

10 (b) POINT OF ORDER.—

11 (1) IN GENERAL.—In the Senate, it shall not be
12 in order to consider a provision that directs budg-
13 etary treatment in a bill, joint resolution, motion,
14 amendment, amendment between the Houses, or
15 conference report, unless the provision is included
16 in—

17 (A) a bill or resolution which has been re-
18 ported by the Committee on the Budget (or
19 from the consideration of which such committee
20 has been discharged); or

21 (B) a motion on, amendment to, amend-
22 ment between the Houses in relation to, or con-
23 ference report on a bill or resolution described
24 in subparagraph (A).

1 (2) POINT OF ORDER SUSTAINED.—If a point
2 of order is made by a Senator against a provision
3 described in paragraph (1), and the point of order
4 is sustained by the Chair, that provision shall be
5 stricken from the measure and may not be offered
6 as an amendment from the floor.

7 (c) FORM OF THE POINT OF ORDER.—A point of
8 order under subsection (b)(1) may be raised by a Senator
9 as provided in section 313(e) of the Congressional Budget
10 Act of 1974 (2 U.S.C. 644(e)).

11 (d) CONFERENCE REPORTS.—When the Senate is
12 considering a conference report on, or an amendment be-
13 tween the Houses in relation to, a bill or resolution, upon
14 a point of order being made by any Senator pursuant to
15 subsection (b)(1), and such point of order being sustained,
16 such material contained in such conference report or
17 House amendment shall be stricken, and the Senate shall
18 proceed to consider the question of whether the Senate
19 shall recede from its amendment and concur with a fur-
20 ther amendment, or concur in the House amendment with
21 a further amendment, as the case may be, which further
22 amendment shall consist of only that portion of the con-
23 ference report or House amendment, as the case may be,
24 not so stricken. Any such motion in the Senate shall be
25 debatable. In any case in which such point of order is sus-

1 tained against a conference report (or Senate amendment
 2 derived from such conference report by operation of this
 3 subsection), no further amendment shall be in order.

4 (e) SUPERMAJORITY WAIVER AND APPEAL.—In the
 5 Senate, this section may be waived or suspended only by
 6 an affirmative vote of three-fifths of the Members, duly
 7 chose and sworn. An affirmative vote of three-fifths of
 8 Members of the Senate, duly chosen and sworn shall be
 9 required to sustain an appeal of the ruling of the Chair
 10 on a point of order raised under this section.

11 **SEC. 4107. POINT OF ORDER AGAINST DESIGNATION OF**
 12 **FUNDS FOR OVERSEAS CONTINGENCY OPER-**
 13 **ATIONS/GLOBAL WAR ON TERRORISM.**

14 (a) IN GENERAL.—When the Senate is considering
 15 a bill, joint resolution, amendment, motion, amendment
 16 between the Houses, or conference report, if a point of
 17 order is made by a Senator against a designation of funds
 18 for Overseas Contingency Operations/Global War on Ter-
 19 rorism, in accordance with section 251(b)(2)(A)(ii) of the
 20 Balanced Budget and Emergency Deficit Control Act of
 21 1985 (2 U.S.C. 901(b)(2)(A)(ii)), in that measure, that
 22 provision making such a designation shall be stricken from
 23 the measure and may not be offered as an amendment
 24 from the floor.

25 (b) SUPERMAJORITY WAIVER AND APPEALS.—

1 (1) WAIVER.—Subsection (a) may be waived or
 2 suspended in the Senate only by an affirmative vote
 3 of three-fifths of the Members, duly chosen and
 4 sworn.

5 (2) APPEALS.—Appeals in the Senate from the
 6 decisions of the Chair relating to any provision of
 7 this subsection shall be limited to 1 hour, to be
 8 equally divided between, and controlled by, the ap-
 9 pellant and the manager of the bill or joint resolu-
 10 tion, as the case may be. An affirmative vote of
 11 three-fifths of the Members of the Senate, duly cho-
 12 sen and sworn, shall be required to sustain an ap-
 13 peal of the ruling of the Chair on a point of order
 14 raised under this subsection.

15 (c) FORM OF THE POINT OF ORDER.—A point of
 16 order under subsection (a) may be raised by a Senator
 17 as provided in section 313(e) of the Congressional Budget
 18 Act of 1974 (2 U.S.C. 644(e)).

19 (d) CONFERENCE REPORTS.—When the Senate is
 20 considering a conference report on, or an amendment be-
 21 tween the Houses in relation to, a bill or joint resolution,
 22 upon a point of order being made by any Senator pursuant
 23 to this section, and such point of order being sustained,
 24 such material contained in such conference report or
 25 House amendment shall be stricken, and the Senate shall

1 proceed to consider the question of whether the Senate
 2 shall recede from its amendment and concur with a fur-
 3 ther amendment, or concur in the House amendment with
 4 a further amendment, as the case may be, which further
 5 amendment shall consist of only that portion of the con-
 6 ference report or House amendment, as the case may be,
 7 not so stricken. Any such motion in the Senate shall be
 8 debatable. In any case in which such point of order is sus-
 9 tained against a conference report (or Senate amendment
 10 derived from such conference report by operation of this
 11 subsection), no further amendment shall be in order.

12 **Subtitle B—Other Provisions**

13 **SEC. 4201. BUDGETARY TREATMENT OF CERTAIN DISCRE-** 14 **TIONARY ADMINISTRATIVE EXPENSES.**

15 (a) IN GENERAL.—In the Senate, notwithstanding
 16 section 302(a)(1) of the Congressional Budget Act of
 17 1974 (2 U.S.C. 633(a)(1)), section 13301 of the Budget
 18 Enforcement Act of 1990 (2 U.S.C. 632 note), and section
 19 2009a of title 39, United States Code, the joint explana-
 20 tory statement accompanying the conference report on any
 21 concurrent resolution on the budget shall include in its
 22 allocations under section 302(a) of the Congressional
 23 Budget Act of 1974 (2 U.S.C. 633(a)) to the Committees
 24 on Appropriations amounts for the discretionary adminis-

1 trative expenses of the Social Security Administration and
2 of the Postal Service.

3 (b) SPECIAL RULE.—In the Senate, for purposes of
4 enforcing sections 302(f) of the Congressional Budget Act
5 of 1974 (2 U.S.C. 633(f)), estimates of the level of total
6 new budget authority and total outlays provided by a
7 measure shall include any discretionary amounts described
8 in subsection (a).

9 **SEC. 4202. APPLICATION AND EFFECT OF CHANGES IN AL-**
10 **LOCATIONS AND AGGREGATES.**

11 (a) APPLICATION.—Any adjustments of allocations
12 and aggregates made pursuant to this resolution shall—

13 (1) apply while that measure is under consider-
14 ation;

15 (2) take effect upon the enactment of that
16 measure; and

17 (3) be published in the Congressional Record as
18 soon as practicable.

19 (b) EFFECT OF CHANGED ALLOCATIONS AND AG-
20 GREGATES.—Revised allocations and aggregates resulting
21 from these adjustments shall be considered for the pur-
22 poses of the Congressional Budget Act of 1974 (2 U.S.C.
23 621 et seq.) as allocations and aggregates contained in
24 this resolution.

1 (c) BUDGET COMMITTEE DETERMINATIONS.—For
 2 purposes of this resolution the levels of new budget au-
 3 thority, outlays, direct spending, new entitlement author-
 4 ity, revenues, deficits, and surpluses for a fiscal year or
 5 period of fiscal years shall be determined on the basis of
 6 estimates made by the Committee on the Budget of the
 7 Senate.

8 **SEC. 4203. ADJUSTMENTS TO REFLECT CHANGES IN CON-**
 9 **CEPTS AND DEFINITIONS.**

10 Upon the enactment of a bill or joint resolution pro-
 11 viding for a change in concepts or definitions, the Chair-
 12 man of the Committee on the Budget of the Senate may
 13 make adjustments to the levels and allocations in this res-
 14 olution in accordance with section 251(b) of the Balanced
 15 Budget and Emergency Deficit Control Act of 1985 (2
 16 U.S.C. 901(b)).

17 **SEC. 4204. EXERCISE OF RULEMAKING POWERS.**

18 Congress adopts the provisions of this title—

19 (1) as an exercise of the rulemaking power of
 20 the Senate, and as such they shall be considered as
 21 part of the rules of the Senate and such rules shall
 22 supersede other rules only to the extent that they
 23 are inconsistent with such other rules; and

24 (2) with full recognition of the constitutional
 25 right of the Senate to change those rules at any

- 1 time, in the same manner, and to the same extent
- 2 as is the case of any other rule of the Senate.
