1 AN ACT concerning

2 **Baltimore County – Alcoholic Beverages – Class D Beer, Wine, and Liquor**
3 **License**

4 FOR the purpose of repealing a prohibition on the Board of License Commissioners for
5 Baltimore County from issuing a Class D beer, wine, and liquor license for use by a
6 drugstore in Baltimore County; and generally relating to alcoholic beverages in
7 Baltimore County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

2 This title applies only in Baltimore County.

3 13–904.

4 (a) There is a Class D beer, wine, and liquor license.

5 (b) The Board may:

6 (1) issue the license only to a holder of a Class B (SB) restaurant – service
7 bar beer, wine, and liquor (on–sale) license; or

8 (2) restrict off–sale privileges of the license holder.

9 (c) (1) The license authorizes the license holder to sell beer, wine, and liquor
10 at retail at the place described in the license for on– and off–premises consumption.

11 (2) The area of the licensed premises normally used to prepare and
12 consume food and alcoholic beverages on the premises may occupy not less than 80% of the
13 square foot area, unless the license holder has held the license since before December 31,
14 1966.

15 (d) [The license may not be issued for use by a drugstore.

16 (e)] The annual license fee is \$1,500.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2021.
