BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – Courts and Judicial Proceedings** 3-801.

- 1 In this subtitle the following words have the meanings indicated. (a) 2 (f) "Child in need of assistance" means a child who requires court intervention 3 because: 4 The child has been abused, has been neglected, has a developmental (1)disability, or has a mental disorder; and 5 6 The child's parents, guardian, or custodian are unable or unwilling to 7 give proper care and attention to the child and the child's needs. 8 "Neglect" means the leaving of a child unattended or other failure to 9 give proper care and attention to a child by any parent or individual who has permanent or 10 temporary care or custody or responsibility for supervision of the child under circumstances 11 that indicate: 12 That the child's health or welfare is harmed or placed at [(1)] (I) substantial risk of harm; or 13 14 That the child has suffered mental injury or been placed at [(2)] (II) 15 substantial risk of mental injury. 16 "NEGLECT" DOES NOT INCLUDE THE USE OF CANNABIS BY ANY 17 PARENT OR INDIVIDUAL WHO HAS PERMANENT OR TEMPORARY CARE OR CUSTODY 18 OR RESPONSIBILITY FOR SUPERVISION OF THE CHILD UNLESS, AS A RESULT OF THE 19 **USE OF CANNABIS:** 20 **(I)** THE CHILD'S HEALTH OR WELFARE IS HARMED OR PLACED 21 AT SUBSTANTIAL RISK OF HARM; OR
- 22 (II) THE CHILD HAS SUFFERED MENTAL INJURY OR HAS BEEN 23 PLACED AT SUBSTANTIAL RISK OF MENTAL INJURY.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
