A BILL

- To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to pay educational assistance or subsistence allowances to certain individuals during school term, quarter, or semester breaks, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Break Relief for Every
 - 5 Academic Kind of Period in an Academic Year for Vet-
 - 6 erans Act" or the "BREAK PAY for Veterans Act".

1	SEC. 2. PAYMENT OF EDUCATIONAL ASSISTANCE OR SUB-
2	SISTENCE ALLOWANCES TO CERTAIN INDI-
3	VIDUALS DURING SEMESTER BREAKS.
4	Section 3680(a)(2) of title 38, United States Code,
5	is amended—
6	(1) in subparagraph (A), by striking "; or" and
7	inserting a semicolon;
8	(2) in subparagraph (B)(ii), by striking "dis-
9	approval." and inserting "disapproval; or";
10	(3) by adding at the end the following new sub-
11	paragraph:
12	"(C) during periods between school terms,
13	quarters, or semesters where the educational institu-
14	tion certifies the enrollment of the eligible veteran or
15	eligible person on an individual term basis if—
16	"(i) the period between those terms, quar-
17	ters, or semesters does not exceed eight weeks;
18	and
19	"(ii) both terms, quarters, or semesters im-
20	mediately preceding and immediately following
21	the period are not shorter in length than the
22	period."; and
23	(4) by adding at the end the following new
24	paragraph:
25	"(3) Notwithstanding any other provision of this
26	chapter or chapter 35 of this title, any payment of an edu-

- 1 cational assistance allowance described in paragraph
- 2 (2)(C) of this subsection shall not—
- 3 "(A) be charged against the entitlement of any
- 4 individual under this chapter; or
- 5 "(B) be counted toward the aggregate period
- 6 for which section 3695 of this title limits the receipt
- 7 of assistance of an individual.".
