11 Amend the amendment by striking out all of section 5 and inserting the following:

12 **'Sec. 5. Rulemaking.** The Department of Health and Human Services shall amend
13 its rule in 10-144 C.M.R. Chapter 101: MaineCare Benefits Manual, Chapter III, Section
14 67, Principles of Reimbursement for Nursing Facilities and Section 97, Appendix C,
15 Principles of Reimbursement for Medical and Remedial Service Facilities to determine,
16 of the funds provided in section 6, the proportional amount to be distributed to each
17 provider based on sections 1 to 4 of this Act.
