- 4 (b) "Cannabis" has the meaning stated in [§ 5–101 of the Criminal Law Article]

- 1 that all conditions for the application for a waiver required in the regulations adopted by
- 2 the Secretary have been satisfied, the health officer of a county may grant a waiver from

- 4 the applicant for a waiver establishes in writing:
- 5 (1) Compliance with a specific provision of this subtitle would cause undue
- 6 financial hardship; or
