## S. 843

To require the Secretary of Commerce to establish the Sea Turtle Rescue Assistance Grant Program.

Mr. Markey (for himself, Mr. Cornyn, Mr. Tillis, Mr. Graham, Mr. Van Hollen, and Mr. Booker) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

## A BILL

To require the Secretary of Commerce to establish the Sea Turtle Rescue Assistance Grant Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Sea Turtle Rescue As-
- 5 sistance and Rehabilitation Act of 2025".
- 6 SEC. 2. SEA TURTLE RESCUE, REHABILITATION, AND RE-
- 7 SPONSE.
- 8 Section 408 of the Marine Mammal Protection Act
- 9 of 1972 (16 U.S.C. 1421f–1) is amended—

1	(1) in subsection (b), by adding at the end the
2	following:
3	"(10) Sea turtle rescue, rehabilitation,
4	AND RESPONSE.—
5	"(A) In general.—Subject to the avail-
6	ability of appropriations specific to address sea
7	turtle rescue, rehabilitation, and response, the
8	Secretary of Commerce and the Director of the
9	United States Fish and Wildlife Service shall
10	include separate eligibility for grants under this
11	subsection to address the purposes described in
12	paragraph (2) with respect to sea turtles.
13	"(B) Conditions of Grant.—A grant
14	awarded under this subsection to address sea
15	turtle rescue, rehabilitation, and response
16	shall—
17	"(i) include the equivalent grant cri-
18	teria and administration authorities and
19	requirements described under paragraph
20	(3), subparagraphs (A) and (B) of para-
21	graph (4), and paragraphs (5) through (9),
22	developed, as appropriate, and awarded
23	separately for sea turtles and in consulta-
24	tion with the United States Fish and Wild-

1	life Service in lieu of the Marine Mammal
2	Commission; and
3	"(ii) in addition to the considerations
4	under paragraph (4)(B), also consider re-
5	habilitation of stranded sea turtles.
6	"(C) ELIGIBILITY CRITERIA.—In order to
7	apply for a grant awarded under this subsection
8	to address sea turtle rescue, rehabilitation, and
9	response, an entity shall—
10	"(i) submit an application described
11	in paragraph (5) to the Secretary of Com-
12	merce with respect to sea turtles;
13	"(ii) be authorized by and in compli-
14	ance with—
15	"(I) an authorization issued
16	under section 10(a)(1)(A) of the En-
17	dangered Species Act of 1973 (16
18	U.S.C. $1539(a)(1)(A)$ ) with respect to
19	sea turtles; or
20	"(II) a cooperative agreement en-
21	tered into under section 6 of the En-
22	dangered Species Act of 1973 (16
23	U.S.C. 1535) with respect to sea tur-
24	tles;

1	"(iii) comply with the standard condi-
2	tions for care and maintenance of captive
3	sea turtles prescribed by the Secretary of
4	the Interior when relevant facilities will be
5	utilized for such purposes; and
6	"(iv) comply with all relevant data re-
7	porting, requirements, such as the Sea
8	Turtle Stranding and Salvage Network
9	data collection requirements.";
10	(2) by striking subsection (c) and inserting the
11	following:
12	"(c) Rescue and Rapid Response Funds.—
13	"(1) IN GENERAL.—There is established in the
14	Treasury of the United States—
15	"(A) an interest-bearing fund to known as
16	the 'Joseph R. Geraci Marine Mammal Rescue
17	and Rapid Response Fund'; and
18	"(B) an interest-bearing fund to be known
19	as the 'Sea Turtle Rescue, Rehabilitation, and
20	Rapid Response Fund'.
21	"(2) Use of funds.—Amounts in the funds
22	established under paragraph (1) shall be available
23	only for use by the Secretary to provide emergency
24	assistance."; and
25	(3) in subsection (d)—

1	(A) in paragraph (1)—
2	(i) in subparagraph (A), by inserting
3	"marine mammal rescue and response"
4	after "to carry out the";
5	(ii) by redesignating subparagraph
6	(B) as subparagraph (C);
7	(iii) by inserting after clause (ii) of
8	subparagraph (A) the following:
9	"(B) Authorization of appropriations
10	WITH RESPECT TO SEA TURTLE RESCUE, REHA-
11	BILITATION, AND RESPONSE.—There is author-
12	ized to be appropriated for the Secretary of
13	Commerce to carry out the sea turtle rescue, re-
14	habilitation, and response grant program under
15	subsection (b)(10), $$5,000,000$ for each of fis-
16	cal years 2025 through 2030, to remain avail-
17	able until expended."; and
18	(iv) in subparagraph (C), as redesig-
19	nated by clause (ii), by inserting "or (B)"
20	after "subparagraph (A)"; and
21	(B) by striking paragraph (2) and insert-
22	ing the following:
23	"(2) Rescue and rapid response funds.—
24	There is authorized to be appropriated—

1	"(A) to the Joseph R. Geraci Marine
2	Mammal Rescue and Rapid Response Fund
3	\$500,000 for each of fiscal years 2025 through
4	2030; and
5	"(B) to the Sea Turtle Rescue, Rehabilita-
6	tion, and Rapid Response Fund \$500,000 for
7	each of fiscal years 2025 through 2030"
