A BILL

To amend title 31, United States Code, to limit the use of Federal funds for the salaries or expenses of political employees if the President's annual budget submission to Congress is late, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Presidential Account-
5 ability for Yearly Submission of The United States’ Budg-
6 et Act” or the “PAYSTUB Act”.

1 **SEC. 2. LIMITATION ON USE OF FEDERAL FUNDS FOR PO-**
2 **LITICAL EMPLOYEE SALARIES AND EX-**
3 **PENSES IF PRESIDENT'S BUDGET IS LATE.**

4 Section 1105 of title 31, United States Code, is
5 amended by adding at the end the following:

6 “(j)(1) If the budget under subsection (a) is not sub-
7 mitted to Congress on or before the first Monday in Feb-
8 ruary of a year, during the period beginning on the first
9 Tuesday of February of such year and ending on the date
10 the budget is submitted, no Federal funds may be obli-
11 gated or expended for the salary or expenses of any polit-
12 ical employee.

13 “(2) Each political employee whose salary and ex-
14 penses are not paid by operation of paragraph (1) shall
15 be paid for the period the limitation under such subsection
16 was in effect at the employee's standard rate of pay, at
17 the earliest date possible after such period ends, regardless
18 of scheduled pay dates.

19 “(3) In this subsection, the term ‘political employee’
20 means any individual—

21 “(A) occupying a position described under sec-
22 tions 5312 through 5316 of title 5 (relating to the
23 Executive Schedule);

24 “(B) serving under a noncareer appointment in
25 the Senior Executive Service, as defined under para-
26 graph (7) of section 3132(a) of such title; or

1 “(C) occupying a position in the executive
2 branch of the Government of a confidential or pol-
3 icy-determining character under schedule C of sub-
4 part C of part 213 of title 5, Code of Federal Regu-
5 lations.”.
