A BILL

To direct the Secretary of Agriculture to amend certain regulations to clarify that livestock auction owners may have an interest in small meatpacking businesses, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Amplifying Processing
- 5 of Livestock in the United States Act" or the "A-PLUS
- 6 Act".

1	SEC. 2. AMPLIFYING PROCESSING OF LIVESTOCK IN THE
2	UNITED STATES (A- PLUS).
3	(a) In General.—Not later than 1 year after the
4	date of enactment of this Act, the Secretary shall revise
5	section 201.67 of title 9, Code of Federal Regulations, as
6	in effect on January 1, 2025, to specify that—
7	(1) market agencies may have an ownership in-
8	terest in, finance, or participate in the management
9	or operation of, a packer, so long as such packer—
10	(A) with respect to cattle and sheep, has a
11	cumulative slaughter capacity of less than—
12	(i) 2,000 animals per day; or
13	(ii) 700,000 animals per year; and
14	(B) with respect to hogs, has a cumulative
15	slaughter capacity of less than—
16	(i) 10,000 animals per day; or
17	(ii) 3,000,000 animals per year; and
18	(2) market agencies that have an ownership in-
19	terest in, finance, or participate in the management
20	or operation of, a packer shall disclose to sellers of
21	livestock the existence of such ownership interest, fi-
22	nancial relationship, or participation.
23	(b) SAVINGS CLAUSE.—Nothing in this section shall
24	be interpreted as a limitation on the authority of the Sec-
25	retary to adopt or enforce rules or regulations under the
26	Packers and Stockyards Act, 1921 (7 U.S.C. 181 et seq.)
