A BILL

To prohibit COVID-19 vaccination mandates, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "No Mandates Act".

1 SEC. 2. PROHIBITION ON AGENCIES ISSUING VACCINE

- 2 MANDATES.
- 3 (a) IN GENERAL.—No agency may issue any rule,
- 4 regulations, or guidance requiring any individual to receive
- 5 a vaccination for COVID-19.
- 6 (b) AGENCY DEFINED.—In this section, the term
- 7 "agency" has the meaning given that term in section 551
- 8 of title 5, United States Code.
- 9 SEC. 3. PROHIBITION ON REQUIRING PROOF OF COVID-19
- 10 VACCINATION FOR FEDERAL ACCESS.
- 11 A vaccination for COVID-19 shall not be required
- 12 for access to Federal property or Federal services, or for
- 13 access to congressional grounds or services.
- 14 SEC. 4. FEDERAL FUNDING RESTRICTIONS.
- 15 (a) Funding Restriction.—No entity that received
- 16 Federal funds under a COVID-19 relief package or that
- 17 receives any other Federal funds after the date of the en-
- 18 actment of this Act may require any individual to have
- 19 received a vaccination for COVID-19 as a condition of
- 20 such entity providing any service to such individual.
- 21 (b) Return of Funds.—Any entity that does not
- 22 comply with subsection (a) shall be required to pay to the
- 23 Government an amount equal to the sum of all funds such
- 24 entity received.
