## A BILL

To provide for improved management of Federal lands and increased efficiencies within public land agencies while strengthening tourism, conservation, outdoor recreation, grazing, responsible energy production, and other multiple uses.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Local Opportunities,
- 5 Conservation, and American Lands Act" or the "LOCAL
- 6 Act".

- 2 In this Act:
- 3 (1) Secretary.—The term "Secretary" means
- 4 the Secretary of the Interior.
- 5 (2) Western State.—The term "western
- 6 State" means any of the States of Alaska, Arizona,
- 7 California, Colorado, Idaho, Montana, Nevada, New
- 8 Mexico, Oregon, Utah, Washington, or Wyoming.
- 9 SEC. 3. HEADQUARTERS OFFICE OF THE BUREAU OF LAND
- 10 MANAGEMENT IN GRAND JUNCTION, COLO-
- 11 **RADO.**
- 12 (a) Headquarters.—The headquarters for the Bu-
- 13 reau of Land Management shall remain located in Grand
- 14 Junction, Colorado.
- 15 (b) Employee Stations.—All Bureau of Land
- 16 Management employee positions stationed in Grand Junc-
- 17 tion, Colorado on the date of the enactment of this Act
- 18 shall remain stationed in Grand Junction, Colorado.
- 19 SEC. 4. STUDY OF RELOCATION OF EXISTING BUREAU OF
- 20 LAND MANAGEMENT EMPLOYEE POSITIONS.
- 21 (a) Study Required.—The Secretary shall conduct
- 22 a study on the feasibility of relocating more existing Bu-
- 23 reau of Land Management employee positions to the head-
- 24 quarters in Grand Junction, Colorado or a western State
- 25 specified by the Secretary and determine amongst other
- 26 things whether such relocation will improve management

- 1 of Federal lands, increase coordination with local commu-
- 2 nities, and strengthen tourism, conservation, outdoor
- 3 recreation, grazing, responsible energy production, or
- 4 other multiple uses.
- 5 (b) Report.—Not later than 365 days after the date
- 6 of the enactment of this Act, the Secretary shall submit
- 7 to the Committee on Natural Resources of the House of
- 8 Representatives and the Committee on Energy and Nat-
- 9 ural Resources of the Senate a report on the study re-
- 10 quired under subsection (a).
