A BILL

To amend section 4501.21 and to enact section 1
4503.741 of the Revised Code to create the "Ohio 2
House Rabbit Rescue" license plate. 3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4501.21 be amended and section 4
4503.741 of the Revised Code be enacted to read as follows: 5

Sec. 4501.21. (A) There is hereby created in the state 6
treasury the license plate contribution fund. The fund shall 7
consist of all contributions for specialty license plates paid 8
by motor vehicle registrants and collected by the registrar of 9
motor vehicles pursuant to the Revised Code sections referenced 10
in division (B) of this section. 11

(B) The registrar shall pay the contributions the 12
registrar collects in the fund as follows: 13

The registrar shall pay the contributions received 14
pursuant to section 4503.491 of the Revised Code to the breast 15
cancer fund of Ohio, which shall use that money only to pay for 16
programs that provide assistance and education to Ohio breast 17
cancer patients and that improve access for such patients to 18
quality health care and clinical trials and shall not use any of 19

the money for abortion information, counseling, services, or 20
other abortion-related activities. 21

The registrar shall pay the contributions the registrar 22
receives pursuant to section 4503.492 of the Revised Code to the 23
organization cancer support community central Ohio, which shall 24
deposit the money into the Sheryl L. Kraner Fund of that 25
organization. Cancer support community central Ohio shall expend 26
the money it receives pursuant to this division only in the same 27
manner and for the same purposes as that organization expends 28
other money in that fund. 29

The registrar shall pay the contributions received 30
pursuant to section 4503.493 of the Revised Code to the autism 31
society of Ohio, which shall use the contributions for programs 32
and autism awareness efforts throughout the state. 33

The registrar shall pay the contributions the registrar 34
receives pursuant to section 4503.494 of the Revised Code to the 35
national multiple sclerosis society for distribution in equal 36
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 37
chapters of the national multiple sclerosis society. These 38
chapters shall use the money they receive under this section to 39
assist in paying the expenses they incur in providing services 40
directly to their clients. 41

The registrar shall pay the contributions the registrar 42
receives pursuant to section 4503.495 of the Revised Code to the 43
national pancreatic cancer foundation, which shall use the money 44
it receives under this section to assist those who suffer with 45
pancreatic cancer and their families. 46

The registrar shall pay the contributions the registrar 47
receives pursuant to section 4503.496 of the Revised Code to the 48

Ohio sickle cell and health association, which shall use the 49
contributions to help support educational, clinical, and social 50
support services for adults who have sickle cell disease. 51

The registrar shall pay the contributions the registrar 52
receives pursuant to section 4503.497 of the Revised Code to the 53
St. Baldrick's foundation, which shall use the contributions for 54
its research and other programs. 55

The registrar shall pay the contributions the registrar 56
receives pursuant to section 4503.498 of the Revised Code to 57
special olympics Ohio, inc., which shall use the contributions 58
for its programs, charitable efforts, and other activities. 59

The registrar shall pay the contributions the registrar 60
receives pursuant to section 4503.499 of the Revised Code to the 61
children's glioma cancer foundation, which shall use the 62
contributions for its research and other programs. 63

The registrar shall pay the contributions the registrar 64
receives pursuant to section 4503.4910 of the Revised Code to 65
the KylerStrong foundation, which shall use the contributions to 66
raise awareness of brain cancer caused by diffuse intrinsic 67
pontine glioma and to fund research for the cure of such cancer. 68

The registrar shall pay the contributions the registrar 69
receives pursuant to section 4503.4911 of the Revised Code to 70
the research institution for childhood cancer at nationwide 71
children's hospital, which shall use the contributions to fund 72
research for the cure of childhood cancers. 73

The registrar shall pay the contributions the registrar 74
receives pursuant to section 4503.50 of the Revised Code to the 75
future farmers of America foundation, which shall deposit the 76
contributions into its general account to be used for 77

educational and scholarship purposes of the future farmers of 78
America foundation. 79

The registrar shall pay the contributions the registrar 80
receives pursuant to section 4503.501 of the Revised Code to the 81
4-H youth development program of the Ohio state university 82
extension program, which shall use those contributions to pay 83
the expenses it incurs in conducting its educational activities. 84

The registrar shall pay the contributions received 85
pursuant to section 4503.502 of the Revised Code to the Ohio 86
cattlemen's foundation, which shall use those contributions for 87
scholarships and other educational activities. 88

The registrar shall pay the contributions received 89
pursuant to section 4503.505 of the Revised Code to the 90
organization Ohio region phi theta kappa, which shall use those 91
contributions for scholarships for students who are members of 92
that organization. 93

The registrar shall pay the contributions the registrar 94
receives pursuant to section 4503.506 of the Revised Code to 95
Ohio demolay, which shall use the contributions for 96
scholarships, educational programs, and any other programs or 97
events the organization holds or sponsors in this state. 98

The registrar shall pay the contributions received 99
pursuant to section 4503.508 of the Revised Code to the 100
organization bottoms up diaper drive to provide funding for that 101
organization for collecting and delivering diapers to parents in 102
need. 103

The registrar shall pay the contributions the registrar 104
receives pursuant to section 4503.509 of the Revised Code to a 105
kid again, incorporated for distribution in equal amounts to the 106

Ohio chapters of a kid again. 107

The registrar shall pay each contribution the registrar 108
receives pursuant to section 4503.51 of the Revised Code to the 109
university or college whose name or marking or design appears on 110
collegiate license plates that are issued to a person under that 111
section. A university or college that receives contributions 112
from the fund shall deposit the contributions into its general 113
scholarship fund. 114

The registrar shall pay the contributions the registrar 115
receives pursuant to section 4503.514 of the Revised Code to the 116
university of Notre Dame in South Bend, Indiana, for purposes of 117
awarding grants or scholarships to residents of Ohio who attend 118
the university. The university shall not use any of the funds it 119
receives for purposes of administering the scholarship program. 120
The registrar shall enter into appropriate agreements with the 121
university of Notre Dame to effectuate the distribution of such 122
funds as provided in this section. 123

The registrar shall pay the contributions the registrar 124
receives pursuant to section 4503.521 of the Revised Code to the 125
Ohio bicycle federation to assist that organization in paying 126
for the educational programs it sponsors in support of Ohio 127
cyclists of all ages. 128

The registrar shall pay the contributions the registrar 129
receives pursuant to section 4503.522 of the Revised Code to the 130
"friends of Perry's victory and international peace memorial, 131
incorporated," a nonprofit corporation organized under the laws 132
of this state, to assist that organization in paying the 133
expenses it incurs in sponsoring or holding charitable, 134
educational, and cultural events at the monument. 135

The registrar shall pay the contributions the registrar 136
receives pursuant to section 4503.523 of the Revised Code to the 137
fairport lights foundation, which shall use the money to pay for 138
the restoration, maintenance, and preservation of the 139
lighthouses of fairport harbor. 140

The registrar shall pay the contributions the registrar 141
receives pursuant to section 4503.524 of the Revised Code to the 142
Massillon tiger football booster club, which shall use the 143
contributions only to promote and support the football team of 144
Washington high school of the Massillon city school district. 145

The registrar shall pay the contributions the registrar 146
receives pursuant to section 4503.525 of the Revised Code to the 147
United States power squadron district seven which shall annually 148
distribute the contributions in equal amounts to all United 149
States power squadrons located in the state. Each power squadron 150
district shall use the money it receives under this section to 151
pay for the educational boating programs each district holds or 152
sponsors within this state. 153

The registrar shall pay the contributions the registrar 154
receives pursuant to section 4503.526 of the Revised Code to the 155
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 156
international, which shall use the money it receives under this 157
section to pay the costs of its educational and humanitarian 158
activities. 159

The registrar shall pay the contributions the registrar 160
receives pursuant to section 4503.528 of the Revised Code to the 161
Ohio children's alliance, which shall use the money it receives 162
under this section to pay the expenses it incurs in advancing 163
its mission of sustainably improving the provision of services 164
to children, young adults, and families in this state. 165

The registrar shall pay the contributions the registrar 166
receives pursuant to section 4503.529 of the Revised Code to the 167
Ohio nurses foundation. The foundation shall use the money it 168
receives under this section to provide educational scholarships 169
to assist individuals who aspire to join the nursing profession, 170
to assist nurses in the nursing profession who seek to advance 171
their education, and to support persons conducting nursing 172
research concerning the evidence-based practice of nursing and 173
the improvement of patient outcomes. 174

The registrar shall pay the contributions the registrar 175
receives pursuant to section 4503.531 of the Revised Code to the 176
thank you foundation, incorporated, a nonprofit corporation 177
organized under the laws of this state, to assist that 178
organization in paying for the charitable activities and 179
programs it sponsors in support of United States military 180
personnel, veterans, and their families. 181

The registrar shall pay the contributions the registrar 182
receives pursuant to section 4503.534 of the Revised Code to the 183
disabled American veterans department of Ohio, to be used for 184
programs that serve disabled American veterans and their 185
families. 186

The registrar shall pay the contributions the registrar 187
receives pursuant to section 4503.55 of the Revised Code to the 188
pro football hall of fame, which shall deposit the contributions 189
into a special bank account that it establishes and which shall 190
be separate and distinct from any other account the pro football 191
hall of fame maintains, to be used exclusively for the purpose 192
of promoting the pro football hall of fame as a travel 193
destination. 194

The registrar shall pay the contributions that are paid to 195

the registrar pursuant to section 4503.545 of the Revised Code 196
to the national rifle association foundation, which shall use 197
the money to pay the costs of the educational activities and 198
programs the foundation holds or sponsors in this state. 199

The registrar shall pay to the Ohio pet fund the 200
contributions the registrar receives pursuant to section 201
4503.551 of the Revised Code and any other money from any other 202
source, including donations, gifts, and grants, that is 203
designated by the source to be paid to the Ohio pet fund. The 204
Ohio pet fund shall use the moneys it receives under this 205
section to support programs for the sterilization of dogs and 206
cats and for educational programs concerning the proper 207
veterinary care of those animals, and for expenses of the Ohio 208
pet fund that are reasonably necessary for it to obtain and 209
maintain its tax-exempt status and to perform its duties. 210

The registrar shall pay the contributions the registrar 211
receives pursuant to section 4503.552 of the Revised Code to the 212
rock and roll hall of fame and museum, incorporated. 213

The registrar shall pay the contributions the registrar 214
receives pursuant to section 4503.553 of the Revised Code to the 215
Ohio coalition for animals, incorporated, a nonprofit 216
corporation. Except as provided in division (B) of this section, 217
the coalition shall distribute the money to its members, and the 218
members shall use the money only to pay for educational, 219
charitable, and other programs of each coalition member that 220
provide care for unwanted, abused, and neglected horses. The 221
Ohio coalition for animals may use a portion of the money to pay 222
for reasonable marketing costs incurred in the design and 223
promotion of the license plate and for administrative costs 224
incurred in the disbursement and management of funds received 225

under this section. 226

The registrar shall pay the contributions the registrar 227
receives pursuant to section 4503.554 of the Revised Code to the 228
Ohio state council of the knights of Columbus, which shall use 229
the contributions to pay for its charitable activities and 230
programs. 231

The registrar shall pay the contributions the registrar 232
receives pursuant to section 4503.555 of the Revised Code to the 233
western reserve historical society, which shall use the 234
contributions to fund the Crawford auto aviation museum. 235

The registrar shall pay the contributions the registrar 236
receives pursuant to section 4503.556 of the Revised Code to the 237
Erica J. Holloman foundation, inc., for the awareness of triple 238
negative breast cancer. The foundation shall use the 239
contributions for charitable and educational purposes. 240

The registrar shall pay each contribution the registrar 241
receives pursuant to section 4503.557 of the Revised Code to the 242
central Ohio chapter of the Ronald McDonald house charities, 243
which shall distribute the contribution to the chapter of the 244
Ronald McDonald house charities in whose geographic territory 245
the person who paid the contribution resides. 246

The registrar shall pay the contributions the registrar 247
receives pursuant to section 4503.561 of the Revised Code to the 248
state of Ohio chapter of ducks unlimited, inc., which shall 249
deposit the contributions into a special bank account that it 250
establishes. The special bank account shall be separate and 251
distinct from any other account the state of Ohio chapter of 252
ducks unlimited, inc., maintains and shall be used exclusively 253
for the purpose of protecting, enhancing, restoring, and 254

managing wetlands and conserving wildlife habitat. The state of 255
Ohio chapter of ducks unlimited, inc., annually shall notify the 256
registrar in writing of the name, address, and account to which 257
such payments are to be made. 258

The registrar shall pay the contributions the registrar 259
receives pursuant to section 4503.562 of the Revised Code to the 260
Mahoning river consortium, which shall use the money to pay the 261
expenses it incurs in restoring and maintaining the Mahoning 262
river watershed. 263

The registrar shall pay the contributions the registrar 264
receives pursuant to section 4503.564 of the Revised Code to the 265
Glen Helen association to pay expenses related to the Glen Helen 266
nature preserve. 267

The registrar shall pay the contributions the registrar 268
receives pursuant to section 4503.565 of the Revised Code to the 269
conservancy for Cuyahoga valley national park, which shall use 270
the money in support of the park. 271

The registrar shall pay the contributions the registrar 272
receives pursuant to section 4503.566 of the Revised Code to the 273
Ottawa national wildlife refuge, which shall use the 274
contributions for wildlife preservation purposes. 275

The registrar shall pay the contributions the registrar 276
receives pursuant to section 4503.567 of the Revised Code to the 277
girls on the run of Franklin county, inc., which shall use the 278
contributions to support the activities of the organization. 279

The registrar shall pay the contributions the registrar 280
receives pursuant to section 4503.576 of the Revised Code to the 281
Ohio state beekeepers association, which shall use those 282
contributions to promote beekeeping, provide educational 283

information about beekeeping, and to support other state and 284
local beekeeping programs. 285

The registrar shall pay the contributions the registrar 286
receives pursuant to section 4503.577 of the Revised Code to the 287
national aviation hall of fame, which shall use the 288
contributions to fulfill its mission of honoring aerospace 289
legends to inspire future leaders. 290

The registrar shall pay the contributions the registrar 291
receives pursuant to section 4503.579 of the Revised Code to the 292
national council of negro women, incorporated, which shall use 293
the contributions for educational purposes. 294

The registrar shall pay the contributions the registrar 295
receives pursuant to section 4503.581 of the Revised Code to the 296
Ohio sons of the American legion, which shall use the 297
contributions to support the activities of the organization. 298

The registrar shall pay to a sports commission created 299
pursuant to section 4503.591 of the Revised Code each 300
contribution the registrar receives under that section that an 301
applicant pays to obtain license plates that bear the logo of a 302
professional sports team located in the county of that sports 303
commission and that is participating in the license plate 304
program pursuant to division (E) of that section, irrespective 305
of the county of residence of an applicant. 306

The registrar shall pay to a community charity each 307
contribution the registrar receives under section 4503.591 of 308
the Revised Code that an applicant pays to obtain license plates 309
that bear the logo of a professional sports team that is 310
participating in the license plate program pursuant to division 311
(G) of that section. 312

The registrar shall pay the contributions the registrar 313
receives pursuant to section 4503.592 of the Revised Code to 314
pollinator partnership's monarch wings across Ohio program, 315
which shall use the contributions for the protection and 316
preservation of the monarch butterfly and pollinator corridor in 317
Ohio and for educational programs. 318

The registrar shall pay the contributions the registrar 319
receives pursuant to section 4503.594 of the Revised Code to 320
pelotonia, which shall use the contributions for the purpose of 321
supporting cancer research. 322

The registrar shall pay the contributions the registrar 323
receives pursuant to section 4503.595 of the Revised Code to the 324
Stan Hywet hall and gardens. 325

The registrar shall pay the contributions the registrar 326
receives pursuant to section 4503.596 of the Revised Code to the 327
Cuyahoga valley scenic railroad. 328

The registrar shall pay the contributions the registrar 329
receives pursuant to section 4503.67 of the Revised Code to the 330
Dan Beard council of the boy scouts of America. The council 331
shall distribute all contributions in an equitable manner 332
throughout the state to regional councils of the boy scouts. 333

The registrar shall pay the contributions the registrar 334
receives pursuant to section 4503.68 of the Revised Code to the 335
girl scouts of Ohio's heartland. The girl scouts of Ohio's 336
heartland shall distribute all contributions in an equitable 337
manner throughout the state to regional councils of the girl 338
scouts. 339

The registrar shall pay the contributions the registrar 340
receives pursuant to section 4503.69 of the Revised Code to the 341

Dan Beard council of the boy scouts of America. The council 342
shall distribute all contributions in an equitable manner 343
throughout the state to regional councils of the boy scouts. 344

The registrar shall pay the contributions the registrar 345
receives pursuant to section 4503.70 of the Revised Code to the 346
charitable foundation of the grand lodge of Ohio, f. & a. m., 347
which shall use the contributions for scholarship purposes. 348

The registrar shall pay the contributions the registrar 349
receives pursuant to section 4503.701 of the Revised Code to the 350
Prince Hall grand lodge of free and accepted masons of Ohio, 351
which shall use the contributions for scholarship purposes. 352

The registrar shall pay the contributions the registrar 353
receives pursuant to section 4503.702 of the Revised Code to the 354
Ohio Association of the Improved Benevolent and Protective Order 355
of the Elks of the World, which shall use the funds for 356
charitable purposes. 357

The registrar shall pay the contributions the registrar 358
receives pursuant to section 4503.71 of the Revised Code to the 359
fraternal order of police of Ohio, incorporated, which shall 360
deposit the fees into its general account to be used for 361
purposes of the fraternal order of police of Ohio, incorporated. 362

The registrar shall pay the contributions the registrar 363
receives pursuant to section 4503.711 of the Revised Code to the 364
fraternal order of police of Ohio, incorporated, which shall 365
deposit the contributions into an account that it creates to be 366
used for the purpose of advancing and protecting the law 367
enforcement profession, promoting improved law enforcement 368
methods, and teaching respect for law and order. 369

The registrar shall pay the contributions received 370

pursuant to section 4503.712 of the Revised Code to Ohio 371
concerns of police survivors, which shall use those 372
contributions to provide whatever assistance may be appropriate 373
to the families of Ohio law enforcement officers who are killed 374
in the line of duty. 375

The registrar shall pay the contributions received 376
pursuant to section 4503.713 of the Revised Code to the greater 377
Cleveland peace officers memorial society, which shall use those 378
contributions to honor law enforcement officers who have died in 379
the line of duty and support its charitable purposes. 380

The registrar shall pay the contributions received 381
pursuant to section 4503.714 of the Revised Code to the Ohio 382
association of chiefs of police. 383

The registrar shall pay the contributions the registrar 384
receives pursuant to section 4503.715 of the Revised Code to the 385
fallen linemen organization, which shall use the contributions 386
to recognize and memorialize fallen linemen and support their 387
families. 388

The registrar shall pay the contributions the registrar 389
receives pursuant to section 4503.716 of the Revised Code to the 390
fallen timbers battlefield preservation commission, which shall 391
use the contributions to further the mission of the commission. 392

The registrar shall pay the contributions the registrar 393
receives pursuant to section 4503.72 of the Revised Code to the 394
organization known on March 31, 2003, as the Ohio CASA/GAL 395
association, a private, nonprofit corporation organized under 396
Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 397
shall use these contributions to pay the expenses it incurs in 398
administering a program to secure the proper representation in 399

the courts of this state of abused, neglected, and dependent 400
children, and for the training and supervision of persons 401
participating in that program. 402

The registrar shall pay the contributions the registrar 403
receives pursuant to section 4503.722 of the Revised Code to the 404
Down Syndrome Association of Central Ohio, which shall use the 405
contributions for advocacy purposes throughout the state. 406

The registrar shall pay the contributions the registrar 407
receives pursuant to section 4503.724 of the Revised Code to the 408
Ohio Chapter of the American Foundation for Suicide Prevention, 409
which shall use the contributions for programs, education, and 410
advocacy purposes throughout the state. 411

The registrar shall pay the contributions the registrar 412
receives pursuant to section 4503.725 of the Revised Code to the 413
ALS association central & southern Ohio chapter, which shall 414
split the contributions between that chapter and the ALS 415
association northern Ohio chapter in accordance with any 416
agreement between the two associations. The contributions shall 417
be used to discover treatments and a cure for ALS, and to serve, 418
advocate for, and empower people affected by ALS to live their 419
lives to the fullest. 420

The registrar shall pay the contributions the registrar 421
receives pursuant to section 4503.73 of the Revised Code to 422
Wright B. Flyer, incorporated, which shall deposit the 423
contributions into its general account to be used for purposes 424
of Wright B. Flyer, incorporated. 425

The registrar shall pay the contributions the registrar 426
receives pursuant to section 4503.732 of the Revised Code to the 427
Siegel Shuster society, a nonprofit organization dedicated to 428

commemorating and celebrating the creation of Superman in 429
Cleveland, Ohio. 430

The registrar shall pay the contributions the registrar 431
receives pursuant to section 4503.733 of the Revised Code to the 432
central Ohio chapter of the juvenile diabetes research 433
foundation, which shall distribute the contributions to the 434
chapters of the juvenile diabetes research foundation in whose 435
geographic territory the person who paid the contribution 436
resides. 437

The registrar shall pay the contributions the registrar 438
receives pursuant to section 4503.734 of the Revised Code to the 439
Ohio highway patrol auxiliary foundation, which shall use the 440
contributions to fulfill the foundation's mission of supporting 441
law enforcement education and assistance. 442

The registrar shall pay the contributions the registrar 443
receives pursuant to section 4503.74 of the Revised Code to the 444
Columbus zoological park association, which shall disburse the 445
moneys to Ohio's major metropolitan zoos, as defined in section 446
4503.74 of the Revised Code, in accordance with a written 447
agreement entered into by the major metropolitan zoos. 448

The registrar shall pay the contributions the registrar 449
receives pursuant to section 4503.741 of the Revised Code to the 450
Ohio house rabbit rescue, which shall use the contributions for 451
its rescue, adoption, and educational programs. 452

The registrar shall pay the contributions the registrar 453
receives pursuant to section 4503.75 of the Revised Code to the 454
rotary foundation, located on March 31, 2003, in Evanston, 455
Illinois, to be placed in a fund known as the permanent fund and 456
used to endow educational and humanitarian programs of the 457

rotary foundation. 458

The registrar shall pay the contributions the registrar 459
receives pursuant to section 4503.751 of the Revised Code to the 460
Ohio association of realtors, which shall deposit the 461
contributions into a property disaster relief fund maintained 462
under the Ohio realtors charitable and education foundation. 463

The registrar shall pay the contributions the registrar 464
receives pursuant to section 4503.752 of the Revised Code to 465
buckeye corvettes, incorporated, which shall use the 466
contributions to pay for its charitable activities and programs. 467

The registrar shall pay the contributions the registrar 468
receives pursuant to section 4503.754 of the Revised Code to the 469
municipal corporation of Twinsburg. 470

The registrar shall pay the contributions the registrar 471
receives pursuant to section 4503.763 of the Revised Code to the 472
Ohio history connection to be used solely to build, support, and 473
maintain the Ohio battleflag collection within the Ohio history 474
connection. 475

The registrar shall pay the contributions the registrar 476
receives pursuant to section 4503.764 of the Revised Code to the 477
Medina county historical society, which shall use those 478
contributions to distribute between the various historical 479
societies and museums in Medina county. 480

The registrar shall pay the contributions the registrar 481
receives pursuant to section 4503.765 of the Revised Code to the 482
Amaranth grand chapter foundation, which shall use the 483
contributions for communal outreach, charitable service, and 484
scholarship purposes. 485

The registrar shall pay the contributions the registrar 486

receives pursuant to section 4503.767 of the Revised Code to 487
folds of honor of central Ohio, which shall use the 488
contributions to provide scholarships to spouses and children 489
either of disabled veterans or of members of any branch of the 490
armed forces who died during their service. 491

The registrar shall pay the contributions the registrar 492
receives pursuant to section 4503.85 of the Revised Code to the 493
Ohio sea grant college program to be used for Lake Erie area 494
research projects. 495

The registrar shall pay the contributions the registrar 496
receives pursuant to section 4503.86 of the Revised Code to the 497
Ohio Lincoln highway historic byway, which shall use those 498
contributions solely to promote and support the historical 499
preservation and advertisement of the Lincoln highway in this 500
state. 501

The registrar shall pay the contributions the registrar 502
receives pursuant to section 4503.87 of the Revised Code to the 503

receives pursuant to section 4503.962 of the Revised Code to 1037
Hamilton high school located in the municipal corporation of 1038
Hamilton. The high school shall not use the contributions for 1039
any political purpose. 1040

The registrar shall pay the contributions the registrar 1041
receives pursuant to section 4503.963 of the Revised Code to 1042
Ross high school located in Ross township in Butler county. The 1043
high school shall not use the contributions for any political 1044
purpose. 1045

The registrar shall pay the contributions the registrar 1046
receives pursuant to section 4503.97 of the Revised Code to the 1047
friends of united Hatzalah of Israel, which shall use the money 1048
to support united Hatzalah of Israel, which provides free 1049
emergency medical first response throughout Israel. 1050

The registrar shall pay the contributions the registrar 1051
receives pursuant to section 4503.98 of the Revised Code to the 1052
Westerville parks foundation to support the programs and 1053
activities of the foundation and its mission of pursuing the 1054
city of Westerville's vision of becoming "A City Within A Park." 1055

(C) All investment earnings of the license plate 1056
contribution fund shall be credited to the fund. Not later than 1057
the first day of May of every year, the registrar shall 1058
distribute to each entity described in division (B) of this 1059
section the investment income the fund earned the previous 1060
calendar year. The amount of such a distribution paid to an 1061
entity shall be proportionate to the amount of money the entity 1062

received from the fund during the previous calendar year. 1063

Sec. 4503.741. (A) The owner or lessee of any passenger 1064
car, noncommercial motor vehicle, recreational vehicle, or other 1065
vehicle of a class approved by the registrar of motor vehicles 1066
may apply to the registrar for the registration of the vehicle 1067
and issuance of "Ohio House Rabbit Rescue" license plates. The 1068
application may be combined with a request for a special 1069
reserved license plate under section 4503.40 or 4503.42 of the 1070
Revised Code. Upon receipt of the completed application and 1071
compliance by the applicant with divisions (B) and (C) of this 1072
section, the registrar shall issue to the applicant the 1073
appropriate vehicle registration and a set of "Ohio House Rabbit 1074
Rescue" license plates and a validation sticker, or a validation 1075
sticker alone when required by section 4503.191 of the Revised 1076
Code. 1077

In addition to the letters and numbers ordinarily 1078
inscribed on the license plates, "Ohio House Rabbit Rescue" 1079
license plates shall display an appropriate logo, selected by 1080
representatives of the Ohio house rabbit rescue, that are 1081
approved by the registrar, and the words "Ohio House Rabbit 1082
Rescue." "Ohio House Rabbit Rescue" license plates shall display 1083
county identification stickers that identify the county of 1084
registration as required under section 4503.19 of the Revised 1085
Code. 1086

(B) "Ohio House Rabbit Rescue" license plates and a 1087
validation sticker, or validation sticker alone, shall be issued 1088
upon receipt of an application for registration of a motor 1089
vehicle under this section; payment of the regular license tax 1090
as prescribed under section 4503.04 of the Revised Code, any 1091
applicable motor vehicle license tax levied under Chapter 4504. 1092

of the Revised Code, any applicable additional fee prescribed by 1093
section 4503.40 or 4503.42 of the Revised Code, an additional 1094
administrative fee of ten dollars, and a contribution as 1095
provided in division (C) (1) of this section; and compliance with 1096
all other applicable laws relating to the registration of motor 1097
vehicles. 1098

(C) (1) For each application for registration and 1099
registration renewal notice the registrar receives under this 1100
section, the registrar shall collect a contribution of fifteen 1101
dollars. The registrar shall deposit this contribution into the 1102
state treasury to the credit of the license plate contribution 1103
fund created in section 4501.21 of the Revised Code. 1104

(2) The registrar shall deposit the administrative fee of 1105
ten dollars, the purpose of which is to compensate the bureau of 1106
motor vehicles for additional services required in the issuing 1107
of "Ohio House Rabbit Rescue" license plates, into the state 1108
treasury to the credit of the public safety - highway purposes 1109
fund created in section 4501.06 of the Revised Code. 1110

Section 2. That existing section 4501.21 of the Revised 1111
Code is hereby repealed. 1112
