## A BILL

- To amend the Food and Nutrition Act of 2008 to require the Secretary to designate food and food products to be made available under the supplemental nutrition assistance program, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Healthy SNAP Act
  - 5 of 2025".

| 20 | Secretary shall designate by regulation the foods and    |
| 21 | food products that shall be included in the definition   |
| 22 | of the term 'food' under section $3(k)(1)$ .             |
| 23 | "(2) Considerations.—In carrying out para-               |
| 24 | graph (1), the Secretary shall—                          |
| 25 | "(A) take into consideration food and food               |
| 26 | products that—   |

| 16 | years, the Secretary shall—                           |
| 17 | "(A) conduct a scientific review of the food          |
| 18 | and food products designated under paragraph          |

| 20 | "(B) amend those foods and food products,             |
| 21 | as necessary, to reflect nutrition science, public    |
| 22 | health concerns, and cultural eating patterns.        |

1 consistent with regulations developed by the Sec-2 retary under this subsection.

"(5) CULTURAL CUISINES.—To allow for different cultural eating patterns, State agencies may, with the approval of the Secretary, substitute different food for food designated under paragraph (1) subject to the condition that the different food is nutritionally equivalent to the substituted food.".
