RESOLUTION

Providing for the expenses of certain committees of the House of Representatives in the One Hundred Sixteenth Congress.

- 1 Resolved,
- 2 SECTION 1. COMMITTEE EXPENSES FOR THE ONE HUN-
- 3 DRED SIXTEENTH CONGRESS.
- 4 (a) In General.—With respect to the One Hundred
- 5 Sixteenth Congress, there shall be paid out of the applica-
- 6 ble accounts of the House of Representatives, in accord-

- 1 ance with this primary expense resolution, not more than
- 2 the amount specified in subsection (b) for the expenses
- 3 (including the expenses of all staff salaries) of each com-
- 4 mittee named in such subsection.
- 5 (b) Committees and Amounts.—The committees
- 6 and amounts referred to in subsection (a) are: Committee
- 7 on Agriculture, \$11,513,328; Committee on Armed Serv-
- 8 ices, \$16,350,222; Committee on the Budget,

- 10 (1) Review.—None of the amounts provided
- for in section 1 for a committee named in subsection
- 12 (b) may be available for expenses of the committee
- after March 15, 2020, unless the chair or ranking
- minority member of the committee appears and pre-
- sents testimony at a hearing of the Committee on
- 16 House Administration held prior to such date to re-
- view the committee's use of the amounts provided
- for in section 1 during the first session of the One
- 19 Hundred Sixteenth Congress and to determine
- whether the amount specified in subsection (b) with
- respect to the committee should be updated on the
- basis of the review.
- 23 (2) Waiver.—The Committee on House Ad-
- 24 ministration may waive the application of paragraph

- 1 (1) to any or all of the committees named in sub-
- 2 section (b).
- 3 SEC. 4. VOUCHERS.
- 4 Payments under this resolution shall be made on
- 5 vouchers authorized by the committee involved, signed by
- 6 the chair of such committee, and approved in the manner
- 7 directed by the Committee on House Administration.
- 8 SEC. 5. REGULATIONS.
- 9 Amounts made available under this resolution shall
- 10 be expended in accordance with regulations prescribed by
- 11 the Committee on House Administration.
- 12 SEC. 6. RESERVE FUND FOR UNANTICIPATED EXPENSES.
- 13 (a) Establishment.—There is hereby established a
- 14 reserve fund for unanticipated expenses of committees for
- 15 the One Hundred Sixteenth Congress.
- 16 (b) Amount.—The reserve fund under this section
- 17 shall have a balance of \$8,000,000, of which—
- 18 (1) \$1,500,000 shall be available for unantici-
- pated expenses incurred during the period beginning
- at noon on January 3, 2019, and ending imme-
- 21 diately before noon on January 3, 2020; and
- (2) \$6,500,000 shall be available for unantici-
- pated expenses incurred during the period beginning
- at noon on January 3, 2020, and ending imme-
- diately before noon on January 3, 2021.

- 1 (c) Allocation to Committees.—Amounts in the
- 2 reserve fund under this section shall be paid to a com-
- 3 mittee pursuant to an allocation approved by the Com-
- 4 mittee on House Administration.

5 SEC. 7. ADJUSTMENT AUTHORITY.

- 6 The Committee on House Administration shall have
- 7 authority to make adjustments in amounts under section
- 8 1, if necessary to comply with an order of the President
- 9 issued under section 251A or 254 of the Balanced Budget
- 10 and Emergency Deficit Control Act of 1985 or to conform
- 11 to any change in appropriations for the purposes of such
- 12 section 1.
