A BILL

To expand the payment of principal, interest, and fees for certain disaster loans under the CARES Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Loan Interest Forgive-
- 5 ness for Taxpayers Under a Pandemic Act of 2021" or
- 6 the "LIFT UP Act of 2021".
- 7 SEC. 2. SUBSIDY FOR CERTAIN LOAN PAYMENTS.
- 8 Section 1112 of the CARES Act (15 U.S.C. 9011)
- 9 is amended—
- 10 (1) in subsection (a)—

1	(A) in paragraph (1)(B), by striking "or"
2	at the end;
3	(B) in paragraph (2), by striking the pe-
4	riod at the end and inserting "; or"; and
5	(C) by adding at the end the following:
6	"(3) made during the period beginning on Jan-
7	uary 1, 2015, and ending on the day before the date
8	of enactment of this paragraph—
9	"(A) to a business concern under section
10	7(b)(1) of the Small Business Act (15 U.S.C.
11	636(b)(1)) that is unrelated to the COVID-19
12	pandemic; or
13	"(B) under section 7(b)(2) of the Small
14	Business Act (15 U.S.C. 636(b)(2)) that is un-
15	related to the COVID-19 pandemic."; and
16	(2) in subsection (c)—
17	(A) in paragraph (1)—
18	(i) in subparagraphs (A) and (B), by
19	inserting "(except a covered loan described
20	in subsection $(a)(3)$ " after "on
21	deferment" each place it appears; and
22	(ii) by adding at the end the following
23	new subparagraph:
24	"(E) With respect to a covered loan de-
25	scribed in subsection (a)(3), for the 6-month

1	period beginning with the first payment due on
2	the covered loan."; and
3	(B) in paragraph (6), by inserting "(except
4	a covered loan described in subsection (a)(3))"
5	after "for a covered loan".
6	SEC. 3. EMERGENCY EIDL GRANTS.
7	A borrower of a loan made under section 7(b)(2) of
8	the Small Business Act (15 U.S.C. 636(b)(2)) may also
9	receive payments under section 1112 of the CARES Act
n	(15 U.S.C. 9011) as amended by this Act
