2 Maryland Uniform Disposition of Abandoned Property Act – Revisions

3 FOR the purpose of making certain virtual currency subject to the abandoned property laws 4 in the State; establishing provisions to determine certain information about certain apparent owners of abandoned property; providing that a certain operation does not 5 prevent certain insurance policies from maturing or terminating; altering and 6 7 establishing certain provisions pertaining to the presumption of abandonment for 8 certain types of property; establishing certain procedures to establish the death of a 9 certain insured or certain annuitant; altering the dollar value at which the Comptroller is required to publish certain notice; authorizing the Comptroller to 10 retain, for certain purposes, certain funding from proceeds obtained through the 11 12 disposition of abandoned property; altering the procedures for filing a claim with the 13 Comptroller to reclaim abandoned property; and generally relating to the Maryland 14 Uniform Disposition of Abandoned Property Act.


