(g) That the parent, for reasons other than poverty alone, has continuously or repeatedly failed to provide or is incapable of providing essential food, clothing, shelter, medical care, or education reasonably necessary and available for the child's well-being and that there is no reasonable expectation of significant improvement in the parent's conduct in the immediately foreseeable future, considering the age of the child;

## (h) That:

- 1. The parent's parental rights to another child have been involuntarily terminated;
- 2. The child named in the present termination action was born subsequent to or during the pendency of the previous termination; and
- 3. The conditions or factors which were the basis for the previous termination finding have not been corrected;
- (i) That the parent has been convicted in a criminal proceeding of having caused or contributed to the death of another child as a result of physical or sexual abuse or neglect;
- (j) That the child has been in foster care under the responsibility of the cabinet for fifteen (15) cumulative months out of forty-eight (48) months preceding the filing of the petition to terminate parental rights; or
- (k) That the child has been removed from the biological or legal parents more than two (2) times in a twenty-four (24) month period by the cabinet or a court.
- 24 (3) In determining the best interest of the child and the existence of a ground for termination, the Circuit Court shall consider the following factors:
- 26 (a) Mental illness as defined by KRS 202A.011(9), or an intellectual disability as 27 defined by KRS 202B.010(9) of the parent as certified by a qualified mental

1			health professional, or a disability as defined in Section 1 of this Act, if the
2			mental illness, intellectual disability, or disability[which] renders the parent
3			consistently unable to care for the immediate and ongoing physical or
4			psychological needs of the child for extended periods of time;
5		(b)	Acts of abuse or neglect as defined in KRS 600.020(1) toward any child in the
6			family;
7		(c)	If the child has been placed with the cabinet, whether the cabinet has, prior to
8			the filing of the petition:
9			<u>1.</u> Made reasonable efforts as defined in KRS 620.020 to reunite the child
10			with the parents unless one or more of the circumstances enumerated in
11			KRS 610.127 for not requiring reasonable efforts have been
12			substantiated in a written finding by the District Court; or
13			2. Provided a parent with a disability as defined in Section 1 of this Act
14			with targeted adaptive and supportive services based on an individual
15			assessment of the parent, or has received a written acknowledgement
16			from the parent knowingly and affirmatively rejecting the offered
17			services;
18		(d)	The efforts and adjustments the parent has made in his or her circumstances,
19			conduct, or conditions to make it in the child's best interest to return the
20			<u>child[him]</u> to his <u>or her</u> home within a reasonable period of time, considering
21			the age of the child;
22		(e)	The physical, emotional, and mental health of the child and the prospects for
23			the improvement of the child's welfare if termination is ordered; and
24		(f)	The payment or the failure to pay a reasonable portion of substitute physical
25			care and maintenance if financially able to do so.
26	(4)	If th	e child has been placed with the cabinet, the parent may present testimony
27		conc	terning the reunification, adaptive, or supportive services offered by the cabinet

1 and whether additional services would be likely to bring about lasting parental 2 adjustment enabling a return of the child to the parent. 3 If the parent proves by a preponderance of the evidence that the child will not 4 continue to be an abused or neglected child as defined in KRS 600.020(1) if 5 returned to the parent, or if the parent proves by a preponderance of the evidence 6 that appropriate and specifically targeted adaptive or supportive services based 7 upon an individual assessment of the parent have not been offered or provided to 8 *the parent*, the court in its discretion may determine not to terminate parental rights. 9 (6) Upon the conclusion of proof and argument of counsel, the Circuit Court shall enter 10 findings of fact, conclusions of law, and a decision as to each parent-respondent 11 within thirty (30) days either: 12 Terminating the right of the parent; or (a) 13 Dismissing the petition and stating whether the child shall be returned to the (b) 14 parent or shall remain in the custody of the state.
