- 6 (3) There shall be in each county, at all times, one or more commissioners 7 available for the convenience of the public and police in obtaining charging documents, 8 warrants, or criminal summonses and to advise arrested persons of their rights as required 9 by law.
- 10 (4) A commissioner may exercise the powers of office in any county to which 11 the commissioner is assigned by the Chief Judge of the District Court or a designee of the 12 Chief Judge of the District Court.
 - (5) The Chief Judge of the District Court may authorize one or more commissioners to perform the duties of a commissioner regarding persons arrested in a county other than the county in which the commissioner resides and for which the commissioner was appointed when the arrested persons are brought before the commissioner by a peace officer of the jurisdiction in which that arrest was made.
- 18 (6) (i) An individual may file an application for a statement of charges 19 with a District Court commissioner.
- 20 (ii) On review of an application for a statement of charges, a District 21 Court commissioner may issue a summons or an arrest warrant.
- 22 (iii) A District Court commissioner may issue an arrest warrant only 23 on a finding that:
- 24 1. There is probable cause to believe that the defendant 25 committed the offense charged in the charging document; and
- 26 2. A. The defendant previously has failed to respond to a summons that has been personally served or a citation;
- B. The whereabouts of the defendant are unknown and the issuance of a warrant is necessary to subject the defendant to the jurisdiction of the court;
- 30 C. The defendant is in custody for another offense; or
- D. There is probable cause to believe that the defendant poses a danger to another person or to the community.
