Natural Resources - Fishing Licenses and Stamps - Exemptions

- FOR the purpose of authorizing the Department of Natural Resources to issue an annual fishing license and stamp exemption to certain entities and organizations to provide fishing clinics and instructional opportunities to certain individuals; altering certain reporting requirements for certain entities and organizations that are issued certain fishing license and stamp exemptions; and generally relating to exemptions to requirements to obtain a fishing license or stamp.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 15 That the Laws of Maryland read as follows:

- 18 (a) (1) The Department may issue a 1-day license exemption to a nonprofit organization to take individuals with physical or mental disabilities fishing from shore in
- 20 the tidal or nontidal waters of the State.
- 21 (2) The primary caregiver or representative of the organization attending 22 to the disabled individuals is included in the license exemption under this subsection.
- 23 (3) Application for a license exemption for an organization attending to disabled individuals shall state the location, time, and day of the event and the number of

4 5 6 7	(c) The primary caregiver or representative of the governmental entity or nonprofit organization exempted under subsection (a) or (b) of this section shall have in possession the letter of exemption from the Director of the Fisheries Service while the organization is engaged in fishing activity.
8	(d) An individual covered under a license exemption under subsection (a) or (b) of this section may:
10 11	(1) Engage in angling on the nontidal waters of the State without holding an angler's license under \S 4–604 of this title;
$\frac{12}{3}$	(2) Engage in angling for trout on the nontidal waters of the State without holding a trout stamp under \S 4–614 of this title; and
14 15 16	(3) Fish for finfish in the Chesapeake Bay and its tributaries or in the State waters of the Atlantic Ocean and the Atlantic coastal bays and their tributaries without holding a Chesapeake Bay and coastal sport fishing license under § 4–745 of this title.
17	(e) An angler's license is not required of the following:
18 19 20	(1) A patient who is under treatment by a State-approved mental health facility and an individual who attends or resides in a State-approved facility for developmentally disabled individuals; or
21 22 23	(2) A caregiver, family member, or designee of a mental health care facility or private group home of a patient who is under treatment by a State-approved mental health facility, if:
24 25 26	(i) The administrator of the mental health care facility, or treating physician or psychologist provides the Department with a letter stating that the caregiver or family member is the primary caretaker of the patient; or
27 28 29	(ii) The individual accompanying the patient carries a copy of the letter described under item (i) of this item, or a professional license or certificate of a health care professional involved in the care of the patient.

30 **(F)** THE DEPARTMENT MAY ADOPT REGULATIONS TO CARRY OUT THIS 31 SECTION.
