1	A RESOLUTION honoring the life and memory of world-renowned Thoroughbred
2	horse owner, breeder, and pillar of the horse racing industry, Frank L. Jones, Jr.
3	WHEREAS, Frank L. Jones, Jr. was born in 1937 in Louisville, Kentucky, to
4	parents Frank L. Jones, Sr. and Ann Epperson Jones; and
5	WHEREAS, Frank L. Jones, Jr. attended Western Kentucky University before
6	faithfully serving his country in the United States Air Force; and
7	WHEREAS, Frank L. Jones, Jr. was introduced to the world of horse racing when a
8	friend convinced him to wager a \$2 on a horse. His first bet earned him a return of \$96
9	and was the catalyst to him becoming a legend in the horse racing industry; and
10	WHEREAS, Frank L. Jones, Jr. purchased his first horse in 1968 for \$1,500 and
11	exclusively used Jerry Romans, Sr. and his son, Dale, as trainers; and
12	WHEREAS, Frank L. Jones, Jr. became a prominent breeder and owner of
13	Thoroughbred horses who helped shape the horse industry in Kentucky over his decades
14	of leadership. He was the leading owner at the Churchill Downs spring meets in 1989,
15	1990, 1992, and 1995; and
16	WHEREAS, the star of his stable was Tapitsfly (Tapit), who won the inaugural
17	Breeders' Cup Juvenile Fillies Turf in 2009, as well as the winner of Belmont's Grade 1
18	Just a Game Stakes and Keeneland's First Lady Stakes Jones sold the filly in 2012 at the
19	Fasig-Tipton Kentucky November sale for \$1.85 million to Katsumi Yoshida; and
20	WHEREAS, in addition to his other roles, Frank L. Jones, Jr. spent more than 30
21	years serving as the owner's vice president of the Kentucky Horsemen's Benevolent and
22	Protective Association (HBPA) where he was instrumental in negotiating contracts for
23	owners and trainers with racetracks; and
24	WHEREAS, Frank L. Jones, Jr. also chaired the HBPA's finance committee and
25	acted as a legislative liaison; and
26	WHEREAS, in 1997, Frank L. Jones, Jr. was appointed to serve as vice chairman of
27	the Kentucky Horse Racing Commission (KHRC), where he was first appointed by

1 Governor Paul Patton, reappointed by Governor Steve Beshear in 2008, and then 2 reappointed again in 2020 by Governor Andy Beshear; and 3 WHEREAS, Frank L. Jones, Jr. also served as a long-time board member and 4 secretary of the Kentucky Racing Health and Welfare Fund, which provides health 5 resources and financial assistance to the Commonwealth's backstretch workers; and 6 WHEREAS, Frank L. Jones, Jr. served as president of the Kentucky Thoroughbred 7 Owners in 1998-1999, and was a member of the American Horse Council, Thoroughbred 8 Owners and Breeders Association, and the Kentucky Thoroughbred Association. In 9 October of 2022, he was selected as a member of the Horseracing Integrity and Safety 10 Authority's Horseman Advisory Group; and 11 WHEREAS, Frank L. Jones, Jr. was nominated as a candidate for the Ernst and 12 Young Entrepreneur of the Year Award in 1989 and 1990. In 2019, he was also honored 13 with the Warner Jones Award, which recognizes individuals for outstanding contributions 14 to Kentucky racing; and 15 WHEREAS, Frank L. Jones, Jr. was also an accomplished businessman, founding 16 Recreonics, Inc. in Louisville and growing it into a leader in the commercial aquatic 17 industry; and 18 WHEREAS, in his personal life, Frank L. Jones, Jr. was an avid enjoyer of sports, 19 especially enjoying volleyball, basketball, and tennis; and 20 WHEREAS, Frank L. Jones, Jr. passed away Thursday, August 10th at his home in 21 Louisville. Frank was preceded in death by his parents, Frank L. Jones, Sr. and Ann 22 Epperson Jones; sister, Margie Y. Garland; and first wife, Gloria Goodman Jones. He is 23 survived by wife, Nancy Delony-Jones; brother, Morris Jones; Dale Romans, whom he 24 considered to be his son; nephews, Steve (Becky) Baldwin Michael (Jamie) Garland Tim 25 (Stephanie) Garland, Jonathan Jones; niece, Renee Garland; and all the employees of 26 Recreonics, whom he considered his extended family; and

WHEREAS, Frank L. Jones, Jr. is remembered by his friends and family as not just
