

117TH CONGRESS H.R. 6772

To amend the Natural Gas Act to authorize expedited approval of applications to export natural gas to certain allies of the United States, and for other purposes.

A BILL

To amend the Natural Gas Act to authorize expedited approval of applications to export natural gas to certain allies of the United States, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Expediting Natural
- 5 Gas Exports to Allies Act".

SEC. 2. NATURAL GAS EXPORTS TO ALLIES AND STRATEGIC 2 PARTNERS. 3 (a) FINDING.—Congress finds that expediting the approval of natural gas export applications for projects in-4 5 tended to increase the capacity of the United States to export natural gas to allies and strategic partners will— 6 7 (1) empower United States natural gas export-8 ers to better assist the strategic and national secu-9 rity interests of the United States and allies and 10 strategic partners of the United States; and 11 (2) lead to job growth, economic development, 12 and energy security. 13 (b) NATURAL GAS EXPORTS.—Section 3(c) of the Natural Gas Act (15 U.S.C. 717b(c)) is amended— (1) by striking "(c) For purposes" and insert-15 16 ing the following: 17 "(c) Expedited APPLICATION AND APPROVAL 18 Process.— 19 "(1) Definition of Covered Nation.— 20 "(A) IN GENERAL.—In this subsection, the 21 term 'covered nation'— 22 "(i) means an ally described in section 23 3(b)(2) of the Arms Export Control Act 24 (22 U.S.C. 2753(b)(2)); and25 "(ii) during the period described in 26 subparagraph (B), includes Cyprus, Fin-

1	land, Moldova, Sweden, Taiwan, and
2	Ukraine.
3	"(B) Period described.—The period de-
4	scribed in this subparagraph is the period—
5	"(i) beginning on the date of enact-
6	ment of the Expediting Natural Gas Ex-
7	ports to Allies Act; and
8	"(ii) ending on December 31, 2026, or
9	such later date as the President determines
10	is in the interest of national defense (as
11	defined in section 702 of the Defense Pro-
12	duction Act of 1950 (50 U.S.C. 4552)) or
13	is otherwise in the interests of the United
14	States.
15	"(2) Expedited approval.—Except as pro-
16	vided in paragraph (3), for purposes";
17	(2) in paragraph (2) (as so designated), by in-
18	serting "the exportation of natural gas to a covered
19	nation," before "or the exportation"; and
20	(3) by adding at the end the following:
21	"(3) Exclusions.—
22	"(A) Nations subject to sanctions.—
23	The Commission shall not grant expedited ap-
24	proval under paragraph (2) of an application
25	for exportation of natural gas to any nation

1	that is subject to sanctions or trade restrictions
2	imposed by the United States.

"(B) NATIONS DESIGNATED BY CONGRESS.—The Commission shall not grant expedited approval under paragraph (2) of an application for exportation of natural gas to any nation designated by an Act of Congress as excluded from such expedited approval for reasons of national security."

10 (c) EFFECT.—The amendments made by subsection
11 (b) shall not affect any Federal authorization to export
12 natural gas from the United States to a foreign nation
13 or to import natural gas into the United States from a
14 foreign nation that is in effect on the date of enactment
15 of this Act.
