(ii) 8 (3)(i) A party to be married may obtain a replacement for a valid 9 marriage license while the license is valid. 10 (ii) The fee for a replacement license is \$10, payable into the General Fund of the State. 11 12 (n) In Prince George's County: 13 (1)the County Council may set by resolution an additional fee of up to \$60 14 for each license: 15 (2)the clerk shall pay the proceeds from the additional fee to the Director of Finance of the county, who shall distribute the proceeds to the [Family Crisis Center of 16 Prince George's County COMMUNITY CRISIS SERVICES, INC., each month: 17 18 if the [Family Crisis Center of Prince George's County] **COMMUNITY** 19 CRISIS SERVICES, INC., changes its name or objectives or ceases to exist, the proceeds, in 20 addition to designated federal, State, and county funds, shall be used to fund battered 21spouse shelters and domestic violence programs; and 22the County Executive shall prepare and make available an annual **(4)** 23report on or before December 1 of each year on the disposition of fees collected under this 24subsection during the previous fiscal year. 25SECTION 2.
