AN ACT

To establish the New Philadelphia National Historic Site in the State of Illinois as a unit of the National Park System, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "New Philadelphia Na-
- 3 tional Historic Site Act".
- 4 SEC. 2. DEFINITIONS.
- 5 In this Act:
- 6 (1) HISTORIC SITE.—The term "Historic Site"
- 7 means the New Philadelphia National Historic Site
- 8 established by this Act.
- 9 (2) MAP.—The term "Map" means the map ti-
- 10 tled "New Philadelphia National Historic Site Pro-
- posed Boundary', numbered 591/176,516, and
- 12 dated July, 2021.
- 13 (3) Secretary.—The term "Secretary" means
- the Secretary of the Interior.
- 15 (4) STATE.—The term "State" means the State
- of Illinois.
- 17 SEC. 3. ESTABLISHMENT OF NEW PHILADELPHIA.
- 18 (a) Establishment.—Subject to subsection (c),
- 19 there is established the New Philadelphia National His-
- 20 toric Site in the State of Illinois as a unit of the National
- 21 Park System to preserve, protect, and interpret the history
- 22 and archeological resources of the town established by
- 23 Frank McWorter, a formerly enslayed man, in 1836.
- 24 (b) BOUNDARY.—The boundaries of the Historic Site
- 25 shall be the boundaries generally depicted on the Map.

1 (c) Secretarial Determination.—The Historic Site shall not be established until the date on which the 3 Secretary determines that the Secretary has acquired a 4 sufficient quantity of land or interests in and within the 5 boundary of the Historic Site to constitute a manageable 6 unit. 7 (d) Notice.—Not later than 30 days after the date 8 on which the Secretary makes a determination under subsection (c), the Secretary shall publish in the Federal Reg-10 ister notice of the establishment of the Historic Site. SEC. 4. ADMINISTRATION. 12 (a) In General.—The Secretary shall administer land within the boundary of the Historic Site in accord-14 ance with— 15 (1) this Act; and 16 (2) the laws generally applicable to units of the 17 National Park System, including— 18 (A) section 100101(a), chapter 1003, and 19 100752, sections 100751(a), 100753, 20 102101 of title 54, United States Code; and 21 (B) chapter 3201 of title 54, United States 22 Code. 23 (b) Cooperative Agreements.—The Secretary may enter into cooperative agreements with the State or 25 other public and nonpublic entities, under which the Sec-

- 1 retary may identify, interpret, and provide assistance for
- 2 the preservation of non-Federal land within the bound-
- 3 aries of the Historic Site and at sites in close proximity
- 4 to the Historic Site, but located outside the boundaries
- 5 of the Historic Site, including providing for placement of
- 6 directional and interpretive signage, exhibits, and tech-
- 7 nology-based interpretive devices.
- 8 (c) Acquisition of Land.—The Secretary may ac-
- 9 quire any land (including interests in land), within the
- 10 Historic Site boundary by donation, transfer, exchange, or
- 11 purchase from a willing seller using donated or appro-
- 12 priate funds.
- 13 (d) Management Plan.—Not later than 3 years
- 14 after the date on which funds are first made available to
- 15 carry out this Act, the Secretary, in consultation with the
- 16 State, shall complete a general management plan for the
- 17 Historic Site in accordance with any other applicable laws.
- 18 (e) NO BUFFER ZONE CREATED.—Nothing in this
- 19 Act, the acquisition of the land or an interest in land au-
- 20 thorized by this Act, or the management plan for the Park
- 21 shall be construed to create buffer zones outside of the
- 22 Park. That activities or uses can be seen, heard, or de-
- 23 tected from the acquired land shall not preclude, limit,
- 24 control, regulate, or determine the conduct or manage-
- 25 ment of activities or uses outside of the Park.

- 1 (f) Eminent Domain or Condemnation.—In car-
- 2 rying out this Act, the Secretary of the Interior may not
- 3 use eminent domain or condemnation.
