20 21	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 2 (a) (1) The Board may employ one full—time inspector and as many part—time 3 inspectors as the Board considers necessary.
- 4 (2) The employment of the inspectors is subject to the County Personnel 5 Policy and Procedure Manual.
- 6 (b) An individual may not accept appointment or continue as an inspector if the 7 individual or a member of the individual's immediate family has a personal or financial 8 interest directly or indirectly in a license or in a premises licensed under this article.
- 9 (c) An inspector:
- 10 (1) has all the powers of a peace officer or sheriff in the State arising out of 11 or relating to the enforcement of this article; and
- 12 (2) may serve a summons under § 17–2603 of this title.
- 13 (d) An inspector shall:
- 14 (1) investigate all applicants for a license or transfer of a license;
- 15 (2) visit and inspect at unannounced times every licensed premises in the 16 county at least once every 90 days;
- 17 (3) enforce all alcoholic beverages laws:
- 18 (4) investigate all violations of the alcoholic beverages laws and report 19 them to the Board; and
- 20 (5) submit monthly reports in writing to the Board of the inspector's activities, setting forth complaints and listing violations that the inspector observed or were reported to the inspector.
- (e) (1) Subject to paragraph (2) of this subsection, an inspector acting in an official capacity may enter a premises licensed as a cannabis business under Title 36, Subtitle 4 of this article for the purpose of observing whether the requirements of the license are being met.
- 28 **(2) (I) O**N ENTERING THE PREMISES, THE INSPECTOR SHALL 29 ANNOUNCE TO THE LICENSEE OR THE EMPLOYEES OF THE LICENSEE THAT THE 30 INSPECTOR IS ACTING IN AN OFFICIAL CAPACITY AND IS AUTHORIZED TO REMAIN 31 ON THE PREMISES.

- 1 (II) AN INSPECTOR ACTING IN ACCORDANCE WITH THIS 2 SUBSECTION MAY NOT ISSUE A CITATION OR WARNING OR TAKE ANY OTHER ACTION 3 AGAINST THE LICENSEE OR AN EMPLOYEE OF THE LICENSEE.
- 4 **(F)** An inspector shall take the oath required by Article I, § 9 of the Maryland 5 Constitution.
- 6 **[(f)] (G)** The salaries and travel expenses of the inspectors shall be established 7 by the County Commissioners using county personnel department regulations and 8 guidelines.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024.
