4 FOR the purpose of requiring the Prince George's County Local Management Board to
5 develop and implement a certain strategic plan and to submit the strategic plan to
6 certain entities on or before a certain date; authorizing the Prince George's County
7 Local Management Board to apply for and accept donations, grants, or other
8 financial assistance from certain entities; requiring the Prince George's County Local
9 Management Board to submit a certain report including certain information to
10 certain entities on or before a certain date each year; and generally relating to a
11 strategic plan and report by the Prince George's County Local Management Board.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

21 **(A) ON OR BEFORE JANUARY 1, 2018, THE PRINCE GEORGE'S COUNTY**
22 **LOCAL MANAGEMENT BOARD SHALL:**

1 **(1) DEVELOP AND IMPLEMENT A STRATEGIC PLAN TO RAISE**
2 **REVENUES TO MATCH THE TOTAL FUNDING PROVIDED BY THE GOVERNOR'S OFFICE**
3 **FOR CHILDREN; AND**

4 **(2) SUBMIT THE STRATEGIC PLAN TO:**

5 **(I) THE COUNTY EXECUTIVE OF PRINCE GEORGE'S COUNTY;**

6 **(II) THE COUNTY COUNCIL OF PRINCE GEORGE'S COUNTY;**

7 **(III) THE PRINCE GEORGE'S COUNTY SENATE DELEGATION OF**
8 **THE GENERAL ASSEMBLY; AND**

9 **(IV) THE PRINCE GEORGE'S COUNTY HOUSE DELEGATION OF**
10 **THE GENERAL ASSEMBLY.**

11 **(B) THE PRINCE GEORGE'S COUNTY LOCAL MANAGEMENT BOARD MAY**
12 **APPLY FOR AND ACCEPT DONATIONS, GRANTS, OR OTHER FINANCIAL ASSISTANCE**
13 **FROM A GOVERNMENTAL ENTITY OR ANY NONPROFIT OR OTHER PRIVATE**
14 **ORGANIZATION.**

15 **(C) ON OR BEFORE JANUARY 1 EACH YEAR, THE PRINCE GEORGE'S**
16 **COUNTY LOCAL MANAGEMENT BOARD SHALL SUBMIT A REPORT ON THE TOTAL**
17 **REVENUE RECEIVED IN THE PREVIOUS FISCAL YEAR AND THE TOTAL REVENUE**
18 **FROM EACH SOURCE TO:**

19 **(1) THE COUNTY EXECUTIVE OF PRINCE GEORGE'S COUNTY;**

20 **(2) THE COUNTY COUNCIL OF PRINCE GEORGE'S COUNTY;**

21 **(3) THE PRINCE GEORGE'S COUNTY SENATE DELEGATION OF THE**
22 **GENERAL ASSEMBLY; AND**

23 **(4) THE PRINCE GEORGE'S COUNTY HOUSE DELEGATION OF THE**
24 **GENERAL ASSEMBLY.**

25 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
26 **October 1, 2017.**
