A BILL

To amend the United States-Mexico Border Health Commission Act, with respect to preparedness for COVID-19 and other infectious diseases in the border region, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Binational Health
- 5 Strategies Act of 2021".

1 SEC. 2. UNITED STATES-MEXICO BORDER HEALTH COMMIS-

- 2 SION INFECTIOUS DISEASE PREPAREDNESS.
- 3 The United States-Mexico Border Health Commis-
- 4 sion Act (22 U.S.C. 290n et seq.) is amended by inserting
- 5 after section 4 (22 U.S.C. 290n-2) the following:

6 "SEC. 4A. INFECTIOUS DISEASE PREPAREDNESS.

- 7 "(a) Presidential Negotiations.—The President
- 8 is authorized and directed to, not later than 30 days after
- 9 the date of the enactment of this section, seek to begin
- 10 negotiations with Mexico to amend the agreement entered
- 11 into pursuant to section 2, addressing infectious disease
- 12 preparedness in the United States-Mexico Border Area,
- 13 with respect to—
- "(1) COVID-19, including the development of
- the report specified in subsection (b) and the plan
- specified in subsection (c); and
- 17 "(2) other infectious diseases, including the de-
- velopment and implementation of the plan specified
- in subsection (d).
- 20 "(b) COVID-19 RESPONSE.—Not later than 120
- 21 days after the date on which negotiations referred to in
- 22 subsection (a) begin, and annually thereafter (for as long
- 23 as the Commission, acting with the participation of mem-
- 24 bers representing both the United States and Mexican sec-
- 25 tions, determines is necessary), the Commission shall sub-
- 26 mit to Congress a report on the United States-Mexico Bor-

1	der Area's response (beginning on February 1, 2020) to
2	COVID-19, including with respect to testing, contact trac-
3	ing, and other infection prevention and control measures
4	carried out in the United States-Mexico Border Area, in
5	both the United States and Mexico.
6	"(c) COVID-19 BINATIONAL PLAN.—
7	"(1) In general.—Not later than 60 days
8	after the date on which negotiations referred to in
9	subsection (a) begin, the Commission (acting with
10	the participation of members representing both the
11	United States and Mexican sections) shall develop,
12	and publish on a public website of the Commission,
13	a binational strategic plan that addresses, with re-
14	spect to COVID-19, how—
15	"(A) the United States-Mexico Border
16	Area should strengthen its response to COVID-
17	19, with a focus on testing, contact tracing, and
18	other infection prevention and control measures;
19	"(B) the effect of COVID-19 on the eco-
20	nomic conditions in the United States-Mexico
21	Border Area may be mitigated;
22	"(C) the sharing of relevant health data,
23	with respect to COVID-19, including testing
24	and positivity rates, between health agencies

within the United States-Mexico Border Area can be strengthened; and

"(D) a COVID-19 vaccine should be disbursed throughout the United States-Mexico Border Area, taking into account the various vulnerable populations in the region.

"(2) Implementation.—Not later than 90 days after the date on which negotiations referred to in subsection (a) begin, the Commission (acting with the participation of members representing both the United States and Mexican sections) shall develop, and publish on a public website of the Commission, what actions Federal agencies will take within the United States section and agencies of the Government of Mexico will take within the Mexican section of the United States-Mexico Border Area to facilitate implementation of the plan under paragraph (1). At least once each year after the publication of such information, the Commission shall submit to Congress a report on actions taken by Federal agencies and agencies of the Government of Mexico to facilitate that implementation during the year covered by the report.

"(d) Future Infectious Disease Plan.—

1	"(1) In general.—Not later than 180 days
2	after the date on which negotiations referred to in
3	subsection (a) begin, the Commission shall develop
4	and publish a plan to prepare and respond to infec-
5	tious diseases (other than COVID-19) within the
6	United States-Mexico Border Area. Such plan shall
7	address how—
8	"(A) the United States-Mexico Border
9	Area should strengthen its response to such in-
10	fectious diseases, with a focus on testing, con-
11	tact tracing, and other infection prevention and
12	control measures;
13	"(B) the effect of such infectious diseases
14	on the economic conditions in the United
15	States-Mexico Border Area may be mitigated;
16	"(C) the sharing of relevant health data,
17	with respect to such infectious diseases, includ-
18	ing testing and positivity rates, between health
19	agencies within the United States-Mexico Bor-
20	der Area can be strengthened; and
21	"(D) a vaccine for such infectious diseases
22	should be disbursed throughout the United
23	States-Mexico Border Area, taking into account
24	the various vulnerable populations in the region.

1 "(2) UPDATES.—The Commission shall update 2 the plan published under paragraph (1) at least once 3 every 3 years for as long as the Commission, acting 4 with the participation of members representing both 5 the United States and Mexican sections, determines 6 is necessary.

> "(3) IMPLEMENTATION.—Not later than 210 days after the date on which negotiations referred to in subsection (a) begin, the Commission (acting with the participation of members representing both the United States and Mexican sections) shall develop, and publish on a public website of the Commission, what actions Federal agencies will take within the United States section and agencies of the Government of Mexico will take within the Mexican section of the United States-Mexico Border Area to facilitate implementation of the plan under paragraph (1). At least once a year after the publication of such information, the Commission shall submit to Congress a report on actions taken by Federal agencies and agencies of the Government of Mexico to facilitate that implementation during the year covered by the report.

1	"(1) COVID-19.—The term 'COVID-19' re-
2	fers to the 2019 coronavirus disease caused by
3	SARS-CoV-2.
4	"(2) SARS-CoV-2.—The term "SARS-CoV-2"
5	refers to the severe acute respiratory syndrome
6	coronavirus 2 virus responsible for COVID-19 and
7	includes any viral variant mutating therefrom with
8	pandemic potential.".
