Section 4

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Education

13–516.

(g) Subject to the rules, regulations, protocols, orders, and standards of the EMS
Board, a paramedic may administer:

(1) Influenza and hepatitis B immunizations and tuberculosis skin testing,
in a nonemergency environment, to public safety or ambulance service personnel within
the jurisdiction of the paramedic, if the services are:

(i) Authorized by a written agreement between the provider's
jurisdictional EMS operational program medical director or ambulance service medical
director and the county or city health department in whose jurisdiction the services are
performed, which shall include provisions for documentation, referral and follow-up, and
storage and inventory of medicine;

(ii) Under the direction of the jurisdictional EMS operational
program medical director or ambulance service medical director; and

(iii) Approved by the Institute; and

(2) Influenza and ~~2019CoV~~ **COVID-19** immunizations, if the
immunizations are:

(i) 1. Provided under the direction of the EMS operational
program medical director, ambulance service medical director, or other qualified physician;
and

2. Authorized by the Institute;

(ii) Part of a population health outreach effort conducted by the
appropriate local health department or a hospital or health system in the State; and

(iii) Provided in accordance with a written agreement between the
paramedic's EMS operational program or ambulance service and the county or city health
department in the jurisdiction in which the services are performed or a hospital or health
system in the State, which includes provisions for:

SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:
