Mr. Larsen of Washington (for himself and Mrs. Torres) introduced the following bill; which was referred to the Committee on Education and the Workforce

A BILL

To encourage online workforce training.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Online Job Training
- 5 Act of 2018".
- 6 SEC. 2. ONLINE WORKFORCE TRAINING PROGRAMS.
- 7 Section 169 of the Workforce Investment and Oppor-
- 8 tunity Act (29 U.S.C. 3224) is amended by adding at the
- 9 end the following:
- 10 "(d) Online Workforce Training Program.—

1	"(1) National online workforce training
2	GRANTS.—
3	"(A) In general.—From the amount ap-
4	propriated under subparagraph (G), the Sec-
5	retary shall award National Online Workforce
6	Training Grants on a competitive basis to eligi-
7	ble entities to enable such entities to carry out
8	workforce training programs using distance-
9	learning technologies, such as the Internet. An
10	entity may leverage such grant with other Fed-
11	eral, State, local, and private resources, in
12	order to expand the participation of businesses,
13	employees, and other individuals in such train-
14	ing programs.
15	"(B) Eligible entity defined.—For
16	purposes of this subsection, the term 'eligible
17	entity' means an educational institution, com-
18	munity-based organization, nonprofit organiza-
19	tion, State board or local board, or unit of gen-
20	eral local government, which provides online
21	workforce training.
22	"(C) Priority—Priority in awarding
23	grants under this paragraph shall be given to
24	eligible entities that—

1	"(i) have demonstrated experience in
2	implementing and operating online work-
3	force training and education programs;
4	"(ii) have demonstrated experience co-
5	ordinating activities, where appropriate,
6	with the workforce investment system; and
7	"(iii) conduct training for in-demand
8	industry sectors or occupations.
9	"(D) Data collection.—Each eligible
10	entity receiving a grant under this paragraph
11	shall collect and report information on—
12	"(i) the number of participants in the
13	workforce training program funded under
14	this paragraph;
15	"(ii) the services received by the par-
16	ticipants;
17	"(iii) program completion rates;
18	"(iv) factors determined as signifi-
19	cantly interfering with program participa-
20	tion or completion;
21	"(v) the rate of job placement; and
22	"(vi) other information as determined
23	as needed by the Secretary.
24	"(E) Outreach.—Each eligible entity re-
25	ceiving a grant under this paragraph shall con-

1	duct outreach activities to disseminate informa-
2	tion to workforce investment boards, local gov-
3	ernments, educational institutions, and other
4	workforce training organizations about—
5	"(i) the workforce training program
6	funded under this paragraph; and
7	"(ii) the results of such, and the best
8	practices with respect to workforce training
9	identified as a result of, program.
10	"(F) Performance Levels.—The Sec-
11	retary shall establish indicators of performance
12	that will be used to evaluate the performance of
13	eligible entities under this paragraph in car-
14	rying out the activities required under this
15	paragraph. Prior to awarding a grant under
16	this paragraph to an eligible entity, the Sec-
17	retary shall negotiate and reach agreement with
18	the entity regarding the levels of performance
19	expected to be achieved by the entity on the in-
20	dicators of performance.
21	"(G) AUTHORIZATION OF APPROPRIA-
22	TIONS.—There are authorized to be appro-
23	priated to the Secretary to carry out this para-
24	graph \$50,000,000 for fiscal years 2019

through 2029.

1	"(2) Online training program clearing-
2	HOUSE.—
3	"(A) DESCRIPTION OF GRANT.—From the
4	amounts appropriated under subparagraph (D)
5	the Secretary shall award one grant to an eligi-
6	ble institution of higher education to provide
7	the services described in this paragraph.
8	"(B) Eligibility.—To be eligible to re-
9	ceive a grant under this paragraph, an institu-
10	tion of higher education shall—
11	"(i) have demonstrated the ability to
12	disseminate research on best practices for
13	implementing workforce investment activi-
14	ties; and
15	"(ii) be a national leader in producing
16	cutting-edge research on technology related
17	to workforce development systems under
18	this title.
19	"(C) Services.—The postsecondary edu-
20	cational institution that receives a grant under
21	this paragraph shall use such grant—
22	"(i) to provide technical assistance to
23	entities that receive grants under para-
24	graph (1);

1	"(ii) to collect and nationally dissemi-
2	nate the data gathered by entities that re-
3	ceive grants under paragraph (1); and
4	"(iii) to disseminate best practices
5	identified by the Secretary.
6	"(D) Authorization of Appropria-
7	TIONS.—There are authorized to be appro-
8	priated to the Secretary to carry out this sub-
9	section \$1,000,000 for fiscal years 2019
10	through 2029.".
