

1 AN ACT relating to advanced educational opportunities.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 158.6453 is amended to read as follows:

4 (1) As used in this section:

5 (a) "Accelerated learning" means an organized way of helping students meet  
6 individual academic goals by providing direct instruction to eliminate student  
7 performance deficiencies or enable students to move more quickly through  
8 course requirements and pursue higher level skill development;

9 (b) **"Advanced coursework" means educational programs or opportunities**  
10 **designed to challenge students with more rigorous content beyond the**  
11 **standard curriculum, including but not limited to advanced placement,**  
12 **International Baccalaureate, and honors courses;**

13 **(c)** "Constructed-response items" or "performance-based items" means individual  
14 test items that require the student to create an answer rather than select a  
15 response and may include fill-in-the-blank, short-answer, extended-answer,  
16 open-response, and writing-on-demand formats;

17 **(d)**~~(c)~~ "Criterion-referenced test" means a test that is aligned with defined  
18 academic content standards and measures an individual student's level of  
19 performance against the standards;

20 **(e)**~~(d)~~ "End-of-course examination" means the same as defined in KRS  
21 158.860;

22 **(f)**~~(e)~~ "Formative assessment" means a process used by teachers and students  
23 during instruction to adjust ongoing teaching and learning to improve  
24 students' achievement of intended instructional outcomes. Formative  
25 assessments may include the use of commercial assessments, classroom  
26 observations, teacher-designed classroom tests and assessments, and other  
27 processes and assignments to gain information about individual student

1 learning;

2 ~~(g)~~~~(f)~~ "Interim assessments" means assessments that are given periodically  
3 throughout the year to provide diagnostic information and to show individual  
4 student performance against content standards;

5 ~~(h)~~~~(g)~~ "Summative assessment" means an assessment given at the end of the  
6 school year, semester, or other period of time to evaluate students'  
7 performance against content standards within a unit of instruction or a course;  
8 and

9 ~~(i)~~~~(h)~~ "Writing" means a purposeful act of thinking and expression that uses  
10 language to explore ideas and communicate meaning to others. Writing is a  
11 complex, multifaceted act of communication and is distinct from basic  
12 handwriting or penmanship.

13 (2) (a) Beginning in fiscal year 2017-2018, and every six (6) years thereafter, the  
14 Kentucky Department of Education shall implement a process for reviewing  
15 Kentucky's academic standards and the alignment of corresponding  
16 assessments for possible revision or replacement to ensure alignment with  
17 transition readiness standards necessary for global competitiveness, state  
18 career and technical education standards, and KRS 158.196.

19 (b) The revisions to the content standards shall:

- 20 1. Focus on critical knowledge, skills, and capacities needed for success in  
21 the global economy;
- 22 2. Result in fewer but more in-depth standards to facilitate mastery  
23 learning;
- 24 3. Communicate expectations more clearly and concisely to teachers,  
25 parents, students, and citizens;
- 26 4. Be based on evidence-based research;
- 27 5. Consider international benchmarks; and

- 1           6.    Ensure that the standards are aligned from elementary to high school to  
2                   postsecondary education so that students can be successful at each  
3                   education level.
- 4           (c)  1.   The department shall establish four (4) standards and assessments  
5                   review committees, with each committee composed of a minimum of six  
6                   (6) Kentucky public school teachers and a minimum of two (2)  
7                   representatives from Kentucky institutions of higher education,  
8                   including at least one (1) representative from a public institution of  
9                   higher education. Each committee member shall teach in the subject  
10                  area that his or her committee is assigned to review and have no prior or  
11                  current affiliation with a curriculum or assessment resources vendor.
- 12           2.    One (1) of the four (4) committees shall be assigned to focus on the  
13                   review of language arts and writing academic standards and  
14                   assessments, one (1) on the review of mathematics academic standards  
15                   and assessments, one (1) on the review of science academic standards  
16                   and assessments, and one (1) on the review of social studies academic  
17                   standards and assessments.
- 18           (d)  1.   The department shall establish twelve (12) advisory panels to advise and  
19                   assist each of the four (4) standards and assessments review committees.
- 20           2.    Three (3) advisory panels shall be assigned to each standards and  
21                   assessments review committee. One (1) panel shall review the standards  
22                   and assessments for kindergarten through grade five (5), one (1) shall  
23                   review the standards and assessments for grades six (6) through eight  
24                   (8), and one (1) shall review the standards and assessments for grades  
25                   nine (9) through twelve (12).
- 26           3.    Each advisory panel shall be composed of at least one (1) representative  
27                   from a Kentucky institution of higher education and a minimum of six

1 (6) Kentucky public school teachers who teach in the grade level and  
2 subject reviewed by the advisory panel to which they are assigned and  
3 have no prior or current affiliation with a curriculum or assessment  
4 resources vendor.

5 (e) The commissioner of education and the president of the Council on  
6 Postsecondary Education shall also provide consultants for the standards and  
7 assessments review committees and the advisory panels who are business and  
8 industry professionals actively engaged in career fields that depend on the  
9 various content areas.

10 (f) 1. The standards and assessments process review committee is hereby  
11 established and shall be composed of the commissioner of education or  
12 designee as a nonvoting member and nine (9) voting representatives of  
13 public schools, of whom at least two (2) shall be parents of public  
14 school students, appointed by the Governor and confirmed by the Senate  
15 in accordance with KRS 11.160 as follows:

- 16 a. One (1) language arts teacher;
- 17 b. One (1) math teacher;
- 18 c. One (1) science teacher;
- 19 d. One (1) social studies teacher;
- 20 e. Two (2) school principals;
- 21 f. Two (2) school superintendents; and
- 22 g. One (1) school board member.

23 2. On making appointments to the committee, the Governor shall ensure  
24 broad geographical urban and rural representation and representation of  
25 elementary, middle, and high school levels; ensure equal representation  
26 of the two (2) sexes, inasmuch as possible; and ensure that appointments  
27 reflect the minority racial composition of the Commonwealth.

- 1                   3.    The review of the committee shall be limited to the procedural aspects
- 2                           of the review process undertaken prior to its consideration.
- 3                   4.    Notwithstanding KRS 12.028, the committee shall not be subject to
- 4                           reorganization by the Governor.
- 5           (g) 1.    The review process implemented under this subsection shall be an open,
- 6                           transparent process that allows all Kentuckians an opportunity to
- 7                           participate. The department shall ensure the public's assistance in
- 8                           reviewing and suggesting changes to the standards and alignment
- 9                           adjustments to corresponding state assessments by establishing a
- 10                          website dedicated to collecting comments by the public and educators.
- 11                          An independent third party, which has no prior or current affiliation with
- 12                          a curriculum or assessment resources vendor, shall be selected by the
- 13                          department to collect and transmit the comments to the department for
- 14                          dissemination to the appropriate advisory panel for review and
- 15                          consideration.
- 16                   2.    Each advisory panel shall review the standards and assessments for its
- 17                           assigned subject matter and grade level and the suggestions made by the
- 18                           public and educators. After completing its review, each advisory panel
- 19                           shall make recommendations for changes to the standards and alignment
- 20                           adjustments for assessments to the appropriate standards and
- 21                           assessments review committee.
- 22                   3.    Each standards and assessments review committee shall review the
- 23                           findings and make recommendations to revise or replace existing
- 24                           standards and to adjust alignment of assessments.
- 25                   4.    The recommendations shall be published on the website established in
- 26                           this subsection for the purpose of gathering additional feedback from the
- 27                           public. The commissioner shall subsequently present the

1 recommendations and the public feedback to the Interim Joint  
2 Committee on Education.

3 5. The commissioner shall subsequently provide a report to the standards  
4 and assessments process review committee summarizing the process  
5 conducted under this subsection and the resulting recommendations. The  
6 report shall include but not be limited to the timeline of the review  
7 process, public feedback, and responses from the Interim Joint  
8 Committee on Education.

9 6. After receiving the commissioner's report, the standards and assessments  
10 process review committee shall either concur that stakeholders have had  
11 adequate opportunity to provide input on standards and the  
12 corresponding alignment of state assessments or find the input process  
13 deficient. If the process is found deficient, the recommendations may be  
14 returned to the appropriate standards and assessments review committee  
15 for review as described in subparagraph 3. of this paragraph. If the  
16 process is found sufficient, the recommendations shall be forwarded  
17 without amendment to the Kentucky Board of Education.

18 (h) The Kentucky Board of Education shall promulgate administrative regulations  
19 in accordance with KRS Chapter 13A as may be needed for the administration  
20 of the review process, including staggering the timing and sequence of the  
21 review process by subject area and remuneration of the review committees  
22 and advisory panels described in paragraphs (c) and (d) of this subsection.

23 (i) 1. The Kentucky Board of Education shall consider for approval the  
24 revisions to academic standards for a content area and the alignment of  
25 the corresponding state assessment once recommendations are received  
26 from the standards and assessments process review committee. Existing  
27 state academic standards shall remain in place until the board approves

- 1 new standards.
- 2 2. Any revision to, or replacement of, the academic standards and  
3 assessments as a result of the review process conducted under this  
4 subsection shall be implemented in Kentucky public schools no later  
5 than the second academic year following the review process. Existing  
6 academic standards shall be used until new standards are implemented.
- 7 3. The Department of Education shall disseminate the academic content  
8 standards to the schools and teacher preparation programs.
- 9 (j) The Department of Education shall provide or facilitate statewide training  
10 sessions for existing teachers and administrators on how to:
- 11 1. Integrate the revised content standards into classroom instruction;  
12 2. Better integrate performance assessment of students within their  
13 instructional practices; and  
14 3. Help all students use higher-order thinking and communication skills.
- 15 (k) The Education Professional Standards Board in cooperation with the  
16 Kentucky Board of Education and the Council on Postsecondary Education  
17 shall coordinate information and training sessions for faculty and staff in all of  
18 the teacher preparation programs in the use of the revised academic content  
19 standards. The Education Professional Standards Board shall ensure that each  
20 teacher preparation program includes use of the academic standards in the  
21 pre-service education programs and that all teacher interns will have  
22 experience planning classroom instruction based on the revised standards.
- 23 (l) The Council on Postsecondary Education in cooperation with the Kentucky  
24 Department of Education and the postsecondary education institutions in the  
25 state shall coordinate information sessions regarding the academic content  
26 standards for faculty who teach in the various content areas.
- 27 (3) (a) The Kentucky Board of Education shall be responsible for creating and

1 implementing a balanced statewide assessment program that measures the  
2 students', schools', and districts' achievement of the goals set forth in KRS  
3 158.645 and 158.6451, to ensure compliance with the federal Every Student  
4 Succeeds Act of 2015, Pub. L. No. 114-95, or its successor, and to ensure  
5 school accountability.

6 (b) The board shall revise the annual statewide assessment program as needed in  
7 accordance with revised academic standards and corresponding assessment  
8 alignment adjustments approved by the board under subsection (2) of this  
9 section.

10 (c) The statewide assessments shall not include any academic standards not  
11 approved by the board under subsection (2) of this section.

12 (d) The board shall seek the advice of the Office of Education Accountability; the  
13 School Curriculum, Assessment, and Accountability Council; the Education  
14 Assessment and Accountability Review Subcommittee, and the department's  
15 technical advisory committee in the development of the assessment program.  
16 The statewide assessment program shall not include measurement of a  
17 student's ability to become a self-sufficient individual or to become a  
18 responsible member of a family, work group, or community.

19 (4) (a) The academic components of the statewide assessment program shall be  
20 composed of annual student summative tests, which may include a  
21 combination of multiple competency-based assessment and performance  
22 measures approved by the Kentucky Board of Education.

23 (b) The annual student summative tests shall:  
24 1. Measure individual student achievement in language, reading, English,  
25 mathematics, science, and social studies at designated grades;  
26 2. Provide teachers and parents a valid and reliable comprehensive analysis  
27 of skills mastered by individual students;

- 1           3.    Provide diagnostic information that identifies strengths and academic
- 2                deficiencies of individual students in the content areas;
- 3           4.    Provide information to teachers that can enable them to improve
- 4                instruction for current and future students;
- 5           5.    Provide longitudinal profiles for students; and
- 6           6.    Ensure school and district accountability for student achievement of the
- 7                goals set forth in KRS 158.645 and 158.6451, except the statewide
- 8                assessment program shall not include measurement of a student's ability
- 9                to become a self-sufficient individual or to become a responsible
- 10              member of a family, work group, or community.
- 11   (5)   The state student assessments shall include the following components:
- 12       (a)   Elementary and middle grades requirements are:
- 13           1.    A criterion-referenced test each in mathematics and reading in grades
- 14                three (3) through eight (8) that is valid and reliable for an individual
- 15                student and that measures the depth and breadth of Kentucky's academic
- 16                content standards;
- 17           2.    A criterion-referenced test each in science and social studies that is valid
- 18                and reliable for an individual student as necessary to measure the depth
- 19                and breadth of Kentucky's academic content standards to be
- 20                administered one (1) time within the elementary and middle grades,
- 21                respectively;
- 22           3.    An on-demand assessment of student writing to be administered one (1)
- 23                time within the elementary grades and one (1) time within the middle
- 24                grades; and
- 25           4.    An editing and mechanics test relating to writing, using multiple choice
- 26                and constructed response items, to be administered one (1) time within
- 27                the elementary and the middle grades, respectively;

- 1 (b) High school requirements are:
- 2 1. A criterion-referenced test in mathematics, reading, and science that is
- 3 valid and reliable for an individual student and that measures the depth
- 4 and breadth of Kentucky's academic content standards to be
- 5 administered one (1) time within the high school grades;
- 6 2. A criterion-referenced test in social studies that is valid and reliable for
- 7 an individual student as necessary to measure the depth and breadth of
- 8 Kentucky's academic content standards to be administered one (1) time
- 9 within the high school grades;
- 10 3. An on-demand assessment of student writing to be administered one (1)
- 11 time within the high school grades;
- 12 4. An editing and mechanics test relating to writing, using multiple choice
- 13 and constructed response items, to be administered one (1) time within
- 14 the high school grades; and
- 15 5. A college admissions examination to assess English, reading,
- 16 mathematics, and science in the spring of grade eleven (11);
- 17 (c) The Kentucky Board of Education shall add any other component necessary
- 18 to comply with the Every Student Succeeds Act of 2015, Pub. L. No. 114-95,
- 19 or its successor, as determined by the United States Department of Education;
- 20 (d) The criterion-referenced components required in this subsection shall be
- 21 composed of constructed response items and multiple choice items;
- 22 (e) The Kentucky Board of Education may incorporate end-of-course
- 23 examinations into the assessment program to be used in lieu of requirements
- 24 for criterion-referenced tests required under paragraph (b) of this subsection;
- 25 and
- 26 (f) The results of the assessment program developed under this subsection shall
- 27 be used by schools and districts to determine appropriate instructional

1           modifications for all students in order for students to make continuous  
2           progress, including that needed by advanced learners.

3   (6) Each school district shall administer the statewide student assessment during the  
4       last fourteen (14) days of school in the district's instructional calendar. The  
5       Kentucky Board of Education may change the testing window to allow for  
6       innovative assessment systems or other online test administration and shall  
7       promulgate administrative regulations that minimize the number of days of testing  
8       and outline the procedures to be used during the testing process to ensure test  
9       security, including procedures for testing makeup days, and to comply with federal  
10      assessment requirements.

11   (7) A student enrolled in a district-operated or district-contracted alternative program  
12      shall participate in the appropriate assessments required by this section.

13   (8) A local school district may select and use commercial interim or formative  
14      assessments or develop and use its own formative assessments to provide data on  
15      how well its students are growing toward mastery of Kentucky academic standards,  
16      so long as the district's local school board develops a policy minimizing the  
17      reduction in instructional time related to the administration of the interim  
18      assessments. Nothing in this section precludes teachers from using ongoing teacher-  
19      developed formative processes.

20   (9) Each school that enrolls primary students shall use diagnostic assessments and  
21      prompts that measure readiness in reading and mathematics for its primary students  
22      as determined by the school to be developmentally appropriate. The schools may  
23      use commercial products, use products and procedures developed by the district, or  
24      develop their own diagnostic procedures. The results shall be used to inform the  
25      teachers and parents or guardians of each student's skill level.

26   (10) The state board shall ensure that a technically sound longitudinal comparison of the  
27      assessment results for the same students shall be made available.

1 (11) The following provisions shall apply to the college admissions examination  
2 described in subsection (5)(b)5. of this section:

3 (a) The cost of the college admissions examination administered to students in  
4 high school shall be paid for by the Kentucky Department of Education. The  
5 costs of additional college admissions examinations shall be the responsibility  
6 of the student;

7 (b) If funds are available, the Kentucky Department of Education shall provide a  
8 college admissions examination preparation program to all public high school  
9 juniors. The department may contract for necessary services; and

10 (c) Accommodations provided to a student with a disability taking the college  
11 admissions assessment under this subsection shall consist of:

12 1. Accommodations provided in a manner allowed by the college  
13 admissions assessment provider when results in test scores are  
14 reportable to a postsecondary institution for admissions and placement  
15 purposes, except as provided in subparagraph 2. of this paragraph; or

16 2. Accommodations provided in a manner allowed by a student's  
17 individualized education program as defined in KRS 158.281 for a  
18 student whose disability precludes valid assessment of his or her  
19 academic abilities using the accommodations provided under  
20 subparagraph 1. of this paragraph when the student's scores are not  
21 reportable to a postsecondary institution for admissions and placement  
22 purposes.

23 (12) Kentucky teachers shall have a significant role in providing feedback about the  
24 design of the assessments, except for the college admissions exam described in  
25 subsection (5)(b)5. of this section. The assessments shall be designed to:

26 (a) Measure grade appropriate core academic content, basic skills, and higher-  
27 order thinking skills and their application;

1 (b) Provide valid and reliable scores for schools. If scores are reported for  
2 students individually, they shall be valid and reliable;

3 (c) Minimize the time spent by teachers and students on assessment; and

4 (d) Assess Kentucky academic standards only.

5 (13) The results from assessment under subsections (3) and (5) of this section shall be  
6 reported to the school districts and schools no later than seventy-five (75) days  
7 following the last day the assessment can be administered. Assessment reports  
8 provided to the school districts and schools shall include an electronic copy of an  
9 operational subset of test items from each assessment administered to their students  
10 and the results for each of those test items by student and by school.

11 (14) The Department of Education shall gather information to establish the validity of  
12 the assessment and accountability program. It shall develop a biennial plan for  
13 validation studies that shall include but not be limited to the consistency of student  
14 results across multiple measures, the congruence of school scores with documented  
15 improvements in instructional practice and the school learning environment, and the  
16 potential for all scores to yield fair, consistent, and accurate student performance  
17 level and school accountability decisions. Validation activities shall take place in a  
18 timely manner and shall include a review of the accuracy of scores assigned to  
19 students and schools, as well as of the testing materials. The plan shall be submitted  
20 to the Commission by July 1 of the first year of each biennium. A summary of the  
21 findings shall be submitted to the Legislative Research Commission by September  
22 1 of the second year of the biennium.

23 (15) The Department of Education and the state board shall offer optional assistance to  
24 local school districts and schools in developing and using continuous assessment  
25 strategies needed to ensure student progress. The continuous assessment shall  
26 provide diagnostic information to improve instruction to meet the needs of  
27 individual students.

- 1 (16) The Administration Code for Kentucky's Assessment Program shall include  
2 prohibitions of inappropriate test preparation activities by school district employees  
3 charged with test administration and oversight, including but not limited to the issue  
4 of teachers being required to do test practice in lieu of regular classroom instruction  
5 and test practice outside the normal work day. The code shall include disciplinary  
6 sanctions that may be taken toward a school or individuals.
- 7 (17) The Kentucky Board of Education, after the Department of Education has received  
8 advice from the Office of Education Accountability; the School Curriculum,  
9 Assessment, and Accountability Council; and the department's technical advisory  
10 committee, shall promulgate an administrative regulation under KRS Chapter 13A  
11 to establish the components of a reporting structure for assessments administered  
12 under this section. The reporting structure shall include the following components:
- 13 (a) A school report card that clearly communicates with parents and the public  
14 about school performance. The school report card shall be sent to the parents  
15 of the students of the districts, and information on electronic access to a  
16 summary of the results for the district shall be published in the newspaper  
17 with the largest circulation in the county. It shall include but not be limited to  
18 the following components reported by race, gender, and disability when  
19 appropriate:
- 20 1. Student academic achievement, including the results from each of the  
21 assessments administered under this section;
  - 22 2. For Advanced Placement, Cambridge Advanced International, and  
23 International Baccalaureate, the courses offered, the number of students  
24 enrolled, completing, and taking the examination for each course, and  
25 the percentage of examinees receiving a score of three (3) or better on  
26 AP examinations, a score of "e" or better on Cambridge Advanced  
27 International examinations, or a score of four (4) or better on IB

- 1 examinations. The data shall be disaggregated by gender, race, students  
2 with disabilities, and economic status;
- 3 3. Nonacademic achievement, including the school's attendance, retention,  
4 graduation rates, and student transition to postsecondary;
- 5 4. School learning environment, including measures of parental  
6 involvement; and
- 7 5. Any other school performance data required by the Every Student  
8 Succeeds Act of 2015, Pub. L. No. 114-95, or its successor;
- 9 (b) An individual student report to parents for each student in grades three (3)  
10 through eight (8) summarizing the student's skills in reading, science, social  
11 studies, and mathematics. The school's staff shall develop a plan for  
12 accelerated learning for any student with identified deficiencies or strengths;  
13 and
- 14 (c) A student's score on the college admissions assessment administered under  
15 subsection (5)(b)5. of this section.
- 16 (18) (a) Beginning in fiscal year 2017-2018, and every six (6) years thereafter, the  
17 Kentucky Department of Education shall implement a comprehensive process  
18 for reviewing and revising the academic standards in visual and performing  
19 arts and practical living skills and career studies for all levels and in foreign  
20 language for middle and high schools. The department shall develop review  
21 committees for the standards for each of the content areas that include  
22 representation from certified specialist public school teachers and  
23 postsecondary teachers in those subject areas.
- 24 (b) The academic standards in practical living skills for elementary, middle, and  
25 high school levels shall include a focus on drug abuse prevention, with an  
26 emphasis on the prescription drug epidemic and the connection between  
27 prescription opioid abuse and addiction to other drugs, such as heroin and

1 synthetic drugs.

2 (c) The department shall provide to all schools guidelines for programs that  
3 incorporate the adopted academic standards in visual and performing arts and  
4 practical living and career studies. The department shall provide to middle and  
5 high schools guidelines for including a foreign language program. The  
6 guidelines shall address program length and time, courses offered, staffing,  
7 resources, and facilities.

8 (d) The Kentucky Department of Education, in consultation with certified public  
9 school teachers of visual and performing arts, may develop program standards  
10 for the visual and performing arts.

11 (19) The Kentucky Department of Education shall provide to all school districts  
12 guidelines for including an effective writing program within the curriculum.

13 (20) (a) The Kentucky Department of Education, in consultation with the review  
14 committees described in subsection (18) of this section, shall develop a school  
15 profile report to be used by all schools to document how they will address the  
16 adopted academic standards in their implementation of the programs as  
17 described in subsection (18) of this section, which may include student  
18 opportunities and experiences in extracurricular activities. The department  
19 shall include the essential workplace ethics program on the school profile  
20 report.

21 (b) By October 1 of each year, each school principal shall complete the school  
22 profile report, which shall be signed by the members of the school council, or  
23 the principal if no school council exists, and the superintendent. The report  
24 shall be electronically transmitted to the Kentucky Department of Education,  
25 and the original shall be maintained on file at the local board office and made  
26 available to the public upon request. The department shall include a link to  
27 each school's profile report on its website.

- 1 (c) If a school staff member, student, or a student's parent has concerns regarding  
2 deficiencies in a school's implementation of the programs described in  
3 subsection (18) of this section, he or she may submit a written inquiry to the  
4 school council.

5 **(21) (a) No later than December 1, 2025, each local board of education shall adopt a**  
6 **district plan establishing clear policies on the promotion of advanced**  
7 **coursework or accelerated learning in language arts, mathematics, social**  
8 **studies, and science by grade level for students in grades four (4) to twelve**  
9 **(12).**

10 **(b) The district plan required by paragraph (a) of this subsection shall:**

- 11 **1. Be published on a publicly accessible location on the district website;**  
12 **2. Describe the strategies and approach to advanced coursework or**  
13 **accelerated learning options by grade level for language arts,**  
14 **mathematics, social studies, and science; and**  
15 **3. Require that the service delivery options for students identified as**  
16 **gifted and talented in language arts, mathematics, social studies, and**  
17 **science include the following for each grade level and subject area:**  
18 **a. i. Accelerated learning; or**  
19 **ii. Advanced coursework; and**
