3 COMMENDING THE GFWC LEGACY ON THE OCCASION OF 20TH
4 ANNIVERSARY.

6 WHEREAS, highest commendations are extended to the
7 GFWC Legacy on the occasion of their 20th Anniversary; and

8 WHEREAS, GFWC Legacy is a not-for-profit women's
9 service club operating under the umbrella of the Alabama
10 Federation of Women's Clubs and the General Federation of
11 Women's Clubs (GFWC) in Huntsville, Alabama, one of the
12 world's largest and oldest nonpartisan, nondenominational
13 women's volunteer service organizations; the AFWC was
14 organized in 1895 and chartered into GFWC in 1907; and

15 WHEREAS, in 2000, GFWC Legacy was founded by 12
16 women who attended an organization meeting, adopted bylaws and
17 elected officers; GFWC Legacy projects have benefitted many
18 local organizations some of which are Alzheimer's Association,
19 CASA, Second Mile Development, First Stop, The Neighborhood
20 Store, Hope Place, Crisis Services of North Alabama, the
21 National Children's Advocacy Center, Children's Rehabilitation
22 Center, St. Jude's Regional Clinic, Meals on Wheels, 305 8th
23 Street, Tut Fann Veteran's Home, Still Serving Veterans,
24 Operation Green Team, Huntsville-Madison County Public
25 Library, numerous schools, hospice and nursing homes; they

1 have also supported Camp Smile-A-Mile, Big Oak Ranch,
2 Operation Smile, Heifer International, UNICEF, Alabama PTA,
3 and American Red Cross; and

4 WHEREAS, in 2007, the first GFWC Legacy scholarship
5 was awarded to a local high school female graduate based on
6 her community volunteer involvement; the scholarship has been
7 awarded in each subsequent year, with two scholarships being
8 awarded in 2020; and

9 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
10 HOUSES THEREOF CONCURRING, That GFWC Legacy is honored and
11 commended, and this resolution is offered in highest tribute
12 to its distinguished leadership on the occasion of its 20th
13 Anniversary.
