THE GOVERNOR'S PROPOSED BUDGET FOR FISCAL YEAR 2019 SHALL INCLUDE FOR PROGRAM D26A07.03 COMMUNITY SERVICES A GENERAL FUND APPROPRIATION OF \$1,000,000 OVER THE GENERAL FUND APPROPRIATION PROVIDED IN THE LEGISLATIVE APPROPRIATION IN FISCAL YEAR 2018 TO INCREASE FUNDING FOR THE OMBUDSMAN PROGRAM AND THE PUBLIC GUARDIANSHIP PROGRAM OVER THE FUNDING LEVELS ESTABLISHED FOR THOSE PROGRAMS FOR FISCAL YEAR 2018.
