A BILL ENTITLED

1 AN ACT concerning

2 **County Boards of Education – Root Causes of Chronic Absenteeism and**
3 **Expulsion – Investigation and Reporting**

4 FOR the purpose of requiring each county board of education to investigate, identify, and
5 report on root causes of chronic absenteeism and expulsion in the county; and
6 generally relating to the investigation and reporting of chronic absenteeism and
7 expulsion.

10 Section 4–147

11 Annotated Code of Maryland

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **4–147.**

17 **(A) EACH COUNTY BOARD SHALL INVESTIGATE AND IDENTIFY ROOT**
18 **CAUSES OF CHRONIC ABSENTEEISM AND EXPULSION IN THE COUNTY.**

19 **(B) (1) AN INVESTIGATION PERFORMED UNDER SUBSECTION (A) OF THIS**
20 **SECTION SHALL EXAMINE A STUDENT’S:**

21 **(I) DOMESTIC SITUATION;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **(II) FAMILY VACATIONS;**

2 **(III) HISTORY OF ALCOHOL OR DRUG ADDICTION;**

3 **(IV) MENTAL HEALTH;**

4 **(V) PHYSICAL HEALTH; AND**

5 **(VI) SCHOOL ENVIRONMENT.**

6 **(2) THE INVESTIGATION SHALL ALSO EXAMINE WHETHER THE**
7 **STUDENT IS PROVIDING:**

8 **(I) CARE FOR SOMEONE IN THE STUDENT'S HOUSEHOLD; OR**

9 **(II) LANGUAGE TRANSLATION FOR A MEMBER OF THE**
10 **STUDENT'S HOUSEHOLD WHO IS SICK.**

11 **(C) BEGINNING JANUARY 1, 2026, AND EACH QUARTER THEREAFTER FOR A**
12 **PERIOD OF 10 YEARS, EACH COUNTY BOARD SHALL REPORT, IN ACCORDANCE WITH**
13 **§ 2-1257 OF THE STATE GOVERNMENT ARTICLE, TO EACH APPLICABLE COUNTY**
14 **DELEGATION TO THE GENERAL ASSEMBLY, THE SENATE EDUCATION, ENERGY, AND**
15 **THE ENVIRONMENT COMMITTEE, AND THE HOUSE WAYS AND MEANS COMMITTEE,**
16 **ON THE FINDINGS UNDER SUBSECTION (B) OF THIS SECTION.**

17 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**
18 **1, 2025.**
