A BILL

To amend title 5, United States Code, to allow certain senior employees in the judicial branch of Government to carry over up to 90 days of annual leave each year, and for other purposes.

- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Judicial Branch Senior
- 5 Executive Leave Efficiency and Modernization Act of
- 6 2020".

1	SEC. 2. CARRY OVER OF ANNUAL LEAVE FOR CERTAIN SEN-
2	IOR POSITIONS IN THE JUDICIAL BRANCH OF
3	GOVERNMENT.
4	Paragraph (1) of section 6304(f) of title 5, United
5	States Code, is amended—
6	(1) in subparagraph (G), by striking "or" at
7	the end;
8	(2) in the first subparagraph (H) (relating to
9	Library of Congress positions), by striking the pe-
10	riod at the end and inserting a semicolon;
11	(3) by redesignating the second subparagraph
12	(H) (relating to positions in the United States Se-
13	cret Service Uniformed Division) as subparagraph
14	(I);
15	(4) in subparagraph (I), as redesignated by
16	paragraph (3), by striking the period at the end and
17	inserting "; or"; and
18	(5) by adding at the end the following:
19	"(J) any of the following positions within the
20	judicial branch of Government:
21	"(i) Bankruptcy Administrator as de-
22	scribed in section $302(d)(3)(I)$ of Public Law
23	99–554.
24	"(ii) Circuit executive appointed under sec-
25	tion 332(e) of title 28

1	"(iii) Chief circuit librarian appointed
2	under section 713(a) of title 28.
3	"(iv) Senior staff attorney appointed under
4	section 715(a) of title 28.
5	"(v) Federal public defender appointed
6	under section $3006A(g)(2)(A)$ of title 18.
7	"(vi) Chief pretrial services officer ap-
8	pointed under section 3152(c) of title 18.
9	"(vii) Chief probation officer appointed
10	under section 3602(c) of title 18.
11	"(viii) Any clerk appointed pursuant to
12	section 156(b), 711(a), 751(a), 791(a), or 871
13	of title 28, but not including any chief deputy
14	clerk, assistant clerk, or deputy clerk appointed
15	under such section 871.
16	"(ix) District Court Executive.
17	"(x) Chief Circuit Mediator.
18	"(xi) The Director, the Deputy Director,
19	the Director of the Education Division, the Di-
20	rector of the Research Division, and the Direc-
21	tor of the Information Technology Office within
22	the Federal Judicial Center.
23	"(xii) The Staff Director, the Deputy Staff
24	Director, the General Counsel, the Director of
25	Education and Sentencing Practices, the Direc-

tor of Research and Data, the Director of Legislative and Public Affairs, and the Director of Administration within the United States Sentencing Commission.".
