A BILL TO BE ENTITLED

AN ACT AWARDING A LEGISLATIVE SALARY INCREASE FOR JUVENILE JUSTICE STAFF AND APPROPRIATING FUNDS FOR THAT PURPOSE.

The General Assembly of North Carolina enacts:

SECTION 1.(a) Effective July 1, 2025, there is appropriated from the General Fund to the Department of Public Safety, Division of Juvenile Justice and Delinquency Prevention, the sum of ten million four hundred thousand dollars (\$10,400,000) in recurring funds for the 2025-2026 fiscal year and the sum of fourteen million one hundred thousand dollars (\$14,100,000) in recurring funds for the 2026-2027 fiscal year to be allocated for employee salary increases as awarded by Section 2 of this act.

SECTION 1.(b) Of the funds appropriated in subsection (a) of this section, the sum of three million nine hundred thousand dollars (\$3,900,000) shall be allocated to reduce salary compression in connection with these increases.

SECTION 2.(a) Effective for the 2025-2027 fiscal biennium, the following annual salary schedules shall be in effect for Youth Counselor Technicians, Youth Services Behavioral Specialists, and Youth Counselors in the Division of Juvenile Justice and Delinquency Prevention:
