A BILL

To amend the National and Community Service Act of 1990 to establish a National Climate Service Corps to help communities withstand and respond to changes in the Earth's climate with respect to natural disasters, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Climate Serv-
- 5 ice Corps and Careers Network Act of 2021".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

- 1 (1) Every region of the United States is con2 fronting the effects of climate change and related
 3 natural disasters, including extreme heat and
 4 droughts, heavy rains and flooding, hurricanes and
 5 tornadoes, acidification of the oceans and sea level
 6 rise, wildfires, and mudslides, among other effects.
 - (2) These changes affect the health, agriculture, food supply, infrastructure, energy supply, water quality and water supply, and have the potential to reduce the standard of living and quality of life in the United States.
 - (3) The Fourth National Climate Assessment estimates that low-income communities will be disproportionately impacted by climate change through higher rates of adverse health conditions, greater exposure to environmental hazards, and more severe impacts and longer recovery from natural disasters.
 - (4) The Fourth National Climate Assessment estimates that—
 - (A) climate change will shrink the American economy by up to 10 percent by the year 2100 and will result in losses up to \$141,000,000,000 from heat-related deaths, \$118,000,000,000 from sea level rise, and

- 1 \$32,000,000,000 from infrastructure damage; 2 and
 - (B) proactive adaptation initiatives yield benefits in excess of their costs in both the near term and long term.
 - (5) The frequency and severity of natural disasters taking place each year is steadily and significantly increasing. In 1970, there were 78 registered natural disasters. In 2017, there were 335 natural disasters, impacting approximately 96,000,000 people and costing the United States more than \$306,000,000,000.
 - (6) Service and Conservation Corps, which are descended from the Civilian Conservation Corps of the 1930s, are trained for and have experience with the four stages of disaster: mitigation, preparedness, response, and recovery.
 - (7) During the COVID-19 pandemic, climate change did not stop. The existing network of 137 Service and Conservation Corps continued to respond to the needs of their communities. This included fighting wildfires to controlling erosion.

1 SEC. 3. NATIONAL CLIMATE SERVICE CORPS.

2	(a) In General.—Section 122(a) of the National
3	and Community Service Act of 1990 (42 U.S.C. 12572(a))
4	is amended—
5	(1) by redesignating paragraphs (4) and (5) as
6	paragraphs (5) and (6), respectively; and
7	(2) by inserting after paragraph (3) the fol-
8	lowing new paragraph:
9	"(4) National climate service corps.—
10	"(A) Purpose.—
11	"(i) In general.—The recipient may
12	carry out national service projects through
13	a Climate Service Corps that improves
14	community adaptation, mitigation, pre-
15	paredness, response, and recovery from
16	natural disaster and other trends related
17	to climate change through activities such
18	as those described in subparagraph (B)
19	and improves performance on the indica-
20	tors described in subparagraph (C).
21	"(ii) Selection priority.—In se-
22	lecting national service projects to carry
23	out under this paragraph, the recipient
24	shall, to the extent practicable, carry out
25	projects in communities that are dispropor-
26	tionately impacted by climate and severe

1	weather events, including from commu-
2	nities of color, low-income communities,
3	and tribal communities.
4	"(B) Activities.—
5	"(i) In General.—A Climate Service
6	Corps described in this paragraph may
7	carry out activities, including—
8	"(I) assessing community resil-
9	ience to the effects of climate change;
10	"(II) supporting climate adapta-
11	tion and mitigation of the negative ef-
12	fects of climate change;
13	"(III) environmental sustain-
14	ability and resiliency;
15	"(IV) emergency preparedness;
16	"(V) promoting sustainable and
17	resilient communities;
18	"(VI) assisting with recovery
19	from disasters to rebuild in a manner
20	that provides improved resilience or
21	adaptation for future climate impacts;
22	"(VII) assisting with prevention,
23	recovery, or restoration of wildland,
24	rangeland, and wildland-urban inter-
25	face areas from the effects of wildfire

1	and associated impacts due to the ef-
2	fects of climate change; or
3	"(VIII) other relevant activities,
4	as determined by the Corporation.
5	"(ii) Participation.—In addition to
6	the requirements for participants under
7	section 137, in carrying out national serv-
8	ice projects under this paragraph, the re-
9	cipient shall, to the extent practicable—
10	"(I) select as participants indi-
11	viduals who are at least 16 but not
12	more than 30 years of age (including
13	out of-school youth and other dis-
14	advantaged youth (such as individuals
15	who are aging out of foster care, indi-
16	viduals who have limited English pro-
17	ficiency, homeless individuals, and in-
18	dividuals with disabilities)), and vet-
19	erans who have not reached the age of
20	36, at the time of beginning the term
21	of service; and
22	$``(\Pi)$ provide each participant
23	with team-based, highly structured,
24	and adult-supervised work experience,
25	education, career guidance, and coun-

1	seling, and employment training, sup-
2	port services, and mentoring.
3	"(C) NATIONAL CLIMATE SERVICE CORPS
4	INDICATORS.—The indicators for a Climate Re-
5	siliency Service Corps program described in this
6	paragraph are—
7	"(i) the number of acres, miles,
8	homes, buildings or infrastructure projects
9	built, improved, or treated for improved re-
10	silience and adaptation;
11	"(ii) the number of individuals edu-
12	cated about and prepared for disasters and
13	other trends related to climate change;
14	"(iii) the number of individuals as-
15	sisted, including those rescued, evacuated,
16	or provided shelter;
17	"(iv) the number of tons of debris col-
18	lected;
19	"(v) the number of homes or buildings
20	treated, including those boarded up,
21	tarped, mucked, or gutted during disaster
22	response;
23	"(vi) the number of acres, homes, or
24	buildings restored during disaster recovery:

1	"(vii) the number of trees and plants
2	planted;
3	"(viii) the number of infrastructure
4	projects undertaken to improve resilience
5	against future natural disasters;
6	"(ix) the number of economically dis-
7	advantaged individuals with access to job
8	training and other skill enhancement;
9	"(x) the number of economically dis-
10	advantaged individuals with access to in-
11	formation about job placement services;
12	"(xi) the number of individuals receiv-
13	ing education or training in environ-
14	mentally conscious practices;
15	"(xii) any additional indicator relating
16	to natural disaster and other trends that
17	the Corporation establishes, in consultation
18	(as appropriate), with the Secretaries of
19	the Departments of the Interior, Agri-
20	culture, Commerce, and Defense, the Di-
21	rector of the Federal Emergency Manage-
22	ment Agency, and the Administrator of the
23	Environmental Protection Agency; and
24	"(xiii) any additional local indicator
25	applicable to a particular recipient and on

- 1 which an improvement in performance is 2 needed related to climate change. "(D) 3 LIVING ALLOWANCE.—Notwith-4 standing section 140(a), no participant shall re-5 ceive a living allowance that is less than the 6 equivalent of \$15 per hour.". 7 (b) Conforming Amendments.—Section 122 of the 8 National and Community Service Act of 1990 (42 U.S.C. 12572), as amended by subsection (a), is further amend-10 ed— 11 (1) in paragraph (b)(3), by striking "or (5)" 12 and inserting "(5), or (6)"; and 13 (2) in paragraph (c)(1), by striking "(5)" and 14 inserting "(6)". 15 SEC. 4. ENVIRONMENTAL JUSTICE TASK FORCE.
- 16 (a) In General.—Each recipient of a subgrant
- 17 under section 122(a) of the National and Community
- 18 Service Act of 1990 (42 U.S.C. 12572(a)) that receives
- 19 such subgrant for the purpose of establishing a National
- 20 Climate Service Corps in a subdivision of a State shall
- 21 ensure that such Corps forms an Environmental Justice
- 22 Task Force (in this section referred to as the "Task
- 23 Force") to advise and consult on community-based
- 24 projects and recruitment.

- 1 (b) Duties.—Each Task Force shall have an advi-
- 2 sory role in agenda-setting and shall prioritize projects
- 3 that address environmental justice and benefit commu-
- 4 nities that have suffered systemic racial, social, and eco-
- 5 nomic injustices, and face a disproportionate burden of ad-
- 6 verse human health or environmental effects.
- 7 (c) Composition.—Each Task force shall include—
- 8 (1) local elected officials;
- 9 (2) local educators;
- 10 (3) faith-based leaders;
- 11 (4) veterans advocates;
- 12 (5) State and local service corps leadership; and
- 13 (6) community leaders.
- 14 SEC. 5. COOPERATION AMONG STATES FOR EMERGENCY
- 15 RESPONSE.
- 16 (a) AGREEMENTS BETWEEN STATES.—States that
- 17 provide subgrants to State or nonprofit entities that en-
- 18 gage in National Climate Service Corps activities under
- 19 section 122(a)(4) of the National and Community Service
- 20 Act of 1990, added by section 3(2), or States that have
- 21 nonprofit organizations receiving funding under the na-
- 22 tional service laws (as defined in section 101 of the Na-
- 23 tional and Community Service Act of 1990 (42 U.S.C.
- 24 12511)) and that are engaging in similar activities (re-
- 25 ferred to as "participating States") may enter into a com-

1	pact with other participating States to provide for mutual
2	cooperation to manage any emergency or disaster that is
3	duly declared by the affected State.
4	(b) Participating State Responsibilities.—
5	(1) Requests for assistance.—The author-
6	ized representative of a participating State may re-
7	quest assistance of the National Climate Service
8	Corps or of such nonprofit organizations of another
9	participating State by contacting the authorized rep-
10	resentative of that State. The provisions of the com-
11	pact described in subsection (a) shall only apply to
12	requests for assistance made by and to such author-
13	ized representatives.
14	(2) Consultation.—The State officials of par-
15	ticipating States shall ensure—
16	(A) that there is frequent consultation be-
17	tween State officials who are assigned emer-
18	gency management responsibilities, and other
19	appropriate representatives of the participating
20	States, with the relevant officials of affected ju-
21	risdictions and with the relevant officials of the
22	Federal Government; and
23	(B) the free exchange of information
24	plans, and resource records relating to emer-

gency capabilities.

1 SEC. 6. CLIMATE RESILIENCY AMERICORPS VISTA.

- 2 Section 103(a) of the Domestic Volunteer Service Act
- 3 of 1973 (42 U.S.C. 4953(a)) is amended—
- 4 (1) in paragraph (12), by striking "and" at the
- 5 end;
- 6 (2) in paragraph (13), by striking the period at
- 7 the end and inserting "; and"; and
- 8 (3) after subsection (13), by adding the fol-
- 9 lowing:
- 10 "(14) in addressing the capacity of low-income
- 11 communities to implement projects that increase re-
- silience to shocks and stressors resulting from cli-
- mate change.".

14 SEC. 7. NONCOMPETITIVE HIRING AUTHORITY.

- 15 A qualified corps member under section 122 of the
- 16 National and Community Service Act of 1990 (42 U.S.C.
- 17 12572) shall be eligible for appointment in the competitive
- 18 service in the same manner as a Peace Corps volunteer
- 19 as prescribed in Executive Order 11103 (22 U.S.C. 2504
- 20 note, relating to Providing for the Appointment of Former
- 21 Peace Corps Volunteers to the Civilian Career Services).

22 SEC. 8. CLIMATE CAREERS NETWORK.

- 23 (a) In General.—The Corporation (acting through
- 24 the Employers of National Service initiative), in consulta-
- 25 tion with the Departments of Energy, Agriculture, Edu-
- 26 cation, Labor, Interior, Transportation, Housing and

1	Urban Development, the Environmental Protection Agen-
2	cy, the National Oceanic and Atmospheric Administration,
3	and other relevant Federal agencies, as determined to be
4	appropriate by the Corporation, shall establish a program
5	to be known as the "Climate Careers Network" to carry
6	out the activities described in subsection (b) for the pur-
7	poses of—
8	(1) addressing the challenge of job placement in
9	a clean energy economy; and
10	(2) supporting individuals—
11	(A) who have completed service in the Na-
12	tional Climate Service Corps; and
13	(B) of all ages and backgrounds who want
14	to get involved in growing green industries in
15	the United States.
16	(b) Activities of the Climate Careers Net-
17	WORK.—The activities described in this subsection are as
18	follows:
19	(1) Creating and maintaining a database that
20	outlines opportunities for individuals who have com-
21	pleted service in the National Climate Service Corps
22	and other individuals, and that includes information
23	related to opportunities for those individuals in a

clean energy economy.

1	(2) Establishing direct partnerships between
2	the Climate Careers Network program and existing
3	infrastructure for relevant training and job place-
4	ment in order to connect individuals with new jobs
5	and lifelong careers, such as partnerships with 2 or
6	more of the following:
7	(A) Labor organizations or joint labor
8	management organizations.
9	(B) Employers.
10	(C) High schools and adult education pro-
11	grams.
12	(D) Nonprofit organizations with dem-
13	onstrated success in areas of clean energy and
14	climate change mitigation activities.
15	(E) Institutions of higher education.
16	(F) Community development organizations.
17	(G) State and local workforce development
18	boards established under title I of the Work-
19	force Innovation and Opportunity Act (29
20	U.S.C. 3111 et seq.).
21	(H) Career and technical education pro-
22	viders, including those that award credentials
23	and build career pathways.
24	(I) Other entities that may provide rel-
25	evant direct employment opportunities.

1	(c) Definitions.—In this section:
2	(1) Corporation.—The term "Corporation"
3	means the Corporation for National and Community
4	Service established under section 191 of the Na-
5	tional and Community Service Act of 1990 (42
6	U.S.C. 12651).
7	(2) Institution of Higher Education.—The
8	term "institution of higher education" has the
9	meaning given the term in section 101(a) of the
10	Higher Education Act of 1965 (20 U.S.C. 1001(a)).
11	SEC. 9. MATCHING FUNDS WAIVER.
12	The matching funds requirements under section
13	212(a)(1) of the Public Lands Corps Act of 1993 (16
14	U.S.C. 1729(a)(1)) and section 121(e) of the National and
15	Community Service Act of 1990 (42 U.S.C. 12571(e))
16	shall be waived for projects carried out using amounts
17	made available under this Act or the amendments made
18	by this Act.
19	SEC. 10. AUTHORIZATION OF APPROPRIATIONS.
20	There are authorized to be appropriated—
21	(1) \$2,000,000,000 for each of fiscal years
22	2022 through 2026 to carry out section 3;
23	(2) \$50,000,000 for each of fiscal years 2022
24	through 2026 to carry out section 8; and

- 1 (3) for each of fiscal years 2022 through 2026, 2 such sums as may be necessary to provide national 3 service educational awards under subtitle D of title 4 I of the National and Community Service Act of 5 1990 (42 U.S.C. 12601 et seq.) for the members of 6 the National Climate Service Corps for such fiscal 7 year.
- 8 SEC. 11. NATIONAL CLIMATE SERVICE CORPS DEFINED.
- In this Act, the term "National Climate Service Corps" means the National Climate Service Corps described in section 122(a)(4) of the National and Community Service Act of 1990 (42 U.S.C. 12572(a)(4)), as added by section 3.
