A BILL

To amend title 40, United States Code, to establish a Southern New England Regional Commission, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Southern New England
- 5 Regional Commission Act".

1	SEC. 2. ESTABLISHMENT OF SOUTHERN NEW ENGLAND RE-
2	GIONAL COMMISSION.
3	(a) Establishment.—Section 15301(a) of title 40,
4	United States Code, is amended by adding at the end the
5	following:
6	"(4) The Southern New England Regional
7	Commission.".
8	(b) Purposes for Economic and Infrastruc-
9	TURE DEVELOPMENT GRANTS.—Section 15501(a) of such
10	title is amended to read as follows:
11	"(a) In General.—A Commission may make grants
12	to States and local governments, Indian tribes, and public
13	and nonprofit organizations for projects, approved in ac-
14	cordance with section 15503—
15	"(1) to develop the transportation infrastruc-
16	ture of its region;
17	"(2) to develop the basic public infrastructure
18	of its region;
19	"(3) to develop the telecommunications infra-
20	structure of its region;
21	"(4) to assist its region in obtaining job skills
22	training, skills development and employment-related
23	education, career pathways, apprenticeships opportu-
24	nities, entrepreneurship, technology, job coaching to
25	address the cliff effect, work supports (including
26	child care), and business development;

1	"(5) to provide assistance to severely economi-
2	cally distressed and underdeveloped areas of a region
3	that lack financial resources for improving basic
4	health care, two-generational practices that improve
5	school and workforce readiness and success, and
6	other public services, including work supports crit-
7	ical for families seeking employment which may in-
8	clude quality child care, transportation, health, and
9	housing;
10	"(6) to promote resource conservation, tourism,
11	recreation, and preservation of open space in a man-
12	ner consistent with economic development goals;
13	"(7) to promote the development of renewable
14	and alternative energy sources;
15	"(8) to support the maritime economy, includ-
16	ing boat and ship building and repair industries;
17	"(9) to assist in developing defense manufac-
18	turing industries;
19	"(10) to promote the adoption of composite and
20	other innovative materials in public transportation;
21	"(11) to grow the capacity for successful com-
22	munity economic development in its region;
23	"(12) to provide for employment training for
24	populations seeking employment, including parents

1	in poverty, adults in recovery, and reentry adults, in
2	areas with worker shortages; and
3	"(13) to otherwise achieve the purposes of this
4	subtitle.".
5	(c) Designation of Region.—
6	(1) IN GENERAL.—Subchapter II of chapter
7	157 of such title is amended by adding at the end
8	the following:
9	"§ 15734. Southern New England Regional Commis-
10	sion
11	"The region of the Southern New England Regional
12	Commission shall include the following counties:
