A BILL

To require the maintenance of the country of origin markings
for imported goods produced in the West Bank or Gaza,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Anti-BDS Labeling*
 5 *Act”.*

6 **SEC. 2. CONTINUATION IN EFFECT OF COUNTRY OF ORIGIN**

7 **MARKING POLICY FOR IMPORTED GOODS**

8 **PRODUCED IN THE WEST BANK OR GAZA.**

9 *The policy of the Government of the United States with*
 10 *respect to country of origin marking of imported goods pro-*
 11 *duced in the West Bank or Gaza, notice of which was pub-*
 12 *lished by U.S. Customs and Border Protection in the Fed-*
 13 *eral Register on December 23, 2020 (85 Fed. Reg. 83984),*
 14 *shall remain in effect until repealed by an Act of Congress.*

15 **SEC. 3. PROHIBITION ON USE OF FUNDS TO RESCIND OR**

16 **CHANGE THE COUNTRY OF ORIGIN MARKING**

17 **POLICY FOR IMPORTED GOODS PRODUCED IN**

18 **THE WEST BANK OR GAZA.**

19 *Notwithstanding any other provision of law, none of*
 20 *the funds authorized to be appropriated or otherwise made*
 21 *available for the Department of State or U.S. Customs and*
 22 *Border Protection on or after the date of the enactment of*
 23 *this Act may be obligated or expended to prepare or promul-*
 24 *gate any policy; guidance; regulation; notice; or Executive*
 25 *order or to otherwise implement, administer, or enforce any*

1 *policy that rescinds or changes the policy of the Government*
2 *of the United States with respect to country of origin mark-*
3 *ing of imported goods produced in the West Bank or Gaza,*
4 *notice of which was published by U.S. Customs and Border*
5 *Protection in the Federal Register on December 23, 2020*
6 *(85 Fed. Reg. 83984).*
