BY repealing and reenacting, with amendments, Article – General Provisions Section 4–101 Annotated Code of Maryland (2019 Replacement Volume and 2022 Supplement) BY adding to Article – General Provisions Section 4-357 Annotated Code of Maryland (2019 Replacement Volume and 2022 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

(2) A CUSTODIAN MAY NOT ALLOW INSPECTION OR COPYING OF A RECORDING FROM A BODY-WORN DIGITAL RECORDING DEVICE BY AN INDIVIDUAL WHO IS UNDER INVESTIGATION FOR OR IS CHARGED WITH A VIOLATION DESCRIBED IN SUBSECTION (B) OF THIS SECTION IF THE RECORDING IS OF THE INCIDENT LEADING TO THE INVESTIGATION OR CHARGE.
(3) A CUSTODIAN MAY NOT ALLOW COPYING OF A RECORDING FROM A BODY-WORN DIGITAL RECORDING DEVICE BY AN INDIVIDUAL WHO HAS RECEIVED PROBATION BEFORE JUDGMENT FOR, IS SUBJECT TO A PEACE OR PROTECTIVE ORDER AS A RESULT OF, HAS PLEADED NOLO CONTENDERE TO, HAS PLEADED GUILTY TO, OR HAS BEEN FOUND GUILTY OF A VIOLATION DESCRIBED IN SUBSECTION (B) OF THIS SECTION IF THE RECORDING IS OF THE INCIDENT LEADING TO THE PROBATION BEFORE JUDGMENT, ORDER, PLEA, OR VERDICT.
SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
