## A BILL

To require the Secretary of the Interior to conduct a special resource study of the sites associated with the life and legacy of the noted American philanthropist and business executive Julius Rosenwald, with a special focus on the Rosenwald Schools, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Julius Rosenwald and*  
 5       *the Rosenwald Schools Act of 2020”.*

6       **SEC. 2. RESOURCE STUDY OF JULIUS ROSENWALD AND**  
 7               **ROSENWALD SCHOOLS.**

8       *(a) DEFINITIONS.—In this section:*

9               *(1) ROSENWALD SCHOOL.—The term “Rosenwald*  
 10       *School” means any of the 5,357 schools and related*  
 11       *buildings constructed in 15 southern States during*  
 12       *the period of 1912 through 1932 by the philanthropy*  
 13       *of Julius Rosenwald.*

14              *(2) SECRETARY.—The term “Secretary” means*  
 15       *the Secretary of the Interior.*

16              *(3) STUDY AREA.—The term “study area” means*  
 17       *the sites associated with the life and legacy of Julius*  
 18       *Rosenwald.*

19       *(b) SPECIAL RESOURCE STUDY.—*

20              *(1) STUDY.—The Secretary shall conduct a spe-*  
 21       *cial resource study of the study area, with a special*  
 22       *emphasis on the following Rosenwald Schools and*  
 23       *other sites associated with the life and legacy of Ju-*  
 24       *lius Rosenwald:*

1                   (A) *Sears Administration Building at*  
2                   *Homan Square in Chicago, Illinois.*

3                   (B) *Rosenwald Court Apartments in Chi-*  
4                   *cago, Illinois.*

5                   (C) *Museum of Science & Industry in Chi-*  
6                   *cago, Illinois.*

7                   (D) *Rosenwald House (formerly the Lyon*  
8                   *Home) at the Lincoln Home National Historic*  
9                   *Site in Springfield, Illinois.*

10                  (E) *Cairo Rosenwald School, a one-teacher*  
11                  *school in Sumner County, Tennessee.*

12                  (F) *Shady Grove School, a one-teacher*  
13                  *school in Louisa County, Virginia.*

14                  (G) *Noble Hill School, a two-teacher school*  
15                  *in Bartow County, Georgia.*

16                  (H) *Ridgeley School, a two-teacher school in*  
17                  *Prince Georges County, Maryland.*

18                  (I) *Bay Springs School, a two-teacher*  
19                  *school in Forest County, Mississippi.*

20                  (J) *Russell School, a two-teacher school in*  
21                  *Durham County, North Carolina.*

22                  (K) *Shiloh Rosenwald School, a three-teach-*  
23                  *er school in Macon County, Alabama.*

24                  (L) *San Domingo School, a four-teacher*  
25                  *school in Wicomico County, Maryland.*

1           (M) *Elmore County Training School, a*  
2           *seven-teacher school in Elmore County, Alabama.*

3           (N) *Dunbar Junior High, Senior High and*  
4           *Junior College in Little Rock, Arkansas.*

5           (2) *CONTENTS.—In conducting the study under*  
6           *paragraph (1), the Secretary shall—*

7           (A) *evaluate the national significance of the*  
8           *study area;*

9           (B) *determine the suitability and feasibility*  
10          *of designating the study area as a unit of the*  
11          *National Park System, including an interpretive*  
12          *center in or near Chicago, Illinois;*

13          (C) *consider other alternatives for preserva-*  
14          *tion, protection, and interpretation of the study*  
15          *area by the Federal Government, State or local*  
16          *government entities, or private and nonprofit or-*  
17          *ganizations;*

18          (D) *consult with interested Federal agen-*  
19          *cies, State or local governmental entities, private*  
20          *and nonprofit organizations, or any other inter-*  
21          *ested individuals; and*

22          (E) *identify cost estimates for any Federal*  
23          *acquisition, development, interpretation, oper-*  
24          *ation, and maintenance associated with the al-*  
25          *ternatives.*

1       (c) *APPLICABLE LAW.*—*The study under paragraph*  
2 *(1) shall be conducted in accordance with section 100507*  
3 *of title 54, United States Code.*

4       (d) *RESULTS.*—*Not later than 3 years after the date*  
5 *on which funds are first made available for the study under*  
6 *paragraph (1), the Secretary shall submit to the Committee*  
7 *on Natural Resources of the House of Representatives and*  
8 *the Committee on Energy and Natural Resources of the Sen-*  
9 *ate a report describing—*

10               (1) *the results of the study; and*

11               (2) *any conclusions and recommendations of the*  
12       *Secretary relating to the study.*
