Workers' Compensation - Occupational Disease Presumptions - Hypertension

- FOR the purpose of repealing the requirement that certain firefighters, fire fighting instructors, rescue squad members, advanced life support unit members, and members of the Office of the State Fire Marshal experience partial or total disability or death for hypertension to be presumed to be an occupational disease that was suffered in the line of duty and is compensable under workers' compensation law; and generally relating to occupational disease presumptions under workers' compensation law.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 16 That the Laws of Maryland read as follows:

- 19 (a) (1) A paid firefighter, paid fire fighting instructor, paid rescue squad 20 member, paid advanced life support unit member, or sworn member of the Office of the 21 State Fire Marshal employed by an airport authority, a county, a fire control district, a 22 municipality, or the State or a volunteer firefighter, volunteer fire fighting instructor,
- 23 volunteer rescue squad member, or volunteer advanced life support unit member who is a
- 24 covered employee under § 9–234 of this title is presumed to have an occupational disease
- 25 that was suffered in the line of duty and is compensable under this title if:

- 1 [(1)] (I) 1. the individual has heart disease[, hypertension,] or lung 2 disease:
- 3 [(2)] **2.** the heart disease[, hypertension,] or lung disease results in 4 partial or total disability or death; and
- [(3)] 3. in the case of a volunteer firefighter, volunteer fire fighting instructor, volunteer rescue squad member, or volunteer advanced life support unit member, the individual has met a suitable standard of physical examination before becoming a firefighter, fire fighting instructor, rescue squad member, or advanced life support unit member; **OR**
