Establishing a McCain-Mansfield Fellowship Program in the Senate.

Mr. ROUNDS (for himself, Ms. SINEMA, Mr. COTTON, Mr. CRAMER, Mr. COONS, Mr. KELLY, Mr. KING, and Mr. PETERS) submitted the following resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Establishing a McCain-Mansfield Fellowship Program in the
Senate.

1 *Resolved,*

2 **SECTION 1. MCCAIN-MANSFIELD FELLOWSHIP PROGRAM.**

3 (a) DEFINITIONS.—In this resolution—

4 (1) the term “eligible military veteran” means
5 a veteran, as defined in section 101 of title 38,
6 United States Code, that meets any eligibility re-
7 quirements established by the Secretary for partici-
8 pation in the program under this section; and

9 (2) the term “Sergeant at Arms” means the
10 Sergeant at Arms and Doorkeeper of the Senate.

1 (b) ESTABLISHMENT OF FELLOWSHIP PROGRAM.—

2 (1) IN GENERAL.—From amounts made avail-
 3 able to carry out this section, the Sergeant at Arms
 4 shall establish a program through which eligible
 5 military veterans may apply for and participate in a
 6 fellowship position in the personal office of a Sen-
 7 ator.

8 (2) DESIGNATION.—The program established
 9 under paragraph (1) shall be referred to as the
 10 “McCain-Mansfield Fellowship Program”.

11 (3) ESTABLISHMENT OF AN OFFICE.—The Ser-
 12 geant at Arms shall establish, in the Office of the
 13 Sergeant at Arms, an office to administer the
 14 McCain-Mansfield Fellowship Program. The office
 15 shall develop a process through which—

16 (A) Senators who wish to participate in the
 17 McCain-Mansfield Fellowship Program may no-
 18 tify the Sergeant at Arms; and

19 (B) eligible military veterans may apply for
 20 a McCain-Mansfield Fellowship.

21 (c) DURATION, NUMBER, DISTRIBUTION, AND
 22 AMOUNT OF FELLOWSHIPS.—

23 (1) DURATION.—A McCain-Mansfield Fellow-
 24 ship shall be for a 2-year period.

1 (2) NUMBER AND DISTRIBUTION OF FELLOW-
2 SHIPS.—Subject to the availability of appropria-
3 tions—

4 (A) the Sergeant at Arms shall award not
5 more than 100 McCain-Mansfield Fellowships;
6 and

7 (B) the Sergeant at Arms shall distribute
8 the McCain-Mansfield Fellowships under this
9 section for an award period in a manner that
10 provides not less than 1 Fellowship position for
11 each Senator wishing to participate in the pro-
12 gram.

13 (3) AMOUNT OF FINANCIAL ASSISTANCE.—The
14 Sergeant at Arms shall determine the stipend or
15 other financial assistance appropriate for each par-
16 ticular McCain-Mansfield Fellowship position under
17 this section, depending on the duties of the position
18 and the recommendations from the Senator offering
19 the position.
