# A BILL

To codify Executive Order 13694 (relating to blocking the property of certain persons engaging in significant malicious cyber-enabled activities) and to codify certain Executive orders imposing sanctions in relation to the situation in Ukraine.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Freezing Russian
- 3 Sanctions Act".
- 4 SEC. 2. CODIFICATION OF EXECUTIVE ORDER 13694.
- 5 Executive Order 13694 (80 Fed. Reg. 18077; relat-
- 6 ing to blocking the property of certain persons engaging
- 7 in significant malicious cyber-enabled activities), as in ef-
- 8 fect on January 1, 2017, and any sanctions imposed and
- 9 designations made pursuant to Executive Order 13694,
- 10 shall remain in effect.
- 11 SEC. 3. CODIFICATION OF EXECUTIVE ORDERS IMPOSING
- 12 SANCTIONS IN RELATION TO THE SITUATION
- 13 IN UKRAINE.
- 14 (a) In General.—The Executive orders specified in
- 15 subsection (b), and sanctions imposed and designations
- 16 made pursuant to such Executive orders, and any action
- 17 taken or regulation issued by the Department of Com-
- 18 merce, pursuant to Export Administration Act of 1979 (as
- 19 continued in effect pursuant to the International Emer-
- 20 gency Economic Powers Act), related to licensing exports
- 21 to Russia, designated Russian persons, or designated Rus-
- 22 sian entities shall remain in effect.
- 23 (b) EXECUTIVE ORDERS SPECIFIED.—The Executive
- 24 orders specified in this subsection are the following:
- 25 (1) Executive Order 13660 (79 Fed. Reg.
- 26 13493; relating to blocking property of certain per-

- sons contributing to the situation in Ukraine) (as in effect on January 1, 2017).
- 3 (2) Executive Order 13661 (79 Fed. Reg. 4 15535; relating to blocking property of additional 5 persons contributing to the situation in Ukraine) (as in effect on January 1, 2017).
  - (3) Executive Order 13662 (79 Fed. Reg. 16169; relating to blocking property of additional persons contributing to the situation in Ukraine) (as in effect on January 1, 2017).
    - (4) Executive Order 13685 (79 Fed. Reg. 77357; relating to blocking property of certain persons and prohibiting certain transactions with respect to the Crimea region of Ukraine) (as in effect on January 1, 2017).
