A BILL

To reauthorize the Traumatic Brain Injury program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Traumatic Brain In-
- 5 jury Program Reauthorization Act of 2018".
- 6 SEC. 2. PREVENTION AND CONTROL OF INJURIES.
- 7 Part J of title III of the Public Health Service Act
- 8 (42 U.S.C. 280b et seq.) is amended—
- 9 (1) in section 393C (42 U.S.C. 280b–1d) by
- adding at the end the following:

1	"(c) National Concussion Surveillance Sys-
2	TEM.—The Secretary, acting through the Director of the
3	Centers for Disease Control and Prevention, may imple-
4	ment a national concussion surveillance system to deter-
5	mine the prevalence and incidence of concussion."; and

9	inserting "393B, 393C(a), and 393C(b)";

15	(B) by adding at the end the following:

18	to be appropriated \$5,000,000 for fiscal year 2019, and
19	such sums as may be necessary for each fiscal year there-
20	after.".
