A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County – Natural Resources – Sunday Deer Hunting and**
3 **Archery Hunting Safety Zones**

4 FOR the purpose of authorizing the Department of Natural Resources to allow a person to
5 hunt deer on certain Sundays of the deer hunting seasons in Prince George's County;
6 adding Prince George's County to the list of counties in which the safety zone for
7 archery hunters extends a certain distance from certain structures; and generally
8 relating to hunting in Prince George's County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Natural Resources**

22 10–410.

23 (a) (1) (i) The Department may allow a person to hunt on each Sunday of
24 the game bird and game mammal seasons in:

[Brackets] indicate matter deleted from existing law.



1. Allegany County;

2. Subject to subparagraph (iii) of this paragraph, Calvert County, from 30 minutes before sunrise until 10:30 a.m.;

3. Subject to subparagraph (iii) of this paragraph, Caroline County, from 30 minutes before sunrise until 10:30 a.m.;

4. Cecil County;

5. Subject to subparagraph (iii) of this paragraph, Charles County, from 30 minutes before sunrise until 10:30 a.m.;

6. Subject to subparagraph (iv) of this paragraph, Dorchester County, from 30 minutes before sunrise until 10:30 a.m.;

7. Garrett County;

8. Subject to subparagraph (iii) of this paragraph, Queen Anne's County, from 30 minutes before sunrise until 10:30 a.m.;

9. St. Mary's County;

10. Subject to subparagraph (ii) of this paragraph, Somerset County, from 30 minutes before sunrise until 10:30 a.m.; and

11. Washington County.

(ii) The time restrictions under subparagraph (i)10 of this paragraph do not apply:

1. On each Sunday of the deer firearms season; and

2. On the last three Sundays in October and the first two Sundays in November of the deer bow hunting season.

(iii) The time restrictions under subparagraph (i)2, 3, 5, and 8 of this paragraph do not apply:

1. On each Sunday during the deer firearms season;

2. On the last three Sundays in October and the first two Sundays in November during the deer bow hunting season; and

3. On each Sunday of the spring turkey hunting season.

(iv) The time restrictions under subparagraph (i)6 of this paragraph do not apply:

1. On each Sunday of the deer hunting seasons from the first Sunday in October through the second Sunday in January, inclusive; and

2. On each Sunday of the spring turkey hunting season.

(2) The Department may allow a person to hunt deer on each Sunday of the deer hunting seasons from the first Sunday in October through the second Sunday in January, inclusive, in:

(i) Carroll County; [and]

(ii) Frederick County; AND

(III) PRINCE GEORGE'S COUNTY.

(3) (i) Subject to subparagraph (ii) of this paragraph, the Department may allow a person to hunt deer on each Sunday of the deer hunting seasons from 30 minutes before sunrise until 10:30 a.m. in:

1. Kent County;

2. Montgomery County; and

3. Talbot County.

(ii) The time restrictions under this paragraph do not apply:

1. To a participant in a junior deer hunt authorized under this subtitle;

2. On one Sunday designated by the Department during the deer firearms season;

3. In Kent County, on each Sunday during the deer bow hunting season and the deer muzzle loader season;

4. In Montgomery County, on one Sunday designated by the Department during the deer bow hunting season; and

5. In Talbot County, on the last three Sundays in October and the first two Sundays in November during the bow hunting season.

(4) The Department may allow a person to hunt deer during the deer firearms season:

1 (i) On each Sunday in:

2 1. Harford County; and

3 2. Worcester County;

4 (ii) On the first Sunday in Anne Arundel County; and

5 (iii) In Wicomico County, on:

6 1. The first Sunday; and

7 2. The second Sunday from 30 minutes before sunrise until
8 10:30 a.m.

9 (5) The Department may allow a person to hunt deer during the deer bow
10 hunting season on:

11 (i) The last three Sundays in October and the first two Sundays in
12 November in:

13 1. Harford County;

14 2. Wicomico County; and

15 3. Worcester County; and

16 (ii) The first Sunday in November in Anne Arundel County.

17 (6) The Department may allow a person to hunt turkey on each Sunday of
18 the spring turkey hunting season in:

19 (i) Carroll County;

20 (ii) Kent County; and

21 (iii) Talbot County, from 30 minutes before sunrise until 10:30 a.m.

22 (7) Notwithstanding any other provision of this subtitle, the Department
23 may allow a person with a deer management permit to shoot deer on any Sunday
24 throughout the year in accordance with the terms of the permit.

25 (8) The Department may allow a person using a State certified raptor to
26 hunt game birds or mammals on each Sunday during the open season for the game birds
27 or mammals.

(9) The Department may allow an unarmed person participating in an organized fox chase to chase foxes on Sunday.

(10) The Department may allow a person shooting pen-reared game birds or tower-released flighted mallard ducks to hunt on Sunday at a regulated shooting ground in accordance with § 10-906 of this title.

(11) The Department may allow a person who is 16 years old or younger to hunt on Sunday if participating in a junior hunt established by the Department in accordance with this subtitle.

(12) Except as provided in paragraphs (8) through (10) of this subsection and subject to paragraph (7) of this subsection, a person may not hunt on Sunday in:

- (i) Baltimore City;
- (ii) Baltimore County; **OR**
- (iii) Howard County[]; or
- (iv) Prince George's County[].

(13) A person may not hunt migratory game birds on Sunday.

(14) A person may not hunt on public land within the State park system on Sunday.

(15) (i) The Department may not allow a person to hunt on public land designated for hunting by the Department on Sunday except in:

1. Allegany County;
2. Cecil County;
3. Garrett County;
4. St. Mary's County;
5. Washington County;
6. Dorchester County, for turkey during the spring turkey hunting season;
7. Frederick County, for deer from the first Sunday in October through the second Sunday in January of the following year, inclusive; and

1 8. Subject to subparagraph (ii) of this paragraph, Somerset
2 County, on public land leased to a hunt club from 30 minutes before sunrise until 10:30
3 a.m.

4 (ii) The time restrictions under subparagraph (i)8 of this paragraph
5 do not apply:

6 1. On each Sunday of the deer firearms season; and

7 2. On the last three Sundays in October and the first two
8 Sundays in November of the deer bow hunting season.

9 (g) (1) Except as provided in paragraphs (2) and (3) of this subsection, a
10 person, other than the owner or occupant, while hunting for any wild bird or mammal may
11 not shoot or discharge any firearm or other deadly weapon within 150 yards, known as the
12 “safety zone”, of a dwelling house, residence, church, or other building or camp occupied by
13 human beings, or shoot at any wild bird or mammal while it is within this area, without
14 the specific advance permission of the owner or occupant.

15 (2) A person, while hunting for any wild bird or mammal, may not shoot or
16 discharge any firearm within 300 yards of a public or nonpublic school during school hours
17 or at a time when a school–approved activity is taking place.

18 (3) (i) For archery hunters in Allegany County, Calvert County, Carroll
19 County, Cecil County, Frederick County, Garrett County, Harford County, Montgomery
20 County, **PRINCE GEORGE’S COUNTY**, St. Mary’s County, or Washington County, the
21 safety zone described in paragraph (1) of this subsection extends for 50 yards from a
22 dwelling house, residence, church, or any other building or camp occupied by human beings.

23 (ii) For archery hunters in Anne Arundel County, the safety zone
24 described in paragraph (1) of this subsection extends for 100 yards from a dwelling house,
25 residence, church, or any other building or camp occupied by human beings.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2023.
